# ACT

**To appropriate an additional amount of money from the Provincial Revenue Fund for the requirements of the Provincial Government: Western Cape in respect of the financial year ending 31 March 2009; and to provide for incidental matters.**

---

**B**E IT ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:

**Appropriation of an additional amount of money for the requirements of the Provincial Government: Western Cape**

**1.** (1) Subject to the Public Finance Management Act, 1999 (Act No. 1 of 1999), an additional amount of R10 million is appropriated out of the Provincial Revenue Fund for the requirements of the Provincial Government: Western Cape in respect of the financial year ending 31 March 2009, as set out in the Schedule. 5

(2) The money referred to in subsection (1) must be transferred to the Mandela Rhodes Foundation as a capital grant, subject to conditions determined by the Provincial Government: Western Cape and set out in a written agreement between the Provincial Government: Western Cape and the Foundation. 10

**2.** This Act is called the Western Cape Special Adjustments Appropriation Act, 2008.
