BILL

To repeal the Problem Animal Control Ordinance, 1957; and to provide for matters incidental thereto.

BE IT ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Repeal of Ordinance 26 of 1957 and laws amending it

- 1.** The laws listed in the Schedule are repealed.

Short title

- 2.** This Act is called the Problem Animal Control Ordinance Repeal Act, 2008.

EXPLANATORY MEMORANDUM

1. OBJECT OF BILL

The object of the Bill is to repeal the Problem Animal Control Ordinance 26 of 1957 (“the Ordinance”) and laws amending it.

2. BACKGROUND

- 2.1 The Ordinance was assigned to the Province in terms of Proclamation No. 115 of 1994 published in Government Gazette No. 15813 of 17 June 1994.
- 2.2 The Ordinance provides for the establishment and registration of hunt clubs for the combating of problem animals. It also provides local government (former Divisional Council) with executive power to deal with problem animal control, which is contrary to the Constitution of South Africa.
- 2.3 Currently, matters relating to problem animal control are regulated by the Nature Conservation Ordinance 19 of 1974 and not by the Ordinance. The Western Cape Nature Conservation Board, established in terms of section 2 of the Western Cape Nature Conservation Board Act of 1998 (Act 15 of 1998), is empowered to deal with any matter relating to problem animal control in terms of the Nature Conservation Ordinance 19 of 1974.
- 2.4 Furthermore, the mechanism to control problem animals as contained in the Ordinance, that is, hunt clubs, is defunct and as a consequence thereof, this Ordinance is now obsolete.
- 2.5. The Ordinance also contains discriminatory provisions which is unconstitutional.

VERDUIDELIKENDE MEMORANDUM

1. DOEL VAN WETSONTWERP

Die doel van die Wetsontwerp is om die Ordonnansie op die Beheer van Probleemdiere 26 van 1957 (“die Ordonnansie”), en wette wat dit wysig, te herroep.

2. AGTERGROND

- 2.1 Die Ordonnansie is aan die Provincie toegewys kragtens Proklamasie Nr. 115 van 1994, gepubliseer in die Staatskoerant Nr. 15813 van 17 Junie 1994.
- 2.2 Die Ordonnansie maak voorsiening vir die stigting en registrasie van jagklubs ter bestryding van probleemdiere. Dit voorsien ook die plaaslike regering (voormalige Streeksrade) met uitvoerende gesag om die beheer van probleemdiere te hanteer, wat strydig is met die Grondwet van Suid-Afrika.
- 2.3 Tans word aangeleenthede wat verband hou met die beheer van probleemdiere deur die Natuurbewaringsordonnansie 19 van 1974 gereguleer en nie deur die Ordonnansie nie. Die Wes-Kaap Natuurbewaringsraad, gestig kragtens artikel 2 van die Wet op die Wes-Kaapse Natuurbewaringsraad van 1998 (Wet 15 van 1998), is gevoldmagtig om enige aangeleentheid met betrekking tot die beheer van probleemdiere te hanteer kragtens die Natuurbewaringsordonnansie 19 van 1974.
- 2.4 Verder is die mekanisme om probleemdiere te beheer soos vervat in die Ordonnansie, dit is by wyse van jagklubs, in onbruik en as gevolg hiervan is hierdie Ordonnansie nou uitgedien.
- 2.5. Die Ordonnansie bevat ook diskriminerende bepalings wat onkonstitusioneel is.
