ACT

To appropriate adjusted amounts of money from the Provincial Revenue Fund for the requirements of the Provincial Government: Western Cape in respect of the financial year ending 31 March 2009; and to provide for matters connected therewith.

PREAMBLE

WHEREAS section 226(2) of the Constitution of the Republic of South Africa, 1996, provides that money may be withdrawn from the Provincial Revenue Fund only in terms of an appropriation by a provincial Act,

B E IT THEREFORE ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2008 (Act No. 2 of 2008), has the meaning assigned to it in that Act. 5

Appropriation of adjusted amounts of money for requirements of Provincial Government: Western Cape

2. (1) Adjusted appropriations of money by Provincial Parliament from the Provincial Revenue Fund for the requirements of the Provincial Government: Western Cape in the 2008/09 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in Schedule A. 10

(2) The spending of appropriations contemplated in subsection (1) is subject to the Public Finance Management Act.

Appropriation listed as specific and exclusive 15

3. Despite the provisions of any law, appropriations to a vote or main division within a vote that are listed as specifically and exclusively appropriated in Schedule A, may only be utilised for the purpose indicated, and may not be used for any other purpose, unless an Act of the Provincial Parliament amends or changes the purpose for which it was allocated. 20

Conditional allocations to municipalities

4. Subject to the Municipal Finance Management Act, 2003 (Act No. 56 of 2003), there are hereby appropriated conditional allocations to municipalities out of the Provincial Government's budget in respect of the financial year ending 31 March 2009, the adjusted amounts of money shown in Schedule B. 25

Short title

5. This Act is called the Western Cape Adjustments Appropriation Act, 2008.
