I, Garth Strachan, in my capacity as Provincial Minister of Finance Economic Development and Tourism hereby publish the attached schedule in terms of section 31(2) and (3) of the Division of Revenue Act, 2008 (Act 2 of 2008) (2008 DORA), which determines that despite anything to the contrary contained in any law, a Provincial Treasury may, in accordance with a framework determined by National Treasury, make additional allocations to municipalities that were not published in terms of sections 31(1) and 31(2) of 2008 DORA. The distribution of this additional allocated grant is reflected in the attached schedule.

Purpose	To support the Cape Winelands District Municipality financially with the establishment of a management entity for the newly UNESCO designated Cape Winelands Biosphere Reserve.

Approved Project Business Plan submitted by municipality/institution indicating outputs and time frameworks. Memorandum of Agreement signed by both parties. Personal visits and attendance of projects/steering committee meetings by town and regional planners of the Department. Regular progress and financial reporting. Scrutiny of product at various stages.
Projected life	Dependant on Project Business Plan and accompanying time schedules.
Payment schedule	Once-off transfer to municipality in accordance with Agreement with municipality.
