ACT

To appropriate additional adjusted amounts of money from the Provincial Revenue Fund in respect of funds that have become available for the requirements of the Province of the Western Cape in respect of the 2013/14 financial year; and to provide for matters incidental thereto.

WHEREAS the National Treasury has allocated additional funds to the Province in respect of the national conditional grants: National Health Insurance Grant, Human Settlements Development Grant and Community Library Services Grant.

WHEREAS section 31 of the Public Finance Management Act, 1999 (Act 1 of 1999), provides that the Provincial Minister responsible for finance may table an adjustments budget in the Provincial Parliament in respect of funds that have become available.

AND WHEREAS section 26 of the Public Finance Management Act, 1999, provides that the Provincial Parliament must appropriate money for each financial year for the requirements of the Province.

BE IT THEREFORE ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2013 (Act 5 of 2013), has the meaning assigned to it in that Act.

Appropriation of adjusted amounts of money for requirements of Province

2. (1) Adjusted appropriations by the Provincial Parliament of money from the Provincial Revenue Fund for the requirements of the Province in the 2013/14 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in the Schedule.

(2) The spending of the appropriations is subject to the Public Finance Management Act.

Amounts listed as specifically and exclusively appropriated

3. The amounts in respect of the national conditional grants listed in the Schedule as specifically and exclusively appropriated may be used only for the purpose stipulated in the Division of Revenue Act and in accordance with the framework published in terms of that Act.

Short title

4. This Act is called the Western Cape Additional Adjustments Appropriation Act (2013/14 Financial Year), 2014.

Tot bewilliging van bykomende aangesuiwerde bedrae geld uit die Proviniale Inkomstefonds ten opsigte van fondse wat beskikbaar geword het vir die behoeftes van die Provinsie Wes-Kaap ten opsigte van die 2013/14-boekjaar; en om voorsiening te maak vir aangeleenthede wat daar mee in verband staan.

AANGESEIEN die Nasionale Tesourie bykomende fondse aan die Provinsie toegeken het ten opsigte van die nasionale voorwaardelike toekennings: Nasionale Gesondheidsverzekering, Ontwikkeling van Menslike Nedersetting en Gemeenskapsbibliotekdienste.

AANGESEIEN artikel 31 van die Wet op Openbare Finansiële Bestuur, 1999 (Wet 1 van 1999), bepaal dat die Proviniale Minister verantwoordelik vir finansies 'n aansuiweringsbegroting in die Proviniale Parlement ter tafel kan lê ten opsigte van fondse wat beskikbaar geword het.

EN AANGESEIEN artikel 26 van die Wet op Openbare Finansiële Bestuur, 1999, bepaal dat die Proviniale Parlement vir elke boekjaar geld moet bewillig vir die behoeftes van die Provinsie.

WORD DAAR DERHALWE BEPAAL deur die Proviniale Parlement van die Provinsie Wes-Kaap, soos volg:—

Interpretasie

1. In hierdie Wet, tensy dit uit die samehang anders blyk, het enige woord of uitdrukking waaraan 'n betekenis geheg is in die Wes-Kaapse Begrotingswet, 2013 (Wet 5 van 2013), die betekenis daaraan geheg in daardie Wet.

Bewilliging van aangesuiwerde bedrae geld vir behoeftes van Provinsie

2. (1) Aangesuiwerde bewilligings deur die Proviniale Parlement van geld uit die Proviniale Inkomstefonds vir die behoeftes van die Provinsie in die 2013/14-boekjaar, vir begrotingsposte en hoofindelings binne 'n begrotingspos, en vir die spesifieke doeleinades gelys, word in die Bylae uiteengesit.

(2) Die besteding van die bewilligings is onderhewig aan die Wet op Openbare Finansiële Bestuur.

Bedrae gelys as spesifiek en uitsluitlik bewillig

3. Die bedrae ten opsigte van die nasionale voorwaardelike toekennings in die Bylae gelys as spesifiek en uitsluitlik bewillig, kan gebruik word slegs vir die doel bepaal in die Wet op die Verdeling van Inkomste en ooreenkomsdig die raamwerk gepubliseer ingevolge daardie Wet.
