REGULATIONS (HERITAGE WESTERN CAPE) ON THE PROCESS FOR PUBLICATION OF STATEMENTS OF GENERAL POLICY AND CONSERVATION MANAGEMENT PLANS, 2015

Heritage Western Cape, under section 25(2)(h) read with section 47(4) of the National Heritage Resources Act, 1999 (Act 25 of 1999), has made the regulations set out in the Schedule.

SCHEDULE

Definitions

1. In these regulations a word or expression to which a meaning has been assigned in the Act bears the same meaning and, unless the context indicates otherwise—

“**conservation body**” means an organisation registered as a conservation body in terms of the regulations made by Heritage Western Cape by Provincial Notice 298/2003, dated 29 August 2003;

“**conservation management plan**” means a plan contemplated in section 47(2) of the Act;

“**Heritage Western Cape**” means the provincial heritage resources authority established by the Provincial Minister under section 23 of the Act by Provincial Notice 336/2012, dated 25 October 2012;

“**Province**” means the Province of the Western Cape;

“**Provincial Minister**” means the provincial minister responsible for cultural matters in the Province;

“**statement of general policy**” means a statement of general policy contemplated in section 47(1) of the Act;

“**the Act**” means the National Heritage Resources Act, 1999 (Act 25 of 1999).

Publication of notices

2. (1) Heritage Western Cape must, by notice in the *Provincial Gazette* and at least one other newspaper in general circulation in the Province, or if the proposed statement of general policy or proposed conservation management plan affects only a specific area, in at least one newspaper distributed in that area, notify the public and interested organisations of the availability for inspection and comment of—
- (a) a proposed statement of general policy, or an amendment or review thereof; or
 - (b) a proposed conservation management plan or review thereof.

- (2) In addition to a notice contemplated in subregulation (1), Heritage Western Cape may publish the notice in any other media it regards as necessary.
- (3) A notice contemplated in subregulations (1) and (2) must—
 - (a) be published in all three official languages of the Province;
 - (b) call for comments by the public and interested organisations;
 - (c) specify that the comments must be submitted in writing to Heritage Western Cape;
 - (d) specify the date by which the comments must be submitted;
 - (e) contain a broad outline of the proposed statement of general policy or the proposed conservation management plan;
 - (f) contain details of any public meetings or workshops contemplated in regulation 4; and
 - (g) state that a copy of the proposed statement of general policy or the proposed conservation management plan is available for inspection—
 - (i) on the official Heritage Western Cape website;
 - (ii) at the offices of Heritage Western Cape; and
 - (iii) at any other place Heritage Western Cape may specify in the notice.

Notice to conservation bodies

3. (1) Heritage Western Cape must, when it publishes a notice contemplated in regulation 2(1), notify any conservation bodies in the Province of the availability for inspection and comment of the proposed statement of general policy or proposed conservation management plan contemplated in that regulation by sending the relevant notice—
 - (a) by registered post to the postal address of the conservation bodies; or
 - (b) by facsimile or electronic mail to the facsimile address or electronic mail address, as the case may be, of the conservation bodies.

Public meetings or workshops

4. (1) Heritage Western Cape may in appropriate circumstances hold public meetings or workshops and invite the public and interested organisations to present oral or written representations or objections to Heritage Western Cape regarding the proposed adoption, amendment or review of any statement of general policy or the proposed adoption or review of any conservation management plan.
- (2) A public meeting or workshop may be held before or after the period for comment regarding the proposed adoption, amendment or review of any statement of general policy or the proposed adoption or review of any conservation management plan has expired.

Consideration of comments

5. Heritage Western Cape must give due consideration to all comments, representations and objections received or presented before it adopts a statement of general policy or a conservation management plan or any amendment or review thereof.

Publication of adoption notices

6. (1) Heritage Western Cape must, by notice in the *Provincial Gazette* and at least one other newspaper in general circulation in the Province, or if the proposed statement of general policy or proposed conservation management plan affects only a specific area, in at least one

newspaper distributed in that area, notify the public and interested organisations of the adoption of—

- (a) a statement of general policy, or an amendment or review thereof; or
 - (b) a conservation management plan or review thereof.
- (2) In addition to the notice contemplated in subregulation (1), Heritage Western Cape may publish the notice in any other media Heritage Western Cape regards as necessary.
- (3) A notice contemplated in subregulations (1) and (2) must—
- (a) be published in all three official languages of the Province;
 - (b) state that the adopted statement of general policy or the adopted conservation management plan is available for inspection—
 - (i) on the official Heritage Western Cape website;
 - (ii) at the offices of Heritage Western Cape; and
 - (iii) at any other place Heritage Western Cape specifies in the notice.

Short title

7. These regulations are called the Regulations (Heritage Western Cape) on the Process for Publication of Statements of General Policy and Conservation Management Plans, 2015.

REGULASIES (ERFENIS WES-KAAP) OP DIE PROSES VIR PUBLIKASIE VAN ALGEMENE BELEIDSVERKLARINGS EN BEWARINGSBESTUURSPLANNE, 2015

Erfenis Wes-Kaap, kragtens artikel 25(2)(h) saamgelees met artikel 47(4) van die Wet op Nasionale Erfenishulpbronne, 1999 (Wet 25 van 1999), het die regulasies uiteengesit in die Bylae gemaak.

BYLAE**Omskrywing**

1. In hierdie regulasies het enige woord of uitdrukking waaraan 'n betekenis in die Wet geheg is dieselfde betekenis en, tensy dit uit die samehang anders blyk, beteken—

“**algemene beleidsverklaring**” 'n verklaring van algemene beleid beoog in artikel 47(1) van die Wet;

“**bewaringsbestuursplan**” 'n plan beoog in artikel 47(2) van die Wet;

“**bewaringsliggaam**” 'n organisasie wat as 'n bewaringsliggaam geregistreer is ingevolge die regulasies gemaak deur Erfenis Wes-Kaap by Proviniale Kennisgewing 298/2003 van 29 Augustus 2003;

“**die Wet**” die Wet op Nasionale Erfenishulpbronne, 1999 (Wet 25 van 1999);

“**Erfenis Wes-Kaap**” die provinsiale erfenishulpbronowerheid ingestel deur die Proviniale Minister kragtens artikel 23 van die Wet by Proviniale Kennisgewing 336/2012 van 25 Oktober 2012;

“**Provinsie**” die Provinsie van die Wes-Kaap;

“**Proviniale Minister**” beteken die provinsiale minister verantwoordelik vir kulturele aangeleenthede in die Provinsie.

Publikasie van kennisgewings

2. (1) Erfenis Wes-Kaap moet, by kennisgewing in die *Proviniale Koerant* en in ten minste een ander koerant in algemene omloop in die Provinsie, of indien die voorgestelde algemene beleidsverklaring of voorgestelde bewaringsbestuursplan slegs 'n spesifieke gebied beïnvloed, in ten minste een koerant wat in daardie gebied versprei word, die publiek en belanghebbende organisasies in kennis stel van die beskikbaarheid vir insae en kommentaar van—
 - (a) 'n voorgestelde algemene beleidsverklaring, of 'n wysiging of hersiening daarvan; of
 - (b) 'n voorgestelde bewaringsbestuursplan of 'n hersiening daarvan.
 - (2) Benewens 'n kennisgewing beoog in subregulasie (1), kan Erfenis Wes-Kaap die kennisgewing in enige ander media publiseer wat hy as nodig beskou.
 - (3) 'n Kennisgewing beoog in subregulasies (1) en (2) moet—
 - (a) in al drie die amptelike tale van die Provinsie gepubliseer word;
 - (b) 'n oproep doen om kommentaar deur die publiek en belanghebbende organisasies;
 - (c) spesifiseer dat die kommentaar skriftelik by Erfenis Wes-Kaap ingedien moet word;
 - (d) die datum vermeld waarteen die kommentaar ingedien moet wees;
 - (e) 'n uiteensetting in breeë trekke van die voorgestelde algemene beleidsverklaring of die voorgestelde bewaringsbestuursplan bevat;

- (f) die besonderhede bevat van enige openbare vergaderings of werkswinkels beoog in regulasie 4; en
- (g) vermeld dat 'n afskrif van die voorgestelde algemene beleidsverklaring of die voorgestelde bewaringsbestuursplan vir insae beskikbaar is—
 - (i) op die amptelike Erfenis Wes-Kaap-webtuiste;
 - (ii) by die kantore van Erfenis Wes-Kaap; en
 - (iii) by enige ander plek wat Erfenis Wes-Kaap in die kennisgewing kan vermeld.

Kennisgewing aan bewaringsliggame

3. (1) Erfenis Wes-Kaap moet, wanneer hy 'n kennisgewing beoog in regulasie 2(1) publiseer, enige bewaringsliggame in die Provincie in kennis stel van die beskikbaarheid vir insae en kommentaar van die algemene beleidsverklaring of bewaringsbestuursplan beoog in daardie regulasie deur die tersaaklike kennisgewing te stuur—
 - (a) per geregistreerde pos na die posadres van die bewaringsliggame; of
 - (b) per faks of elektroniese pos na die faksnommer of elektroniese posadres, na gelang van die geval, van die bewaringsliggame.

Openbare vergaderings of slypskole

4. (1) Erfenis Wes-Kaap mag in gepaste omstandighede openbare vergaderings of werkswinkels hou en die publiek en belanghebbende organisasies uitnooi om mondelinge of skriftelike vertoë of besware aan Erfenis Wes-Kaap te lewer rakende die voorgestelde aanneming, wysiging of hersiening van enige algemene beleidsverklaring of die voorgestelde aanneming of hersiening van enige bewaringsbestuursplan.
- (2) 'n Openbare vergadering of werkswinkel mag voor of na die verstryking van die tydperk vir kommentaar oor die voorgestelde aanneming, wysiging of hersiening van enige algemene beleidsverklaring of die voorgestelde aanvaarding of hersiening van enige bewaringsbestuursplan gehou word.

Oorweging van kommentaar

5. Erfenis Wes-Kaap moet alle kommentaar, vertoë en besware wat ontvang of voor hom aangebied is behoorlik oorweeg voordat hy 'n algemene beleidsverklaring of 'n bewaringsbestuursplan of enige wysiging of hersiening daarvan aanneem.

Publikasie van kennisgewings van goedkeuring

6. (1) Erfenis Wes-Kaap moet, by kennisgewing in die *Provinsiale Koerant* en in ten minste een ander koerant in algemene omloop in die Provincie, of indien die voorgestelde algemene beleidsverklaring of voorgestelde bewaringsbestuursplan slegs 'n spesifieke gebied raak, in ten minste een koerant wat in daardie gebied sirkuleer die publiek en belanghebbende organisasies in kennis stel van die aanneming van—
 - (a) 'n algemene beleidsverklaring, of 'n wysiging of hersiening daarvan; of
 - (b) 'n bewaringsbestuursplan of hersiening daarvan.
- (2) Benewens die kennisgewing beoog in subregulasie (1) kan Erfenis Wes-Kaap die kennisgewing in enige ander media publiseer wat Erfenis Wes-Kaap as nodig beskou.
- (3) 'n Kennisgewing beoog in subregulasies (1) en (2) moet—

- (a) in al drie die amptelike tale van die Provinse gepubliseer word;
- (b) vermeld dat die aangename algemene beleidsverklaring of die aangename bewaringsbestuursplan vir insae beskikbaar is—
 - (i) op die amptelike Erfenis Wes-Kaap-webtuiste;
 - (ii) by die kantore van Erfenis Wes-Kaap; en
 - (iii) by enige ander plek wat Erfenis Wes-Kaap in die kennisgewing vermeld.

2. (1) ILifa leMveli leNtshona Koloni kufuneka ukuba, ngokufaka isaziso *kwiGazethi yePhondo* elinye iphepha-ndaba elikhutshwayo kwiPhondo, okanye ukuba isindululo somgaqo-nkqubo jikele okanye isicwangciso sezolawulo lolondolozo sichaphazela indawo ethile kuphela, kwiphepha-ndaba elinye ubuncinane elisasazwa kuloo ndawo, lazisa uluntu nemibutho enomdla kuko oku kulandelayo ukuba kuhlolwe yaye kuvakaliswe izimvo ngako—
 - (a) isindululo somgaqo-nkqubo jikelele, okanye isilungiso okanye uphononongo lwaso; okanye

Isaziso semibutho yezolondolozo

3. (1) ILifa leMveli leNtshona Koloni kufuneka, xa lipapasha isaziso esiqulunqwe ngokomgaqwana 2(1), siyazise imibutho yezolondolozo ekhoyo kwiPhondo ukuba ingxelo yomgaqo-nkqubo okanye isicwangciso solawulo sezolondolozo esiqulunqwe ngokwalaa mgaqo siyafumaneka ukuba singahlolwa kananjalo kuvakaliswe izimvo ngaso ngokuthumela isaziso esichanekileyo—



Significance

The farm is a generally recognised site of very high conservation importance containing very scarce fauna and flora. The two farm houses are significant examples of their types and in the instance of Bartholomeus Klip the buildings also contain early fabric. The historic significance includes being the site of a high profile murder from the early colonial period associated with slavery. The associational significance with a highly significant person in South African history (Lord de Villiers) is noteworthy. Given the length of occupation of the homesteads it is highly likely that there are archaeological remains reflecting the period of occupation.


