**WESTERN CAPE PROVINCIAL SCHOOL EDUCATION ACT, 1997 (ACT 12 OF 1997):
REGULATIONS RELATING TO THE EDUCATION COUNCIL FOR THE
PROVINCE OF THE WESTERN CAPE, 2011: DRAFT AMENDMENT 2015**

The Provincial Minister of Education, in terms of sections 11 and 63 of the Western Cape Provincial School Education Act, 1997 (Act 12 of 1997), intends to make the regulations set out in the Schedule.

SCHEDULE**Definition**

1. In these regulations “the Regulations” means the Regulations relating to the Education Council for the Province of the Western Cape, 2011, published under Provincial Notice 250/2011 in *Provincial Gazette Extraordinary* 6910 on 26 September 2011.

Amendment of regulation 1

2. Regulation 1 of the Regulations is amended—
 - (a) by the deletion of the definition of “FET college”;
 - (b) by the insertion of the following definition before the definition of “governing body associations”:

“**CET college**” means a college contemplated in paragraph (a)(ii) of the definition of “college” in the Continuing Education and Training Act, 2006 (Act 16 of 2006);”; and

- (c) by the addition of the following definitions:

“**TVET college**” means a college contemplated in paragraph (a)(i) of the definition of “college” in the Continuing Education and Training Act, 2006;

“**university**” means a university as defined in the Higher Education Act, 1997 (Act 101 of 1997).”.

Amendment of regulation 2

3. Regulation 2 of the Regulations is amended—
 - (a) by the substitution in sub-regulation (2) for the word “four” of the word “three”;

- (b) by the substitution for paragraph (a) of sub-regulation (4) of the following paragraph:
- “(a) Each of the universities situated in the province may, when so requested by the *Head of Department*, nominate three persons from their own institutions. The *Provincial Minister* must, after considering the nominations, designate three persons as members of the *Education Council*.”;;
- (c) by the substitution in paragraph (e) of sub-regulation (4) for the expression “*FET*”, wherever it occurs, of the expression “*TVET*”;
- (d) by the insertion after paragraph (e) of sub-regulation (4) of the following paragraph:
- “(eA) Each council of a *CET college* in the province may, when so requested by the *Head of Department*, nominate one person who is involved in *CET colleges*. The *Provincial Minister* must, after considering the nominations, designate one person as a member of the *Education Council*.”; and
- (e) by the substitution for sub-regulation (5) of the following sub-regulation:
- “(5) If an institution referred to in sub-regulation (4) fails to make a nomination to the *Head of Department* by a date indicated by the *Head of Department* in the request referred to in that sub-regulation, it is deemed that such institution does not want to make a nomination.”.

Amendment of regulation 3

- 4.** Regulation 3 of the Regulations is amended—
- (a) by the deletion of the word “maximum” in sub-regulation (1); and
- (b) by the substitution for sub-regulation (2) of the following sub-regulation:
- “(2) Notwithstanding sub-regulation (1), a member of the *Education Council* may serve an additional term or terms on the *Education Council*, subject to the provisions relating to nomination and designation in regulation 2.”.

Amendment of regulation 5

- 5.** Regulation 5 of the Regulations is amended by the substitution for paragraph (b) of sub-regulation (1) of the following paragraph:
- “(b) for any reason the number of members of the council falls below the quorum as determined in the rules referred to in regulation 8(6).”.

Amendment of regulation 6

6. Regulation 6 of the Regulations is amended—
- (a) by the substitution in sub-regulation (3) for the words “of a member who was designated” of the words “in the *Education Council*”; and
 - (b) by the substitution for sub-regulation (4) of the following sub-regulation:
- “(4) A member who fills a vacancy by virtue of sub-regulation (3), holds membership for the unexpired term of membership of his or her predecessor.”.

Amendment of regulation 7

7. Regulation 7 of the Regulations is amended by the substitution in sub-regulation (5) for the words “*Head of Department*” of the words “chairperson of the *Education Council*”.

Amendment of regulation 8

8. Regulation 8 of the Regulations is amended by the substitution in sub-regulation (5) for the word “twice” of the words “four times”.

Transitional provisions

9. Subject to regulations 4 and 6 of the Regulations, a member of the *Education Council*—
- (a) who is appointed in terms of regulation 2(2) of the Regulations before the commencement of these amendment Regulations, continues to hold office for the duration of his or her term; or
 - (b) whose membership is extended in terms of regulation 3(2) of the Regulations before the commencement of these amendment Regulations, continues to hold office for the duration of his or her extended term.

Commencement

10. (1) Regulations 2(b) and 3(d) come into operation on 1 January 2018.
(2) Regulation 8 comes into operation on 1 January 2016.

REGULASIES BETREFFENDE DIE ONDERWYSRAAD VIR DIE PROVINSIE VAN
DIE WES-KAAP, 2011: KONSEPWYSIGING 2015**

Die Provinciale Minister van Onderwys is van voorneme om, ingevolge artikels 11 en 63 van die Wes-Kaapse Provinciale Wet op Skoolonderwys, 1997 (Wet 12 van 1997), die regulasies uiteengesit in die Bylae te maak.

BYLAE**Woordomskrywing**

1. In hierdie regulasies beteken “die Regulasies” die Regulasies betreffende die Onderwysraad vir die Provincie van die Wes-Kaap, gepubliseer onder Provinciale Kennisgewing 250/2011 in *Buitengewone Provinciale Koerant* 6910 op 26 September 2011.

Wysiging van regulasie 1

2. Regulasie 1 van die Regulasies word gewysig—
 - (a) deur die volgende omskrywing na die omskrywing van “georganiseerde besigheid” in te voeg:

“**GOO-kollege**” ’n kollege beoog in paragraaf (a)(ii) van die omskrywing van “college” in die “Continuing Education and Training Act, 2006” (Wet 16 van 2006), in Afrikaans vertaal as ’n “gemeenskapsonderwys- en opleidingskollege”;; en
 - (b) deur die volgende omskrywings in te voeg:

“**TBOO-kollege**” ’n kollege beoog in paragraaf (a)(i) van die omskrywing van “college” in die “Continuing Education and Training Act, 2006”, in Afrikaans vertaal as ’n “tegniese en beroepsonderwys- en opleidingskollege”; **‘universiteit’** ’n universiteit soos omskryf in die Wet op Hoër Onderwys, 1997 (Wet 101 van 1997).”; en
 - (c) deur die omskrywing van “VOO-kollege” te skrap.

Wysiging van regulasie 2

3. Regulasie 2 van die Regulasies word gewysig—
 - (a) deur in subregulasie (2) die woord “Vier” deur die woord “Drie” te vervang;

- (b) deur paragraaf (a) van subregulasie (4) deur die volgende paragraaf te vervang:
- “(a) Elkeen van die universiteite wat in die provinsie is, mag, wanneer so versoek deur die *Departementshoof*, drie persone vanuit hulle eie inrigting nomineer. Die *Provinsiale Minister* moet, na oorweging van die nominasies, drie persone aanwys as lede van die *Onderwysraad*.”;;
- (c) deur in paragraaf (e) van subregulasie (4) die uitdrukking “*VOO-kollege*”, waar dit ook al voorkom, deur die uitdrukking “*TBOO-kollege*” te vervang;
- (d) deur na paragraaf (e) van subregulasie (4) die volgende paragraaf in te voeg:
- “(eA) Elke raad van ’n *GOO-kollege* in die provinsie mag, wanneer so versoek deur die *Departementshoof*, een persoon nomineer wat betrokke is by *GOO-kolleges*. Die *Provinsiale Minister* moet, na oorweging van die nominasies, een persoon aanwys as ’n lid van die *Onderwysraad*.”; en
- (e) deur subregulasie (5) deur die volgende subregulasie te vervang:
- “(5) Indien ’n inrigting soos bedoel in subregulasie (4) nalaat om ’n nominasie te maak aan die *Departementshoof* teen ’n datum soos aangedui deur die *Departementshoof* in die versoek soos in daardie subregulasie bedoel, word dit geag dat daardie inrigting nie ’n nominasie wil maak nie.”.

Wysiging van regulasie 3

4. Regulasie 3 van die Regulasies word gewysig—
- (a) deur die woord “maksimum” in subregulasie (1) te skrap; en
- (b) deur subregulasie (2) deur die volgende subregulasie te vervang:
- “(2) Nieteenstaande subregulasie (1), mag ’n lid van die *Onderwysraad* ’n bykomende termyn of termyne in die *Onderwysraad* dien, behoudens die bepalings betreffende nominasie en aanwysing in regulasie 2.

Wysiging van regulasie 5

5. Regulasie 5 van die Regulasies word gewysig deur paragraaf (b) van subregulasie (1) deur die volgende paragraaf te vervang:
- “(b) om enige rede die getal lede van die Raad minder geraak het as die kworum soos bepaal in die reëls bedoel in regulasie 8(6).”.

Wysiging van regulasie 6

6. Regulasie 6 van die Regulasies word gewysig—
- (a) deur in subregulasie (3) die woorde “van ’n lid wat aangewys is,” deur die woorde “in die Onderwysraad” te vervang; en
 - (b) deur subregulasie (4) deur die volgende subregulasie te vervang:

“(4) ’n Lid wat uit hoofde van subregulasie (3) ’n vakature vul, verkry lidmaatskap vir die onverstrekke termyn van lidmaatskap van sy of haar voorganger.”.

Wysiging van regulasie 7

7. Regulasie 7 van die Regulasies word gewysig deur in subregulasie (5) die woord “Departementshoof” deur die woorde “voorsitter van die *Onderwys-raad*” te vervang.

Wysiging van regulasie 8

8. Regulasie 8 van die Regulasies word gewysig deur in subregulasie (5) die woord “twee” deur die woord “vier” te vervang.

Oorgangsbeplings

9. Behoudens regulasies 4 en 6 van die Regulasies—

- (a) beklee ’n lid van die *Onderwysraad* wat ingevolge regulasie 2(2) van die Regulasies voor die inwerkingtreding van hierdie Wysigings-regulasies aangestel is steeds sy of haar amp vir die duur van sy of haar termyn; of
- (b) beklee ’n lid van die *Onderwysraad* wie se lidmaatskap ingevolge regulasie 3(2) van die Regulasies voor die inwerkingtreding van hierdie Wysigingsregulasies verleng is steeds sy of haar amp vir die duur van sy of haar verlengde termyn.

10. (1) Regulasies 2(b) en 3(d) tree in werking op 1 Januarie 2018.
(2) Regulasie 8 tree in werking op 1 Januarie 2016.

“**ikholeji ye-CET**” ithetha ikholeji njengoko kucamngciweyo kumhlathi (a)(ii) wenkazo-magama ye “kholeji” kuMthetho *i-Continuing Education and Training Act* (uMthetho weMfundu noQeqesho olusaQhubekayo), ka-2006 (uMthetho 16 ka-2006);”;

- (c) nangokongezwa kwezi nkazo-magama zilandelayo:

“**ikholeji ye-TVET**” ithetha ikholeji njengoko kucamngciweyo kumhlathi (a)(i) wenkazo-magama ye “kholeji” kuMthetho *i-Continuing Education Act* (uMthetho weMfundu noQeqesho olusaQhubekayo), ka-2006;

- “(a) Iyunivesithi nganye kwezikweli phondo zinako, zakuba zicelwe ngolo hlobo *yiNtloko yeSebe*, ukutyumba abantu abathathu kumaziko azo. *UMphathiswa wePhondo* kufu-neka, emva kokuba eqwalasele izicelo zabatyunjwa atyumbe abantu abathathu njengamalungu *eBhunga lezeMfundu*.”;;
- (c) ngokususwa kumhlathi (e) wommiselwana (4) webinzana u- “*FET*”, naphi aphi kukho ukufumaneka, kwebinzana u- “*TVET*”;
- (d) ngokufakwa kulandela emva komhlathi (e) wommiselwana (4) walo mhlathi ulandelayo:
- “(eA) Ibhunga ngalinye *lekholeji ye-CET* kwiphondo linako, xa kucelwe ngolo hlobo *yiNtloko yeSebe*, ukutyumba umntu abe mnye, obandakanyekayo *kwiikholeji ze-CET*. *UMphathiswa wePhondo* kufuneka, emva kokuqwalasela izicelo zabatyunjwa atyumbe umntu abe mnye njengelungu *leBhunga lezeMfundu*.”; kunye
- (e) nangokususwa kommiselwana (5) walo mmiselwana ulandelayo:
- “(5) Ukuba iziko ekubhekisa kulo kummiselwana (4) alili-thumeli igama lomtyunjwa *kwiNtloko yeSebe* kwisicelo ekubhekiselelwe kuso kuloo mmiselwana, oko kuthathwa njengokuba iziko elo alifuni kwenza utyumbo.”.

- “(2) Ngokungaphandle kommiselo (1), ilungu *leBhunga lezeMfundu* linokubamba kwisikhundla elityunjelwe kuso ixesha okanye amaxesha andisiweyo *kwiBhunga lezeMfundu* phantsi kwemimiselo emalunga nokutyunjwa kwamagama nokutyunjelwa esikhundleni kummiseloso 2.”.
