I, Mr David Maynier, Provincial MEC for Finance and Economic Opportunities in the Western Cape, in terms of section 71(7) of the Local Government: Municipal Finance Management Act (No. 56 of 2003), publish the consolidated statement on municipal budgets in the Western Cape Province. The consolidated statement reflects the financial performance of municipalities as at the end of the second quarter (ending 31 December 2020) of the 2020/21 municipal financial year.

The Provincial Treasury is using the National Treasury Database as the primary source for the information reported in this publication. Although every effort has been made to compile a reliable set of numbers, the quality and completeness of the information is affected by the credibility of reports submitted by municipalities.

Summary on the State of Local Government Revenue and Expenditure: Second Quarter Consolidated Statement for the period 1 October 2020 - 31 December 2020

Background

Section 71 (7) of the Municipal Finance Management Act (MFMA) requires that the Provincial Treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budgets per municipality and per municipal entity.

This publication forms part of the In-Year Management, Monitoring and Reporting System for Local Government which enables the Provincial Treasury to exercise oversight over municipalities in the Western Cape. It provides a high-level review of the implementation of municipal budgets for the second quarter, ending 31 December 2020.

Data used

National Treasury's Local Government Database is the primary data source used for this publication. The quality of the report is subject to the credibility of the municipal Standard Chart of Accounts (mSCOA) data string information submitted and is compromised when municipalities fail to submit all the required data strings.

Some anomalies were noted in the submissions made by municipalities which have a significant impact on the credibility of the financial information reported for the period ending 31 December 2020. Discrepancies on key indicators were observed on the negative cash and cash equivalent budgets as well as the year-to-date actuals reported by some municipalities as well as misalignment on capital funding and expenditure.

The following were noted as contributing factors to inconsistencies between the Municipal Budget and Reporting Regulation (MBRR) schedules and mSCOA data strings:

- Incorrect use of movements account in the mSCOA;
- The use of incorrect mSCOA segments;
- Some Municipalities budgeting and transacting outside the core financial system;
- Errors in the linkages of MBRR tables and mSCOA data strings in the National Treasury Database

The municipal capital and cash flow budget performance presented in this publication may not align to the performance reported by municipalities to their respective Councils in their Financial Management Reports (FMR).

The above challenges are to be corrected in the 2020/21 Municipal Adjustment Budget process using the guidelines provided by National Treasury through mSCOA circulars 10 and 11 that provide further guidance to improve credibility of data strings, especially on cash flow misalignments. Based on such support from both National and Provincial Treasuries, Western Cape municipalities are committed to improving the quality of financial information.

The data presented in this gazette provides a summary of budget implementation performance against key indicators for all municipalities in the province. Detailed information for each municipality is available to the public in the section 71 files published at mfma.treasury.gov.za.

Aggregated Trends

1. On aggregate, Western Cape municipalities spent 40.9 per cent or R32.71 billion of the total adopted expenditure budget of R79.89 billion by the midpoint of the municipal financial year on 31 December 2020 (operating expenditure accounted for R29.18 billion and capital expenditure for R3.53 billion). In respect of revenue, aggregate billing and other revenue amounted to 48.0 per cent or R36.67 billion of the total adopted revenue budget of R76.44 billion (operating revenue accounted for R32.92 billion and capital revenue for R3.75 billion).
2. Aggregate operating revenue for the period ended 31 December 2020 amounted to R32.92 billion or 51.8 per cent of the original operating revenue budget of R63.51 billion, a negative variance of 0.9 per cent when compared to the year to date budget of R33.22 billion.
3. Service charges and property rates are the largest revenue sources, contributing 48.6 and 21.6 per cent respectively, towards the total operating revenue budget of R63.51 billion. As at the end of the second quarter service charges generated R15.19 billion (49.2 per cent of the R30.86 billion annual budget) and property rates generated R7.17 billion (52.3 per cent of the R13.7 billion annual budget). These amounts represent billed revenue and not actual revenue collected. Therefore, municipalities must apply stringent debt collection strategies to realise their planned revenue.
4. Transfers and subsidies revenue are reported as R5.81 billion or 62.1 per cent against the R9.35 billion budget as at 31 December 2020. Other own revenue is reported as R4.20 billion against the budget of R8.31 billion which represents an under-recovery of 6.2 per cent when compared to the year to date budget (R4.48 billion).
5. For the period under review municipalities spent R29.18 billion or 43.6 per cent of their aggregated R66.95 billion operating expenditure budget. This reflects an under performance of 7.5 per cent against the year to date budget of R31.55 billion.
6. The year to date operating expenditure for the City of Cape Town (Metro) amounts to R20.39 billion or 45.2 per cent of their R45.14 billion budget. Secondary cities (Drakenstein, George and Stellenbosch municipalities) reported spending of 40.5 per cent or R2.75 billion against their collective operating expenditure budget of R6.78 billion. District Municipalities reported spending R681.18 million or 42.3 per cent of their total operating budget, while the remaining Local Municipalities spent R5.35 billion or 39.9 per cent against their total operating budget of R13.41 billion.
7. Salaries and Wages are the largest contributor to the operating expenditure budget accounting for 33.6 per cent of the total operating expenditure, followed by other expenditure at 28.4 per cent. All other operating expenditure combined contributes 38 per cent. The highest operating expenditure items to-date are Employee related costs amounting to R10.50 billion followed by Materials and bulk purchases of R8.13 billion and Other expenditure amounting to R7.67 billion.
8. Western Cape municipalities spent R3.53 billion or 27.3 per cent against the R12.94 billion original capital budget. However, the capital expenditure reflected in the data strings is lower than the actual capital spending reported by some municipalities in their Financial Management Reports (FMR) that were presented to their respective Councils. These disparities are mainly the result of mSCOA challenges described above and municipalities are assessing reports for correction in the ensuing periods.

9. The City of Cape Town is the largest contributor to the overall capital performance and reported spending of R2.21 billion or 22.9 per cent of their original capital budget of R9.68 billion. This amount is less than the year to date amount of R2.92 billion (30.2 per cent) reported in the municipal MBRR and the difference is currently being assessed for correction. Secondary cities (Drakenstein, George and Stellenbosch municipalities) reported capital expenditure performance of R287.35 million or 29.3 per cent against their combined original budget of R980.7 million. The capital budget spending for district municipalities amounted to R8.76 million or 15.5 per cent of their total budget of R56.44 million and local municipalities' capital spending amounted to R1,02 billion or 46 per cent of their R2.23 billion budget.
10. In aggregate, the Western Cape municipalities fund 66.9 per cent of their total planned capital investment from own funding. This is made up of borrowing (25.7 per cent) and internally generated funds (41.2 per cent).
11. Capital spending against borrowings amounted to R891.78 million or 26.9 per cent against budgeted borrowings of R3.32 billion. Capital spending funded from transfers recognised amounted to R956.01 million or 22.4 per cent against the R4.28 billion budgeted for and spending funded from internally generated funds amounted to R1.89 billion or 35.6 per cent against the R5.33 billion budgeted for.
12. Aggregate municipal consumer debtors as at 31 December 2020 amounted to R13.42 billion, which represents a slight increase of 1.6 per cent from R13.2 billion reported in Quarter 1 of 2020/21. The largest share is owed by households, which account for R9.89 billion or 73.7 per cent of the total. Household debt has increased by 7.9 per cent from the R9.17 billion reported in the previous quarter. Organs of state account for R202.54 million or 1.5 per cent of the total debt.
13. Debtors older than 90 days amount to R9.39 billion or 70 per cent of the total outstanding debtors of R13.42 billion. This amount represents an increase of 25.7 per cent from the R7.47 billion reported in quarter 2 of 2019/20. These amounts include historic debt that has accumulated over an extended period, interest on arrears and other recoveries.
14. In aggregate, Western Cape municipalities reported outstanding creditors of R369.92 million as at 31 December 2020. The total outstanding creditors older than 30 days' amount to R119.91million or 32.4 per cent of the total.
15. Of the above total creditors amount, R29.45 million (24.6 per cent) relates to creditors outstanding for more than 30 days in respect of Kannaland Municipality. This municipality is being assisted through a Financial Recovery Plan. A further R44.63 million (37.2 per cent) of the total outstanding creditors in excess of 30 days is owed by Cederberg Municipality and R28.76 million (24 per cent) is owed by Beaufort West Municipality. These amounts are largely owed to Eskom, Auditor General and other trade creditors.
16. The total cash and cash equivalents reported by municipalities as at the end of quarter 2 amount to R22.78 billion. This amount is not aligned to the MBRR schedules reported to municipal councils as explained above.
17. Provincial Treasury will continue to provide support to municipalities including guidance in respect of the COVID-19 response, support with mSCOA implementation, budget verifications, Annual Budget and In-Year Monitoring training, capacity building training initiatives, quarterly Chief Financial Officers' and Municipal Accountants Forums as well as facilitating the reduction of government debt owed to municipalities in conjunction with various government departments.
