**DEPARTMENT OF TRANSPORT AND PUBLIC WORKS: WESTERN CAPE
NATIONAL LAND TRANSPORT ACT, 2009 (ACT 5 OF 2009)
EXTRAORDINARY MEASURES IN DECLARED AREAS**

I, Daylin Mitchell, Provincial Minister of Transport and Public Works in the Western Cape, having defined and declared, in Government Notice 416 of 2021 in *Government Gazette* 44836 dated 9 July 2021, that Bellville and Paarl (the declared areas) are areas in respect of which extraordinary measures in terms of section 91(2) of the National Land Transport Act, 2009 (Act 5 of 2009) (the Act), may be made, give notice that—

- (a) under section 91(2)(a) of the Act, the routes and ranks, including loading lanes and a long-distance route facility situated at the Bellville Public Transport Interchange, set out in the Schedule, that are situated in the declared areas, are closed for the operation of any minibus taxi-type services for a period of two months (the closure period), commencing on 26 July 2021;
- (b) under section 91(2)(b) of the Act, any operating licence or permit authorising any minibus taxi-type services on a closed route or at a closed rank contemplated in paragraph (a) is suspended for the duration of the closure period;
- (c) under section 91(2)(c) of the Act, and subject to paragraph (e), no person may, for the duration of the closure period, undertake any minibus-taxi-type services on a closed route or at a closed rank contemplated in paragraph (a), or in terms of an operating licence or permit suspended as contemplated in paragraph (b);
- (d) under section 91(5) of the Act, a current minibus taxi operator who contravenes this Notice, or fails to comply therewith, commits an offence and is liable on conviction to a fine of R5000,00, or to imprisonment for a period not exceeding six months;
- (e) under section 91(6) of the Act, a temporary permit may be issued to an operator of a motor vehicle, minibus or midibus to operate a minibus-taxi-type service, or to an operator of a bus to operate a bus service, on a closed route or at a closed rank during the closure period in substitution for the prohibited services contemplated in paragraph (a).

Ek, Daylin Mitchell, Provinsiale Minister van Vervoer en Openbare Werke in die Wes-Kaap, nadat ek, in Goewermentskennisgewing 416 van 2021 in Staatskoerant 44836 gedateer 9 Julie 2021, omskryf en verklaar het dat Bellville en die Paarl (die verklaarde gebiede) gebiede is ten opsigte waarvan buitengewone maatreëls ingevolge artikel 91(2) van die “National Land Transport Act, 2009” (Wet 5 van 2009) (die Wet), getref kan word, gee kennis dat—

- (a) kragtens artikel 91(2)(a) van die Wet, die roetes en staanplekke, insluitende laaiplekke en ’n langafstandroetefasiliteit geleë by die Bellville Openbare Vervoer-wisselaar, uiteengesit in die Bylae, wat geleë is in die verklaarde gebiede, gesluit is vir die bedrywigheide van enige minibustaxi-tipe dienste vir ’n tydperk van twee maande (die sluitingstydperk), met ingang van 26 Julie 2021;
- (b) kragtens artikel 91(2)(b) van die Wet, enige bedryfslisensie of permit wat enige minibustaxi-tipe dienste magtig op ’n geslote roete of by ’n geslote staanplek beoog in paragraaf (a) opgeskort is vir die duur van die sluitingstydperk;
- (c) kragtens artikel 91(2)(c) van die Wet, en behoudens paragraaf (e), geen persoon, vir die duur van die sluitingstydperk, enige minibustaxi-tipe dienste op ’n geslote roete of by ’n geslote staanplek beoog in paragraaf (a), of ingevolge ’n bedryfslisensie of permit wat soos beoog in paragraaf (b) opgeskort is, mag onderneem nie;
- (d) kragtens artikel 91(5) van die Wet, ’n huidige minibustaxi-operateur wat hierdie Kennisgewing oortree, of versuim om daaraan te voldoen, ’n misdryf pleeg en by skuldigebevinding strafbaar is met ’n boete van R5000,00, of met gevangenisstraf vir ’n tydperk van hoogstens ses maande;
- (e) kragtens artikel 91(6) van die Wet, ’n tydelike permit uitgereik kan word aan ’n operateur van ’n motorvoertuig, minibus of midibus om ’n minibustaxi-tipe diens te bedryf, of aan ’n operateur van ’n bus om ’n busdiens te bedryf, op ’n geslote roete of by ’n geslote staanplek gedurende die sluitingstydperk om die verbode dienste beoog in paragraaf (a) te vervang.
