Act No. 6, 2000 CHIROPRACTORS, HOMEOPATHS AND ALLIED HEALTH
SERVICE PROFESSIONS AMENDMENT ACT, 2000

ACT

To amend the Chiropractors, Homeopaths and Allied Health Service Professions Act, 1982, in order to extend the terms of office of the members of the Chiropractors, Homeopaths and Allied Health Service Professions Interim Council, retrospectively; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 3 of Act 63 of 1982, as amended by section 4 of Act 40 of 1995 and section 1 of Act 91 of 1997

1. Section 3 of the Chiropractors, Homeopaths and Allied Health Service Professions Act, 1982, is hereby amended by the substitution for paragraph (e) of the following paragraph: 5

“(e) to make recommendations to the Minister on the constitution of the new council within a period not exceeding [36] 60 months calculated as from the date of commencement of the Chiropractors, Homeopaths and Allied Health Service Professions Amendment Act, 1995 (Act No. 40 of 1995); and” 10

Amendment of section 5 of Act 63 of 1982, as substituted by section 6 of Act 40 of 1995 and amended by section 2 of Act 91 of 1997

2. Section 5 of the Chiropractors, Homeopaths and Allied Health Service Professions Act, 1982, is hereby amended by the substitution for subsection (6) of the following subsection: 15

“(6) Subject to the provisions of section 6, the members of the council shall hold office as from the date contemplated in subsection (5) until the date of the constitution of a new council but not exceeding a period of [36] 60 months.”.

Short title 20

3. This Act is called the Chiropractors, Homeopaths and Allied Health Service Professions Amendment Act, 2000, and must be regarded as having come into operation on 13 February 1999.

Tot wysiging van die Wet op Chiropraktisyns, Homeopate en Verwante Gesondheidsdiensberoepe, 1982, ten einde die ampstermyn van die lede van die Interim Raad vir Chiropraktisyns, Homeopate en Verwante Gesondheidsdiensberoepe terugwerkend te verleng; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 3 van Wet 63 van 1982, soos gewysig deur artikel 4 van Wet 40 van 1995 en artikel 1 van Wet 91 van 1997

- 5 **1.** Artikel 3 van die Wet op Chiropraktisyns, Homeopate en Verwante Gesondheidsdiensberoepe, 1982, word hierby gewysig deur paragraaf (e) deur die volgende paragraaf te vervang:
- 10 “(e) om binne ’n tydperk van hoogstens [36] 60 maande vanaf die datum van die inwerkingtreding van die Wysigingswet op Chiropraktisyns, Homeopate en Verwante Gesondheidsdiensberoepe, 1995 (Wet No. 40 van 1995), aanbevelings aan die Minister te doen oor die samestelling van ’n nuwe raad; en”.

Wysiging van artikel 5 van Wet 63 van 1982, soos vervang deur artikel 6 van Wet 40 van 1995 en gewysig deur artikel 2 van Wet 91 van 1997

- 15 **2.** Artikel 5 van die Wet op Chiropraktisyns, Homeopate en Verwante Gesondheidsdiensberoepe, 1982, word hierby gewysig deur subartikel (6) deur die volgende subartikel te vervang:
- “(6) Behoudens die bepalings van artikel 6 beklee die lede van die raad hulle amp vanaf die datum in subartikel (5) beoog tot die datum van die samestelling van ’n nuwe raad, maar vir ’n tydperk van hoogstens [36] 60 maande.”.
