ACT

To effect adjustments to the appropriation of money from the National Revenue Fund for the requirements of the State in respect of the 2017/18 financial year; and to provide for matters incidental thereto.

PREAMBLE

WHEREAS section 213(2) of the Constitution of the Republic of South Africa, 1996, provides that money may be withdrawn from the National Revenue Fund only in terms of an appropriation by an Act of Parliament or as a direct charge against that Fund, when it is provided for in the Constitution of the Republic of South Africa, 1996, or an Act of Parliament;

WHEREAS the Appropriation Act, 2017 (Act No. 6 of 2017), provides for the appropriation of money from the National Revenue Fund to provide for the requirements of the State in respect of the 2017/18 financial year;

AND WHEREAS section 12(1) and (2) of the Money Bills Amendment Procedure and Related Matters Act, 2009 (Act No. 9 of 2009), provides for the tabling of a national adjustments budget, as envisaged in section 30 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), with an adjustments appropriation Bill, to make adjustments to the appropriations in an Appropriation Act,

B IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in section 1 of the Appropriation Act, 2017, or section 1 of the Public Finance Management Act, 1999, must bear the meaning so assigned. 5

Adjustments to appropriations of money for requirements of State

2. (1) Adjustments to appropriations by Parliament of money from the National Revenue Fund for the requirements of the State in the 2017/18 financial year to votes and the main divisions within a vote, and amendments to the purposes that are specified, are set out in the Schedule to this Act. 10

(2) The spending of appropriations envisaged in subsection (1) is subject to the provisions of this Act, the Public Finance Management Act, 1999, and the Division of Revenue Act, 2017 (Act No. 3 of 2017).

Thanololo

1. Mo Molaong ono, ntle le fa bokao bo tlhalosa ka mokgwa mongwe, lefoko kgotsa tlhagiso nngwe le nngwe e e neilweng bokao mo karolong 1 ya Molao wa Tekanyetso, 2017, kgotsa mo karolong 1 ya *Public Finance Management Act*, 1999, e tshwanetse go nna le bokao jo bo e neilweng. 5

Diphetolo mo ditekanyetsong tsa madi mabapi le ditlhokego tsa Mmuso

2. (1) Diphetolo mo ditekanyetsong ka Palamente tsa madi a a tswang kwa Letloleng la Lotseno la Bosetšhaba mabapi le ditlhokego tsa Mmuso mo ngwageng wa ditšhelete wa 2017/18 mo diboutung le mo dikarologanyokgolong mo gare ga boutu, le ditlhabololo tsa maitlthomo a a tsepamisitsweng, di tlhagisitswe mo Sejuleng ya Molao ono. 10

(2) Tiriso ya ditekanyetso tse di bonetsweng pele mo karotlaleletsong (1) e go ya ka ditaelosemolao tsa Molao ono, *Public Finance Management Act*, 1999, le Molao wa Karoganyo ya Letseno, 2017 (Molao 3 wa 2017). 15

Amounts listed as specifically and exclusively appropriated

3. An amount within a vote or a main division within a vote that is listed as specifically and exclusively appropriated in the Schedule to this Act, may be used only for the purpose indicated, unless the amount or purpose for which it was appropriated, is amended by, or in terms of, an Act of Parliament. 5

Conditions for appropriations

4. (1) The Minister may, in writing—
 (a) impose conditions on an appropriation in the Schedule to this Act, other than a conditional allocation, in order to promote transparency and accountability and the effective management of the appropriation; and 10
 (b) stop the use of an appropriation in respect of which conditions have been imposed in terms of paragraph (a), until such conditions are met.
 (2) The stoppage of an appropriation in terms of subsection (1)(b) must be disclosed in the National Treasury's next quarterly report to the relevant Parliamentary Committees. 15

Use of unspent funds

5. (1) Despite section 3 of this Act, section 3 of the Appropriation Act, 2017, and section 43 of the Public Finance Management Act, 1999, only the Minister may, for purposes of service delivery, approve that unspent funds in an amount appropriated in the Schedule to the Appropriation Act, 2017, or the Schedule to this Act, be used for 20 compensation of employees within the same vote.
 (2) Despite section 3 of this Act and section 43 of the Public Finance Management Act, 1999, the Minister may, for purposes of service delivery, approve that unspent funds in an amount appropriated in the Schedule to this Act for—
 (a) compensation of employees, be used within the same vote for transfers and 25 subsidies for the payment of severance or exit packages;
 (b) transfer and subsidies to other institutions, be used—
 (i) for compensation of employees in terms of subsection (1); or
 (ii) elsewhere within the same main division; or
 (c) payments for capital assets, be used— 30
 (i) for compensation of employees in terms of subsection (1); or
 (ii) elsewhere within the same vote.
 (3) The approval of the use of unspent funds in terms of subsection (1) or (2) must be disclosed in the National Treasury's next quarterly report to the relevant Parliamentary Committees. 35

Delegations and authorisations

6. (1) The Minister may—
 (a) delegate to an employee of the National Treasury any power conferred on the Minister in terms of this Act, except sections 5(1) and 7; and
 (b) authorise an employee of the National Treasury to perform any duty imposed 40 on the Minister in terms of this Act.
 (2) A delegation or authorisation in terms of subsection (1)—
 (a) must be in writing;
 (b) is subject to any limitations or conditions that the Minister may impose;
 (c) may authorise that employee to sub-delegate, in writing, the delegated power 45 or authorised duty to another suitable employee of the National Treasury;
 (d) does not divest the Minister of the responsibility concerning the exercise of the delegated power or the performance of the authorised duty; and
 (e) may be withdrawn by the Minister in writing.
 (3) The Minister may vary or revoke any decision taken by an employee as a result of 50 a delegation or authorisation in terms of subsection (1), subject to any rights that may have vested as a result of the decision.

- (2) Tholelo kgotsa tumelelo go ya ka karotlaleletso (1)—
- (a) e tshwanetse go kwalwa;
 - (b) e go latela meelwane mengwe le mengwe kgotsa mabaka a a ka pateletswang ke Tona;
 - (c) e ka dumelela gore mothapiwa a rolele ka tlaleletso, ka go kwala, thata e e roletsweng kgotsa tiro e e dumeletsweng go mothapiwa yo mongwe yo o matshwanedi wa Matlotlo a Bosetšhaba;

Regulations

7. The Minister may, by notice in the *Gazette*, make regulations regarding any ancillary or incidental administrative or procedural matter that it is necessary to prescribe for the proper implementation or administration of this Act.
