The National Agricultural Marketing Council (NAMC) received a request from the Sorghum Forum, on behalf of directly affected groups in the sorghum industry, for the introduction and promulgation of a statutory measure, namely a levy of R10,00 per ton sorghum, excluding VAT, payable by the buyers, processors, importers and exporters of sorghum, for four years, to the Sorghum Trust. The existing sorghum levy of R16.00 per ton sorghum, VAT excluded, will lapse on 28 February 2014.

The purpose and aims of this statutory levy are to provide financial support for the sorghum information, transformation and research functions.

The budgeted income from the proposed levy is estimated at approximately R1.7 in 2014/15 and it could increase to R5.5 million in 2017/18. A gradual increase in the production of sorghum is foreseen over the period, due to the possible utilisation of sorghum for the manufacture of bio-fuels. The assumptions regarding increased crop sizes over the four year period are, however, entirely dependent on the actual implementation of the bio-fuel policy within the expected time-frame and the success thereof with the utilisation of sorghum for this purpose. An annual income of at least R2.1 million will ensure the continuation of information, research and transformation projects to the benefit of the sorghum industry.

10(1)(b) OF THE COMPETITION ACT 89 OF 1998:  
NATIONAL HOSPITAL NETWORK**

An application for an exemption from the provisions of the Competition Act 89 of 1998, as amended ("the Competition Act") has been filed with the Competition Commission of South Africa ("the Commission") by the National Hospital Network ("NHN"), in terms of Section 10(1)(b) of the Competition Act.

The NHN is a limited non-listed company. Membership is limited to independent private hospitals operating in Southern Africa. 'Independent' in this context of the application means hospitals not owned or controlled by one of the following hospital groups: Netcare Holdings, Life Healthcare Group and Medi-Clinic (herein after collectively referred to as "the three large hospital groups").

The NHN has been granted exemptions by the Commission in terms of Section 10(3)(b)(ii) of the Competition Act on two (2) occasions before.<sup>1</sup> The grounds and rationale for the current exemption application are similar to those that were previously presented to the Commission in the previous applications.

The application for exemption primarily relates to tariff negotiations between the NHN acting on behalf of its members and individual medical schemes and medical scheme administrators, as well as agreements that result from the collective bargaining. In addition the NHN also promotes the interests of its members and markets theirs services and provides a base for benchmarking.

Also of relevance in this current application are the revised conditions of membership which the NHN wishes to impose on its current and potential members. The following are the conditions of membership which the NHN wishes to impose:

- a) No member shall be directly or indirectly associated with any one of the three large hospital groups. This shall apply to ownership, control or any other association in terms of which any of the three large hospital groups have insight into the business activities of the member.
- b) Members shall comply with the payment terms and conditions of agreements entered into on their behalf by the NHN.
- c) Although members shall be permitted to enter into individual agreements with schemes and administrators where so-called "local options" make that feasible, they shall submit such agreements to the NHN for vetting and approval.

The latter condition is proposed to be implemented as from January 2014 and be applied retroactively to all current members and shall be a condition to new members.

More specifically, the NHN has requested that it be permitted to engage in the following activities:

- Continuing to service existing agreements with medical schemes and/or medical scheme administrators;
- Entering into new agreements with medical schemes and/or medical scheme administrators;

- Accepting new members into the NHN who are not directly or indirectly controlled by, or affiliated with, any one of the three large hospital groups
- That all members should adhere to the revised membership criteria.
- Continuing to promote the interests of its members and to market their services and also to provide a base for benchmarking.

The NHN submits that the collective agreements between its members and shareholders would contravene section 4(1)(b)(i) of the Competition Act which is a *per se* prohibition that cannot be defended on efficiency, technological or pro-competitive grounds. The NHN avers that the above conduct is however necessary to attain the objective stipulated under section 10(3)(b)(ii) of the Act, namely, that it contributes to the objective of promoting the ability of small business and also firms owned or controlled by historically disadvantaged persons to become competitive. The NHN is of the view that the only manner in which the majority of independent hospitals will be able to survive in the long term would be to continue to collaborate in their negotiations with medical schemes and to create competition in the market.

The NHN has requested that that exemption be granted for a period of five (5) years. Though the NHN has expressed its preference for a longer period their request is based on the fact that the Commission had previously granted the NHN with exemptions for similar agreements for a period of five (5) years each.

In accordance with the provisions of Section 10(6)(a) of the Competition Act, notice is hereby given of the above application for exemption. Interested parties can make written submissions to the Commission as to why the exemption should or should not be granted as required by section 10(6)(b) of the Competition Act.

**NOTICE 44 OF 2014****INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF INITIATION OF A SUNSET REVIEW OF ANTI-DUMPING DUTIES ON  
WIRE ROPES AND CABLES OF A DIAMETER EXCEEDING 32MM ORIGINATING IN  
OR IMPORTED FROM THE UNITED KINGDOM (THE UK) AND GERMANY AND ON  
STRANDED WIRE OF A DIAMETER EXCEEDING OR EQUAL TO 12.7MM  
ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA  
(THE PRC)**

In accordance with the provisions in Section 53.1 of the Anti-Dumping Regulations, any definitive anti-dumping duty shall be terminated on a date not later than five years from its imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the anti-dumping duties would likely lead to continuation and/or recurrence of dumping and material injury.

On 28 June 2013, the International Trade Administration Commission of South Africa (the Commission) notified the interested parties through Notice No. 664 of 2013 in Government Gazette No. 36592, that unless a substantiated request is made indicating that the expiry of the anti-dumping duties on imports of wire ropes and cables and stranded wire originating in or imported from Germany, the United Kingdom , China and South Korea and countervailing duties on wire ropes and cables and stranded wire originating in or imported from India would likely lead to the continuation and/or recurrence of dumping and injury, the anti-dumping and countervailing duties will expire on 12 February 2014.

On 01 November 2013 the International Trade Administration Commission of South Africa (the Commission) received a sunset review application from Scaw South Africa (Pty) Ltd.

### **THE APPLICANT**

The application was lodged by Scaw South Africa (Pty) Ltd, representing 100 per cent by production volume of the SACU producers. The applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that a sunset review investigation should be initiated.

### **THE PRODUCT**

The product allegedly being dumped is wire ropes and cables of a diameter exceeding 32mm classifiable under tariff subheadings 7312.10.25 and 7312.10.40 originating in or imported from the United Kingdom and Germany and on stranded wire of a diameter exceeding or equal to 12.7mm classifiable under tariff subheading 7312.10.20 originating in or imported from the PRC .

### **THE ALLEGATION OF THE CONTINUATION AND/OR RECURRENCE OF DUMPING**

The allegation of continuation and/or recurrence of dumping is based on the comparison between the normal values and the export prices.

The normal value for the UK was determined based on UK exports of the subject product to Canada and an adjustment for inland freight was made to bring the FOB price to an ex-factory price. The normal value for Germany was determined based on German exports of the subject product to Austria and an adjustment for inland freight was made to bring the FOB price to an ex-factory price. The normal value for China was determined based on a constructed cost and price build-up.

The export prices for the UK and Germany were determined based on exports of the subject product from the UK and Germany to South Africa and an adjustment for inland freight was made to bring the FOB price to an ex-factory price. The export price for the PRC was determined based on an export quotation and an adjustment for inland freight was made to bring the FOB price to an ex-factory price.

On this basis, the Commission found that there was *prima facie* proof of the likelihood of recurrence of dumping if the anti-dumping duties are removed.

### **THE ALLEGATION OF CONTINUATION AND/OR RECURRENCE OF MATERIAL INJURY**

The applicant alleged and submitted *prima facie* evidence to indicate that should the anti-dumping duties be removed, alleged dumped import volumes would increase to the same level as before the imposition of the anti-dumping duties and as a result there is a likelihood that the applicant will experience price undercutting, price depression and price suppression. The applicant's information indicated that there is a likelihood that it would also experience a decline in sales volume and value, inventory, profit margins, production volume, market share, return on net assets, employment, utilisation of capacity, growth, employment and negative cash flow, should the anti-dumping duties be removed.

On this basis the Commission found that there is *prima facie* proof indicating a likelihood of recurrence or continuation of material injury if the anti-dumping duties are removed.

### **PERIOD OF INVESTIGATION**

The investigation period for dumping is from 01 June 2012 to 31 May 2013, and the injury investigation involves evaluation of data for the period of 01 January 2010 to 31 December 2012 and estimates should anti-dumping duties be removed, plus an additional five months information for 2010 to 2013 (1 January to 31 May).

## PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of a sunset review investigation, the Commission has begun an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, and the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR) giving due regard to the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement). Both the ITA Act and the ADR are available on the Commission's website ([www.itac.org.za](http://www.itac.org.za)) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the application and questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting country has also been notified. Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.

## CONFIDENTIAL INFORMATION

Please note that if any information is considered to be confidential, a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version, the following rules are strictly applicable and parties must indicate:

- where confidential information has been omitted and the nature of such information;
- reasons for such confidentiality;

- a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and
- in exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.

This rule applies to all parties and to all correspondence with and submissions to the Commission, which unless indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties.

If a party considers that any document of another party, on which that party is submitting representations, does not comply with the above rules and that such deficiency affects that party's ability to make meaningful representations, the details of the deficiency and the reasons why that party's rights are so affected must be submitted to the Commission in writing forthwith (and at the latest 14 days prior to the date on which that party's submission is due). Failure to do so timeously will seriously hamper the proper administration of the investigation, and such party will not be able to subsequently claim an inability to make meaningful representations on the basis of the failure of such other party to meet the requirements.

Subsection 33(1) of the ITA Act provides that any person claiming confidentiality of information should identify whether such information is *confidential by nature* or is *otherwise confidential* and, any such claims must be supported by a written statement, in each case, setting out how the information satisfies the requirements of the claim to confidentiality. In the alternative, a sworn statement should be made setting out reasons why it is impossible to comply with these requirements.

Section 2.3 of the ADR provides as follows:

*"The following list indicates "information that is by nature confidential" as per section 33(1)(a) of the Main Act, read with section 36 of the Promotion of Access to Information*

*Act (Act 2 of 2000):*

## PROCEDURES AND TIME LIMITS

The Senior Manager: Trade Remedies II, should receive all responses, including non-confidential copies of the responses, not later than 30 days from the date hereof, or from the date on which the letter accompanying the abovementioned questionnaire was received. The said letter shall be deemed to have been received seven days after the day of its dispatch.

Late submissions will not be accepted except with the prior written consent of the Commission. The Commission will give due consideration to written requests for an extension of not more than 14 days on good cause shown (properly motivated and substantiated), if received prior to the expiry of the original 30-day period. Merely citing insufficient time is not an acceptable reason for extension. Please note that the Commission will not consider requests for extension by an Embassy on behalf of exporters.

The information submitted by any party may need to be verified by the Investigating Officers in order for the Commission to take such information into consideration. It should be noted that unavailability of, or inconvenience to consultants, will not be considered to be good cause.

Parties should also ensure when they engage consultants, that they will be available at the requisite times, to ensure compliance with the above time frames.

Parties should also ensure that all the information requested in the applicable questionnaire is provided in the specified detail and format. The questionnaires are designed to ensure that the Commission is provided with all the information required to make a determination. The Commission may therefore refuse to verify information that is incomplete or does not comply with the format in the questionnaire, unless the Commission has agreed in writing to a deviation from the required format. Failure to submit an adequate non-confidential version of the response that complies with the rules set out above, under the heading *Confidential Information* will be regarded as an incomplete submission.

**NOTICE 45 OF 2014****INTERNATIONAL TRADE ADMINISTRATION COMMISSION****TERMINATION OF THE INTERIM REVIEW INVESTIGATION OF THE ANTI-DUMPING DUTIES ON ROPES AND CABLES ORIGINATING IN OR IMPORTED FROM GERMANY AND MANUFACTURED BY CASAR: FINAL DETERMINATION**

The International Trade Administration Commission of South Africa (the Commission) initiated an interim review investigation on ropes and cables originating in or imported from Germany and manufactured by Casar Drahtseilwerk Saar GMBH (Casar) through Notice No. 386 of 2013 in *Government Gazette* No. 36371 on 19 April 2013.

The application was lodged by Casar Drahtseilwerk Saar GMBH (Casar), a producer and exporter of the subject product in Germany. Casar alleged that there had been a significant change in circumstances to warrant the review of the anti-dumping duties imposed on its exports of ropes and cables.

The review investigation was initiated after the Commission considered that there was *prima facie* evidence to show a significant change in circumstances to warrant the initiation of a review.

On initiation of the review investigation, the non-confidential version of the application was forwarded to interested parties and response on the application was received on 13 June 2013 from the SACU manufacturer of the subject product.

After considering all parties comments, the Commission was of the opinion that there was no convincing argument that Casar's pricing policy cannot be changed again and that the low volumes exported by it during the period of investigation, made it difficult to determine whether or not Casar would resume dumping in future, once the anti-dumping duties are withdrawn.

This was conveyed to interested parties through an essential facts letter which was sent to out on 14 October 2013.

Taking the comments on the essential facts letter into account, the Commission made a final determination opinion that there was no convincing argument that Casar's pricing policy cannot be changed again and therefore that dumping will not recur in the future and that although Casar did not dump the subject product during the period of investigation, the low volumes exported by it made it difficult to determine whether or not Casar would resume dumping in future, once the anti-dumping duties are withdrawn.

The Commission therefore made a final determination to recommend to the Minister of Trade and Industry that the investigation be terminated.

The Commission's detailed reasons for its final determination are set out in Commission Report No. 455 (final report).



1. The following conditions apply:

- (1) Despite the provisions of paragraph 8(7)(b) of the Notice, a manager who has included in a money market and short-term debt portfolio an instrument issued by a special purpose institution as determined in the Notice on Securitisation Schemes under the Banks Act 1990, (Act No 94 of 1990), is not obliged to disinvest from and may continue to hold such instrument on condition that:
  - (a) the securitised assets are permissible for investment in accordance with the Notice;
  - (b) no synthetic securitisation schemes are included; and
  - (c) the manager may not make any new investment in such instruments.
- (2) A manager who is not currently invested in an instrument as described above may not invest in such an instrument for the duration of this exemption.

2. This exemption is effective from the date of publication and remains operative until a date on which the exemption is withdrawn, or a date on which the registrar determines

conditions regarding the inclusion of such instruments in a money market and short-term debt portfolio, whichever is the earlier.
