AMENDMENT OF DIRECTIONS ISSUED IN TERMS OF REGULATION 4(3) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002) REGARDING THE RE-OPENING OF SCHOOLS AND MEASURES TO ADDRESS, PREVENT AND COMBAT THE SPREAD OF COVID-19 IN THE NATIONAL DEPARTMENT OF BASIC EDUCATION, ALL PROVINCIAL EDUCATION DEPARTMENTS, ALL EDUCATION DISTRICT OFFICES AND ALL SCHOOLS IN THE REPUBLIC OF SOUTH AFRICA

I, Angelina Matsie Motshekga, Minister of Basic Education, in terms of regulation 4(3) of the Regulations made under section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), as published under Government Notice No. R.480, in Government *Gazette* No. 43258 of 29 April 2020, as amended by the Regulations published under Government Notice No. R.608, in Government *Gazette* No. 43364 of 28 May 2020, hereby issue the directions in the Schedule.

SCHEDULE

Definitions

1. In this Schedule, the "Directions" means the Directions regarding the re-opening of schools and measures to address, prevent and combat the spread of COVID-19 in the National Department of Basic Education, and Provincial Departments of Education, and all schools in the Republic of South Africa, as published under Government Notice No. 343, in Government *Gazette* No. 43465 of 23 June 2020.

Amendment of direction 1 of Directions

2. Direction 1 of the Directions is hereby amended by the deletion of the definition of "Pre-Grade R".

Amendment of direction 5 of Directions

- 3. Direction 5 of the Directions is hereby amended by the substitution for subdirection(1) of the following subdirection:
 - "(1) The phased return of learners and officials to school will be as follows:

Grade 6; Grade 10; Grade 11; Schools of Skill: Years 2 and 3; Schools for Learners with Severe Intellectual Disabilities ("SID"): Grades R, 1, 2, 3 and final year (Occupational); • Schools with Learners with Severe Profound Intellectual and Disabilities ("LSPID"): Years 1-3; and Schools with autistic learners: Junior Group (below 13 years) and final year (18 years and above). 3 August 2020 Grade 4; Grade 5; Grade 8; Grade 9; Year 1 in Schools of Skill; Schools for Learners with Severe Intellectual Disabilities ("SID"): Grades 4 and 5; and • Schools with autistic learners: Senior Group (13 years and above).

4. This amendment Notice comes into operation on the date of publication thereof in the Government *Gazette*.
