EXCHANGE CONTROL.—AMENDMENT OF REGULATIONS MADE UNDER THE CURRENCY AND EXCHANGES ACT, 1933 (ACT 9 OF 1933)

The State President has, under the powers vested in him by section 9 of the Currency and Exchanges Act, 1933 (Act 9 of 1933), made the regulations set out in the Schedule.

SCHEDULE

Amendment of regulation 22A of the regulations published by Government Notice R. 1111 of 1 December 1961 as inserted by regulation 7 of the regulations published by Government Notice R. 957 of 4 May 1987

1. Regulation 22A of the regulations published by Government Notice R. 1111 of 1 December 1961 is hereby amended by the substitution for the words "12 months" in subregulation (3) (a) of the words "the period referred to in paragraph (g) of section 9 (2) of the Act."

Commencement of regulation 1

2. Regulation 1 shall be deemed to have come into operation on 1 December 1961.
