WET OP BALJU'S, 1986

WYSIGING VAN DIE REGULASIES BETREFFENDE  
BALJU'S, 1990

Die Minister van Justisie het kragtens artikel 62 van die Wet op Balju's, 1986 (Wet No. 90 van 1986), na oorlegpleging met die Raad vir Balju's, die regulasies in die Bylae uitgevaardig.

#### BYLAE

#### Woordomskrywing

1. In hierdie Bylae beteken "die Regulasies" die regulasies afgekondig by Goewermenskennisgewing No. R. 411 van 12 Maart 1990, soos gewysig by Goewermenskennisgewings Nos. R. 2207 van 14 September 1990, R. 3440 van 31 Desember 1992 en R. 1836 van 1 Oktober 1993.

#### Wysiging van regulasie 3 van die Regulasies

2. Regulasie 3 van die Regulasies word hierby gewysig deur subregulasie (2) deur die volgende subregulasie te vervang:

"(2) 'n Aansoek om 'n getrouheidsfondssertifikaat gaan vergesel van 'n bydrae van R50,00 sowel as 'n verdere bydrae van R100,00 ten opsigte van elke adjunkbalju in die aansoeker se diens op 30 September van die jaar wat die kalenderjaar ten opsigte waarvan die getrouheidsfondssertifikaat uitgereik staan te word, voorafgaan."

SHERIFFS ACT, 1986

AMENDMENT OF THE REGULATIONS RELATING  
TO SHERIFFS, 1990

The Minister of Justice has, under section 62 of the Sheriffs Act, 1986 (Act No. 90 of 1986), after consultation with the Board of Sheriffs, made the regulations in the Schedule.

#### SCHEDULE

#### Definition

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 411 of 12 March 1990, as amended by Government Notices Nos. R. 2207 of 14 September 1990, R. 3440 of 31 December 1992 and R. 1836 of 1 October 1993.

#### Amendment of regulation 3 of the Regulations

2. Regulation 3 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:

"(2) An application for a fidelity fund certificate shall be accompanied by a contribution of R50,00, as well as a further contribution of R100,00 in respect of each deputy sheriff that is in the applicant's employ on 30 September of the year preceeding the calendar year with regard to which the fidelity fund certificate is to be issued."
