NEW RADIO SPECTRUM RE-PLANNING PROJECT

1. Introduction

The Department of Posts and Telecommunications is commencing a review of radio spectrum usage between the frequencies **20 MHz and 3 GHz**. This will lead to a nationally agreed frequency band plan for the future. The project is known as **Project SABRE (South African Band Re-planning Exercise)**.

The radio frequency spectrum is a national asset and a scarce resource. The exercise aims to ensure that the limited spectrum available is utilised and managed in an efficient and effective manner, and in a way which is in the interests of all South Africans and is consistent with international developments.

The work is being undertaken by the Department of Posts and Telecommunications together with an international team of consultants, led by UK-based Smith System Engineering and including the UK Radiocommunications Agency and the CSIR in South Africa.

2. Importance of the project

Project SABRE will result in a nationally agreed frequency band plan which will define how the radio spectrum is to be used in the future. The radio spectrum is utilised by a wide range of systems and services, which are either already being used or will in future be used by almost every person in South Africa.

Many different types of systems and services utilise the radio spectrum. The following is only a small selection of these:

- ▶ Telephone services to rural areas and disadvantaged communities;
- ▶ television and radio broadcasts (for example by SABC);
- ▶ mobile radio systems used by commercial organisations;
- ▶ emergency communications by the police, fire and ambulance services, etc.;
- ▶ cellular radios, cordless telephones and pagers;
- ▶ satellites (for telecommunications and broadcasting);
- ▶ alarm systems, remote control devices, etc.

The radio spectrum is not currently being utilised as efficiently and effectively as it could be. This has a number of implications:

- ▶ There is congestion and interference in some frequency bands;
- ▶ opportunities for the introduction of new technologies and services are restricted;
- ▶ users are not able to obtain as many frequencies as they would like;
- ▶ there are costs to business in terms of operational efficiency and equipment costs.

Project SABRE aims to produce a frequency band plan for the future that will make effective use of the scarce resource that is the radio frequency spectrum. This will be done in a way that will benefit all South Africans and will aid the social and economic development of the country.

There are thus a wide range of benefits that may result from Project SABRE and the frequency band plan that is produced. The following are some examples:

- ▶ Enabling the provision of telephone services to communities that do not at present have any telecommunications;
- ▶ making more efficient use of the spectrum so that more users are able to benefit from it;
- ▶ providing opportunities for the use of advanced broadcasting technologies which will enable higher quality and wider ranging broadcasts;
- ▶ improving the quality of service for existing users;
- ▶ enabling businesses to operate more effectively;
- ▶ generation of additional revenue for the country.

- “• After the completion of a report on the matters contained in the foregoing paragraphs, to investigate deficiencies in the regulation and enforcement relating to the monitoring and control of mercury processing, and to recommend steps which could contribute to the minimisation of risk and to the protection of workers and the environment.”

PROCEDURE OF COMMISSION

Under section 12 (6) of the Human Rights Commission Act, 1994 (Act No. 54 of 1994), I, Nyameko Barney Pityana, Chairperson of the Human Rights Commission, hereby make known in the Schedule the particulars of the procedure which the Human Rights Commission has determined in terms of section 12 (5) of the said Act.

N. B. PITANA**Chairperson of the Human Rights Commission****SCHEDULE****Preamble**

Whereas section 116 of the Constitution provides that the Commission shall be competent and obliged to—

- (a) promote observance of, respect for and the protection of fundamental rights;
- (b) develop an awareness of fundamental rights among all people of the Republic;
- (c) make recommendations to organs of state at all levels of government where it considers such action advisable for the adoption of progressive measures for the promotion of fundamental rights within the framework of the law and the Constitution, and of appropriate measures for the further observance of such rights;
- (d) undertake such studies for reporting on or relating to fundamental rights as it considers advisable in the performance of its functions; and
- (e) request any organ of state to supply it with information on any legislative or executive measures adopted by it relating to fundamental rights,

And whereas section 5 of the Human Rights Commission Act, 1994, provides that—

- (a) the Commission may establish one or more committees consisting of one or more members of the Commission designated by the Commission and one or more other persons, if any, whom the Commission may appoint for that purpose and for the period determined by it;
- (b) the Commission may extend the period of any appointment made by it or withdraw any such appointment;
- (c) the Commission shall designate a chairperson for every committee and, if it deems it necessary, a vice-chairperson;
- (d) a committee shall, subject to the directions of the Commission, exercise such powers and perform such duties and functions of the Commission as the Commission may confer on or assign to it and follow such procedure during such exercising of powers and performance of duties and functions as the Commission may direct;
- (e) on completion of the duties and functions assigned to it in terms of subsection (4), a committee shall submit a report thereon to the Commission; and
- (f) the Commission may at any time dissolve any committee,

And whereas, in addition to the above-mentioned functions of the Commission, section 7 of the Human Rights Commission Act, 1994, provides that the Commission—

- (a) shall develop and conduct information programmes to foster public understanding of this Act, Chapter 3 of the Constitution and the role and activities of the Commission;
- (b) shall maintain liaison with institutions, bodies or authorities similar to the Commission in order to foster common policies and practices and to promote co-operation in relation to the handling of complaints in cases of overlapping jurisdiction;
- (c) shall carry out or cause to be carried out such studies concerning fundamental rights as may be referred to it by the President, and the Commission shall include in a report referred to in section 118 of the Constitution a report setting out the results of each study, together with such recommendations in relation thereto as it considers appropriate;
- (d) may bring proceedings in a competent court or tribunal in its own name, or on behalf of a person or a group or class of persons,

Now, therefore, in order to fulfil its obligations and functions, the Commission has determined the following procedure:

Procedure**Definitions**

1. In this Procedure any expression to which a meaning has been assigned in the Human Rights Commission Act, 1994, shall have that meaning and, unless the context otherwise indicates—

"the Act" means the Human Rights Commission Act, 1994 (Act No. 54 of 1994);

"the Chairperson" means the chairperson of the Commission referred to in section 115 (1) and (5) of the Constitution;

"the Commission" means the Human Rights Commission established by section 115 (1) and (5) of the Constitution;

"the Constitution" means the Constitution of the Republic of South Africa, 1993 (Act No. 200 of 1993); and

"the Secretary" means the Secretary of the Commission.

- (3) The Commission may appoint standing committees to deal with any functions and operations of the Commission.

(4) The Commission may appoint *ad hoc* committees to plan the operation and review the progress of the Commission and to make interim reports in this regard.

(5) The chief executive officer shall be responsible for implementing the policies of the Commission and for administering the finances and staff of the Commission.

- (6) The following departments, headed by programme directors, shall assist the chief executive officer:

(a) Finance and Administration Department, which shall be responsible for proper accounting, resources and the development of human resource management practices.

(b) Legal Department, which shall be responsible for the work contemplated in sections 8 to 10, read with section 7 (d) and (e), of the Act.

(c) Education, Training and Information Department, which shall be responsible for carrying out the tasks contemplated in section 7 (1) (a) of the Act, including information programmes, education in human rights, popular information programmes and the consideration of the use of media such as radio, television and newspapers.

(d) Research and Documentation Department, which shall be responsible for coordinating research for the Commission, either by commissioning research or by undertaking it with the staff resources, and for the management of a documentation and resource centre, and a library.

(e) Advocacy Department, which shall be responsible for coordinating campaigns on human rights either on its own or in association with NGOs, including campaigns on racism, children's rights, land rights and gender equality.

Meetings of the Commission

3. (1) The Commission shall meet as often as may be necessary to carry out its activities, provided it meets at least once per month.

(2) Special meetings of the Commission may be convened at the request of the Chairperson or at the request of a majority of its members.

(3) The meetings of the Commission shall be held at its headquarters: Provided that the Commission may decide by majority vote to meet elsewhere.

(4) Any member who is unable to attend a meeting of the Commission or to fulfil any other function because of illness or for any other serious reason, shall notify the Secretary as soon as possible, who shall inform the Chairperson accordingly.

(5) An attendance register shall be kept by the Secretary at each meeting of the Commission.

(6) The duration of the meetings shall be determined by the Commission and may be altered on good cause.

(7) The meetings of the Commission shall be open to members of the public unless the Commission decides otherwise.

(8) The date and time for the next meeting of the Commission shall be set at each meeting and confirmed in writing by the Chairperson to all commissioners, and the public shall be notified of all plenary meetings by notice in the *Gazette* and in such other ways as may be decided by the Commission.

(9) The Chairperson or, in his or her absence, the Vice-Chairperson or, in the absence of both, a member elected by the members present shall preside at meetings of the Commission.

(10) The presence of an absolute majority of the members of the Commission shall be necessary to constitute a quorum.

(11) The voting procedure at meetings of the Commission shall be determined by the Chairperson.

(12) Decisions shall be taken by majority vote of the members present and in the event of an equality of votes the presiding member shall have a casting vote.

(13) Minutes shall be taken at each meeting of the Commission by the Secretary, stating the date and time of the meeting, the names of the members present, the matters dealt with, the decisions made and any statement made by a member especially for inclusion in the minutes.

(14) The Secretary shall distribute copies of the minutes to the members of the Commission as soon as possible after each meeting.

(15) The Chairperson shall set the agenda for any particular meeting and further items may be added at the request of any commissioner.

Working groups

4. The Commission may by majority vote determine the formation and composition of other working groups to consider specific subjects prior to their consideration by the Commission.

Witnesses

5. (1) The Chairperson or an officer generally or specially authorised thereto by the Chairperson shall administer an oath to or accept an affirmation from any witness appearing before the Commission.

(2) Where, at the time of any person giving evidence before the Commission, members of the general public are or have been excluded in terms of paragraph 3 (7) from attendance at the proceedings of the Commission, the Chairperson may, on the request of such a person, direct that no person shall disclose in any manner whatsoever the name or address of such person or any information likely to reveal his or her identity.

(3) Any witness appearing before the Commission may be cross-examined by a person only if the Chairperson permits such cross-examination by such person because the Chairperson deems it necessary or in the interest of the functions of the Commission.

(4) Whenever the Commission is satisfied upon evidence or information presented to it that the Commission's inquiry may adversely affect any existing, instituted or pending legal proceedings or any investigation instituted in terms of any law, evidence which is relevant to such legal proceedings or investigation shall be dealt with by the Commission in such a manner as not to affect adversely such legal proceedings or investigation.

Unforeseen contingency

6. The Chairperson may determine the procedure to be followed in order to deal with any unforeseen contingency.

Public access

7. (1) Any member of the public or any group of people may approach the Commission in writing to investigate any matter pertaining to fundamental rights which falls within the powers of the Commission set out in the Preamble hereto.

BOARD NOTICE 10 OF 1996**SOUTH AFRICAN COUNCIL FOR NATURAL SCIENTIFIC PROFESSIONS****RULES IN TERMS OF THE NATURAL SCIENTIFIC PROFESSIONS ACT, 1993 (ACT No. 106 OF 1993)**

The South African Council for Natural Scientific Professions has, in terms of section 17 of the Natural Scientific Professions Act, 1993 (Act 106 of 1993), and with the concurrence of the Minister of Arts, Culture, Science and Technology and the Competition Board, made the rules contained in the Schedule.

SCHEDULE**DEFINITIONS**

1. In these rules, unless the context otherwise indicates, any word or expression to which a meaning has been assigned in the Natural Scientific Professions Act, 1993 (Act No. 106 of 1993), bears the same meaning, and—

- (i) **"natural science"** means the science of nature (as distinguished from social science), including mathematics;
- (ii) **"natural science technologist"** means a person adequately trained and qualified in applied natural science and performing an occupation in or concerned with the study of applied natural science.
- (iii) **"natural science technology"** means the study of applied natural science;
- (iv) **"natural scientist"** means a person adequately trained and qualified in natural science and performing an occupation in or concerned with natural science;
- (v) **"science"** means a branch of study which is concerned with a connected body of demonstrated truths or with observed facts systematically classified and more or less colligated under general laws, and which includes reliable methods for the discovery of new truths within its own domain;
- (vi) **"scientist"** means a person adequately trained and qualified in science and performing an occupation in or concerned with science; and
- (vii) **"technologist"** means a person adequately trained and qualified in technology and performing an occupation in or concerned with technology.

REQUIREMENTS FOR REGISTRATION**NATURAL SCIENTIST**

2. (1) For the purposes of the Act, a registrable natural scientist shall be described as follows:

A person who holds an appropriate four-year degree, as set forth in Annexures I and II hereto, obtained at a South African university or similar institution, recognised by the Education Advisory Committee of the Council, who can satisfy the Council that he or she has completed an appropriate period of experiential training.

A person holding a three-year bachelor's degree obtained before 31 December 1991 shall also be registrable.

COURSE CONTENT

(2) The first four-year degree held by a candidate applying for registration shall be composed of courses at least 50% of which have been classified as natural science courses. In cases where the 50% requirement is not satisfied, an additional period of study shall be required to achieve the appropriate natural scientific content. In addition, such a degree shall include at least ONE subject that—

- (a) can be related to one of the professions listed in Schedule I to the Act;
- (b) follows the basic pattern of study as in Annexures I and II hereto;
- (c) was studied in increasing depth and breadth over four years; and
- (d) is based on the appropriate level I natural science subject (e.g. physics, chemistry, mathematics or biology).

ACTION

- (3) These requirements necessitate the following steps:

- (a) Each subject shall be evaluated to ensure that it can be related to one of the professions listed in Schedule I to the Act.
- (b) The four consecutive courses in such a subject shall be evaluated at each of the institutions where they are offered to determine whether they comply with the pattern of study as set forth in Annexures I and II hereto. These courses shall be characterised by increasing depth and breadth, as well as the development of analytical skills and problem-solving abilities in the students.
- (c) Each subject shall relate to one of the sciences defined in par. 1 of these rules.
- (d) A candidate applying for registration as a natural scientist-in-training shall nominate a registered natural scientist as his or her mentor, who shall ensure that the experience gained by the candidate is appropriate for registration purposes.
- (e) A Professional Advisory Committee (PAC) shall be responsible for defining the nature of the experience that will be regarded as appropriate and adequate for registration purposes. Such definition shall be approved by the Registration Committee.

NATURAL SCIENCE TECHNOLOGIST

3. (1) For the purposes of the Act, a registrable natural science technologist shall be described as follows:

- (a) A person who holds an appropriate four-year degree or a four-year diploma, as set forth in Annexures I and II hereto, obtained from a South African technikon or similar institution, recognised by the Education Advisory Committee of the Council, and who can satisfy the Council that he or she has completed an appropriate period of experiential training.
- (b) A person holding a three-year national diploma obtained before 31 December 1994 is also registrable.

SPECIAL CIRCUMSTANCES

(2) if a person does not hold an appropriate qualification recognised by the Council, but—

(a) has for a period no less than 20 years performed work of a natural scientific technological nature as a full-time occupation specially pertaining to any one or more of the professions referred to in Schedule I to the Act and which in the opinion of the Council is of sufficient variety and of a satisfactory nature and standard; and

(b) has passed an examination, if any, prescribed by the Council; or

(c) on 1 June 1982 was engaged in the performance of work of a natural scientific technological nature specially pertaining to any one or more of the professions referred to in Schedule I to the Act and which in the opinion of the Council is of sufficient variety and of a satisfactory nature and standard and had been so engaged during a period of no less than 10 years prior to that date,

the Council shall, subject to the provisions of section 11 (9) of the Act, register such person as a professional natural science technologist and issue to him or her a certificate of registration in the prescribed form.

COURSE CONTENT

(3) The degree or diploma held by a candidate applying for registration shall be composed of courses at least 50% of which have been classified as natural science courses. In cases where the 50% requirement is not satisfied, an additional period of study shall be required to achieve the appropriate natural scientific content. In addition, such qualification shall include at least ONE subject that—

(a) can be related to one of the professions listed in Schedule I to the Act;

(b) follows the basic pattern of study as in Annexures I and II hereto;

(c) was studied in increasing depth and breadth over four years;

(d) is based on the appropriate level I natural science subjects (e.g. physics, chemistry, mathematics or biology); and

(e) relates to one of the sciences defined in par. 1 of these rules.

ACTION

(4) These requirements necessitate the following steps:

(a) Each subject shall be evaluated to ensure that it can be related to one of the professions listed in Schedule I to the Act.

(b) The four consecutive courses in such a subject shall be evaluated at each of the institutions where they are offered to determine whether they comply with the pattern of study as set forth in Annexure I and II hereto. These courses shall be characterised by increasing depth and breadth, as well as the development of analytical skills and problem-solving abilities in the students.

(c) Each subject shall relate to one of the sciences defined in par. 1 of these rules.

(d) The four years of study may include a maximum of one year of experiential training but shall be clearly structured and controlled. A three-year diploma obtained before 31 December 1994 may include one-and-a-half years of experiential training.

(e) A candidate applying for registration as a natural science technologist-in-training shall nominate a registered natural science technologist as his or her mentor, who shall ensure that the experience gained by the candidate is appropriate for registration purposes.

(f) A Professional Advisory Committee (PAC) shall be responsible for defining the nature of the experience that will be regarded as appropriate and adequate for registration purposes. Such definition shall be approved by the Registration Committee.

(WET No. 106 VAN 1993)**

Die Suid-Afrikaanse Raad vir Natuurwetenskaplike Professions het kragtens artikel 17 van die Wet op Natuurwetenskaplike Professions, 1993 (Wet No. 106 van 1993), en met die instemming van die Minister van Kuns, Kultuur, Wetenskap en Tegnologie en die Raad op Mededinging, die reëls vervat in die Bylae uitgevaardig.

BYLAE**WOORDOMSKRYWING**

1. In hierdie reëls het 'n woord of uitdrukking waaraan in die Wet op Natuurwetenskaplike Professions, 1993 (Wet 106 van 1993), 'n betekenis geheg is, dieselfde betekenis, en tensy uit die samehang anders blyk, beteken—

- (i) **“natuurwetenskap”** die wetenskap van die natuur (soos onderskei van die sosiale wetenskap), insluitend wiskunde;
- (ii) **“natuurwetenskaplike”** 'n persoon wat toereikend opgelei en gekwalifiseer is in die natuurwetenskappe en 'n beroep beoefen in of betrokke is by die studie van die natuurwetenskappe;
- (iii) **“natuurwetenskaplike tegnologie”** die studie van die toegepaste natuurwetenskap;
- (iv) **“natuurwetenskaplike tegnoloog”** 'n persoon wat toereikend opgelei en gekwalifiseer is in die toegepaste natuurwetenskap en 'n beroep beoefen in of betrokke is by die studie van die toegepaste natuurwetenskappe.

(v) "tegnoloog" 'n persoon wat toereikend opgelei en gekwalifiseer is in die tegnologie en 'n beroep beoefen in of betrokke is by die tegnologie;

(vi) "wetenskap" 'n vertakking van studie wat te doen het met 'n verbonde liggaam van bewese waarhede of met waargenome feite wat sistematies geklassifiseer is en min of meer saamgevoeg is onder algemene wette en wat betroubare metodes insluit vir die ontdekking van nuwe waarhede in sy eie veld; en

(vii) "wetenskaplike" 'n persoon wat toereikend opgelei en gekwalifiseer is in die wetenskap en 'n beroep beoefen in of betrokke is by die wetenskap.

VEREISTES VIR REGISTRASIE

NATUURWETENSKAPLIKE

2. (1) Vir doeleindes van die Wet word 'n registreerbare natuurwetenskaplike soos volg beskryf:

'n Persoon wat oor 'n toepaslike vierjarige graad beskik, soos uiteengesit in Aanhangsels I en II hiervan, verwerf aan 'n Suid-Afrikaanse universiteit of soortgelyke inrigting soos erken deur die Adviserende Onderwyskomitee van die Raad, en wat die Raad kan oortuig dat hy of sy 'n toepaslike periode van ervaringsopleiding ondergaan het.

'n Persoon wat beskik oor 'n driejarige baccalaureusgraad wat voor 31 Desember 1991 verwerf is, is ook registreerbaar.

KURSUSINHOUD

- (2) Die eerste vierjarige graad waarvoor 'n kandidaat beskik wat aansoek doen vir registrasie, moet saamgestel wees uit kursusse waarvan ten minste 50% as natuurwetenskaplike kursusse geklassifiseer is. In gevalle waar daar nie aan die 50%-vereiste voldoen word nie, sal 'n addisionele periode van studie nodig wees om die toepaslike natuurwetenskaplike inhoud te verkry. Voorts moet sodanige graad ten minste EEN vak insluit wat—

- (a) in verband gebring kan word met een van die professies gelys in Bylae I van die Wet;
- (b) die basiese studiepatroon volg soos in Aanhangel I en II hiervan;
- (c) in toenemende diepte en breedte oor vier jaar bestudeer is; en

STAPPE

- (3) Hierdie vereistes noodsaak die volgende stappe:

Hierdie kursusse moet gekenmerk word deur toenemende diepte en breedte, sowel as die ontwikkeling van analitiese vaardighede en die vermoë van studente om probleme op te los.

NATUURWETENSKAPLIKE TEGNOLOOG

3. (1) Vir doeleindes van die Wet word 'n registreerbare natuurwetenskaplike tegnoloog as volg beskryf:

(a) 'n Persoon wat oor 'n toepaslike vierjarige graad of 'n vierjarige diploma beskik, soos uiteengesit in Aanhangsels I en II hiervan, verwerf aan 'n Suid-Afrikaanse teknikon of soortgelyke inrigting soos erken deur die Adviserende Onderwyskomitee van die Raad, en wat die Raad kan oortuig dat hy of sy 'n toepaslike periode van ervaringsopleiding ondergaan het.

(b) 'n Persoon wat beskik oor 'n driejarige nasionale diploma wat voor 31 Desember 1994 verwerf is, is ook registreerbaar.

SPESIALE OMSTANDIGHEDE

- (2) Indien 'n persoon nie oor 'n toepaslike kwalifikasie beskik wat deur die Raad erken word nie, maar—

(a) vir 'n tydperk van minstens 20 jaar as 'n voltydse beroep werk van 'n natuurwetenskaplike tegnologiese aard gedoen het wat spesifiek betrekking het op een of meer van die professies van Bylae I van die Wet en wat na die oordeel van die Raad van voldoende verskeidenheid en bevredigende aard en standaard is; en

(b) in 'n eksamen wat die Raad voorgeskryf het, indien wel, geslaag het; of

(c) op 1 Junie 1982 besig was met die verrigting van werk van 'n natuurwetenskaplik tegnologiese aard wat spesifiek betrekking het op een of meer van die professies van Bylae I van die Wet en wat na die oordeel van die Raad van voldoende verskeidenheid en bevredigende aard en standaard is en vir 'n tydperk van minstens 10 jaar voor daardie datum aldus besig was,

moet die Raad, behoudens die bepalings van artikel 11 (9) van die Wet, sodanige persoon as 'n professionele natuurwetenskaplike tegnoloog registreer en aan hom of haar 'n registrasiesertifikaat in die voorgeskrewe vorm uitreik.

KURSUSINHOUD
