REGULATIONS IN TERMS OF THE SOUTH AFRICAN CITIZENSHIP ACT, 1995

The Minister of Home Affairs has, under section 23 of the South African Citizenship Act, 1995 (Act No. 88 of 1995), made the regulations in the Schedule.

SCHEDULE

Definition

1. In these regulations "the Regulations" means the Regulations in terms of the South African Citizenship Act, 1995, published under Government Notice No. R. 1794 of 17 November 1995.

Substitution of regulation 10 of the Regulations

2. The following regulation is hereby substituted for regulation 10 of the Regulations:

"Fees

10. The following fees are payable in the respective cases:

- (a) Certificate of naturalisation as South African citizen (section 5):
 - (i) Original: Free.
 - (ii) Duplicate: R25,00.

- (b) Certificate of South African citizenship (section 16): R25,00.
- (c) Application for the retention of South African citizenship [section 6 (2)]: R65,00.
- (d) Application for the resumption of South African citizenship (section 13): R65,00.
- (e) Application for consent to make use of another country's passport facilities [section 9, read with section 23 (e) and (f)]: R85,00."

Short title and commencement

3. The regulations shall be called the **First Amendment of the Regulations in terms of the South African Citizenship Act, 1995**, and shall come into operation on **1 April 1996**.

BYLAE**Woordomskrywing**

1. In hierdie regulasies beteken "die Regulasies" die Regulasies kragtens die Wet op Suid-Afrikaanse Burgerskap, 1995, afgekondig by Goewermentskennisgewing No. R. 1794 van 17 November 1995.

Vervanging van regulasie 10 van die Regulasies

2. Regulasie 10 van die Regulasies word hierby deur die volgende regulasie vervang:

"Foole

10. die volgende foole is in die onderskeie gevalle betaalbaar:

- (a) Sertifikaat van naturalisasie as Suid-Afrikaanse burger (artikel 5):
 - (i) Oorspronklike: Gratis.
 - (ii) Afskrif: R25,00.
- (b) Sertifikaat van Suid-Afrikaanse burgerskap (artikel 16): R25,00.
- (c) Aansoek om die behoud van Suid-Afrikaanse burgerskap [(artikel 6 (2))]: R65,00.
- (d) Aansoek vir die herneming van Suid-Afrikaanse burgerskap (artikel 13): R65,00.
- (e) Aansoek om toestemming om van 'n ander land se paspoortgeriewe gebruik te maak [artikel 9, saamgelees met artikel 23 (e) en (f)]: R85,00."

Kort titel en inwerkingtreding

3. Hierdie regulasies heet die **Eerste Wysiging van die Regulasies kragtens die Wet op Suid-Afrikaanse Burgerskap, 1995**, en tree op **1 April 1996** in werking.

No. R. 462**15 March 1996****MARRIAGE ACT, 1961 (ACT No. 25 OF 1961)****FOURTH AMENDMENT OF THE REGULATIONS IN TERMS OF THE MARRIAGE ACT, 1961**

The Minister of Home Affairs has, in terms of section 38 of the Marriage Act, 1961 (Act No. 25 of 1961), made the regulations in the Schedule.

SCHEDULE**Definition**

1. In these regulations "the Regulations" means the Regulations in terms of the Marriage Act, 1961, published under Government Notice No. R. 2207 of 24 October 1986, as amended by Government Notices Nos. R. 883 of 21 May 1993, R. 1577 of 27 August 1993 and R. 726 of 19 May 1995.

Amendment of regulation 5B of the Regulations

2. Regulation 5B is hereby amended by the substitution for subparagraphs (i) and (ii) of subregulation (2) of the following subparagraphs:

- "(i) an amount of R6,00 in respect of a handwritten abridged and computerized marriage certificate: Provided that no fees shall be payable for the issuing of the certificate at the time of the registration of the marriage; or
- (ii) an amount of R30,00 in respect of an unabridged marriage certificate, or a reproduction of the relevant register or a reproduction of any supporting documentation which is coupled to the register concerned."

Short title and commencement

3. These regulations shall be called the **Fourt Amendment of the Regulations in terms of the Marriage Act, 1961**, and shall come into operation on **1 April 1996**.

HUWELIKSWET, 1961 (WET No. 25 VAN 1961)

VIERDE WYSIGING VAN DIE REGULASIES KRAGTENS DIE HUWELIKSWET, 1961

Die Minister van Binnelandse Sake het kragtens artikel 38 van die Huwelikswet, 1961 (Wet No. 25 van 1961), die regulasies in die Bylae uitgevaardig.

BYLAE***Woordomskeywing***

1. In hierdie regulasies beteken "die Regulasies" die Regulasies kragtens die Huwelikswet, 1961, afgekondig by Goewermentskennisgewing No. R. 2207 van 24 Oktober 1986, soos gewysig by Goewermentskennisgewings Nos. R. 883 van 21 Mei 1993, R. 1577 van 27 Augustus 1993 en R. 726 van 19 Mei 1995.

Wysiging van regulasie 5B van die Regulasies

2. Regulasie 5B word hierby gewysig deur subparagrafe (i) en (ii) van subregulasie (2) met die volgende subparagrafe te vervang:

- "(i) 'n bedrag van R6,00 ten opsigte van 'n handgeskrewe verkorte sowel as 'n rekenaargedrukte huweliksertifikaat: Met dien verstande dat geen fooie betaalbaar is nie ten opsigte van die sertifikaat wat by die registrasie van die huwelik uitgereik word nie; of
- (ii) 'n bedrag van R30,00 ten opsigte van 'n volledige huweliksertifikaat, of 'n reproduksie van die betrokke register of die reproduksie van enige ondersteunende dokument wat met die betrokke register verband hou."

Kort titel en Inwerkingtreding

3. Hierdie regulasies heet die **Vierde Wysiging van die Regulasies kragtens die Huwelikswet, 1961**, en tree in werking op **1 April 1996**.
