**2. Category of assets**

Securities owned by a bank, which securities—

- (a) have in accordance with the provisions of the Act been deposited by a participant with, and are held by, a central securities depository and are registered (except in the case of bearer securities) in the name of that central securities depository or of a wholly owned subsidiary thereof that has been approved by the Registrar of Financial Markets; or
- (b) have been deposited with a depository institution or a participant for safe custody and are registered in the name of a wholly owned subsidiary of such institution or participant that has been approved in writing by the Registrar of Banks.

**NOTICE 740 OF 1997****SOUTH AFRICAN LAW COMMISSION****DISCUSSION PAPER ON EUTHANASIA AND THE ARTIFICIAL PRESERVATION OF LIFE**

The South African Law Commission has released a discussion paper dealing with euthanasia and the artificial preservation of life for general information and comment.

The advances made in medical science and especially the application of medical technology have resulted in patients living longer. For many patients this signifies a welcome prolongation of meaningful life, but for others the result is a poor quality of life which inevitably raises the question whether treatment is a benefit or a burden.

According to the present position in our law it is unlawful to terminate a person's life in order to end his or her unbearable suffering even if it is clear that death is inevitable and that the person is about to die. The intentional termination of such a person's life remains punishable even if the suffering person expresses the wish to die or even begs to be killed. Withholding or withdrawing of life-sustaining medical treatment from a patient who is terminally ill may however be permissible under specific circumstances and subject to certain conditions.

Worldwide increased importance is being attached to patient autonomy. The need has therefore arisen to consider the question whether a mentally competent, but terminally ill patient's right to refuse life-sustaining medical treatment or to receive assistance in ending his or her life should be protected. The position of the incompetent patient as well as the patient who is clinically dead has to be clarified as well.

The Commission is consequently considering proposals for possible law reform with regard to the following matters:

- The circumstances in which it would be lawful for a medical practitioner to withhold all further life-sustaining treatment of a patient who has been certified as being braindead and who is being kept alive artificially.
- The right of a mentally competent person to refuse any life-sustaining medical treatment even though such refusal may cause or hasten his or her death.
- The right of a medical practitioner responsible for the treatment of a terminally ill patient to alleviate pain and distress by increasing the dosage of medication to be given to the patient even if the secondary effect of the medication may be to shorten the patient's life.
- Whether it would be lawful for a medical practitioner to actively assist a terminally ill, but mentally competent patient to die by administering or providing a lethal agent.
- Clarification of the legal position with regard to the wishes of the patient as expressed in a so-called advance directive (living will) or power of attorney and the continuing validity of a power of attorney after the principal has become mentally incompetent.
- Those instances in which the chief medical practitioner of a hospital or clinic may, in the absence of a directive of the patient or his agent decide to discontinue the treatment of the terminally ill patient.
- The powers of the court with regard to withholding or withdrawing of medical treatment or performance of any medical procedure which would have the effect of terminating a patient's life.

The Commission has stated the above-mentioned issues objectively and neutrally without making specific recommendations. The issues raised need to be debated thoroughly. The comments of all parties which feel that they have an interest in this topic or may be affected by the type of measures discussed in this paper are therefore of vital importance to the Commission.

Vir baie pasiënte beteken dit 'n verlenging van 'n sinvolle lewe, maar vir ander lei dit tot 'n swak kwaliteit van lewe wat onvermydelik tot die vraag aanleiding gee of die behandeling 'n voordeel of 'n las vir die pasiënt is.

Die huidige stand van ons reg is dat die doodmaak van 'n mens onregmatig is al is die beweegrede vir die handeling die verlossing van iemand uit ondraaglike lyding en al sou die lydende die wens uitspreek om te sterf of selfs smeek om gedood te word. Weerhouding of onttrekking van kunsmatige lewensverlengende mediese behandeling van 'n terminaal siek persoon kan egter toelaatbaar wees onder spesifieke omstandighede en onderworpe aan sekere voorwaardes.

Wêreldwyd word daar toenemende belang geheg aan die outonomie van die pasiënt om self oor sy of haar behandeling te besluit. Daar het dus 'n behoefte ontstaan om die beskerming van 'n pasiënt se reg om mediese behandeling te weier of om hulp in die beëindiging van sy of haar lewe te ontvang, te oorweeg. Die posisie van die handelingsonbevoegde pasiënt sowel as die pasiënt wat klinies dood is moet ook uitgeklaar word.

Die Kommissie oorweeg dus die volgende voorstelle vir moontlike regshervorming met betrekking tot die volgende aangeleenthede:

- Die omstandighede waaronder dit wettig sou wees vir 'n mediese praktisyn om alle lewensverlengende mediese behandeling te staak van 'n pasiënt wat breindood verklaar is en kunsmatig aan die lewe gehou word.
- Die reg van 'n handelingsbevoegde persoon om enige lewensverlengende mediese behandeling te weier selfs al sou sodanige weiering sy of haar dood verhaas of veroorsaak.
- Die reg van 'n mediese praktisyn verantwoordelik vir die behandeling van 'n terminaal siek pasiënt om pyn en lyding te verlig deur die verhoging van die dosis van die medisyne van die pasiënt selfs al sou die sekondêre effek van die medisyne wees om die pasiënt se lewe te verkort.
- Die vraag of dit regmatig sal wees vir 'n mediese praktisyn om 'n handelingsbevoegde pasiënt te help om te sterf deur die beskikbaarstelling of die toediening van 'n dodelike middel.
- Uitklaring van die regsposisie vir sover dit die wense van die pasiënt uiteengesit in 'n lewende testament of volmag raak en die voortdoring van 'n volmag nadat die opdraggewer handelingsonbevoeg geraak het.
- Die geval waar die hoof van 'n mediese inrigting by gebrek aan 'n opdrag van 'n pasiënt of gevolmagtigde en in afwesigheid van 'n hofbevel mag besluit dat voortgesette behandeling van 'n terminaal siek pasiënt gestaak mag word.




