

"[98] The following order is made:

1. The applications of the respondents for
 - (a) condonation of their failure to file answering affidavits in the High Court;
 - (b) leave to file their answering affidavits;
 - (c) the matter concerning the filing of answering affidavits to be remitted to the High Court; and
 - (d) an amendment of their notice of appeal
 are dismissed with costs, including the costs of two counsel, such costs to be paid by the respondents jointly and severally.
2. The appeal of the applicants succeeds and paragraphs 1, 2 and 3 of the order made by the High Court are set aside and replaced with the following:
 - 2.1 the omission from section 25(5) of the Aliens Control Act 96 of 1991, after the word "spouse", of the words "or partner, in a permanent same-sex life partnership," is declared to be inconsistent with the Constitution;
 - 2.2 section 25(5) of the Aliens Control Act 96 of 1991, is to be read as though the following words appear therein after the word "spouse": "or partner, in a permanent same-sex life partnership".
3. The orders in paragraph 2 only come into effect from the moment of the making of this order.

4. Paragraphs 4, 5 and the costs part of the High Court order are confirmed.
5. The costs of the proceedings in this Court, including the costs of two counsel, are to be paid by the respondents, jointly and severally."

MAGISTRATE'S ACT, 1993 (ACT NO. 90 OF 1993)

AMENDMENT OF REGULATIONS

The Minister of Justice has under section 16 of the Magistrate's Act, 1993 (Act No. 90 of 1993), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R. 361 of 11 March 1994, as amended by Government Notices Nos. R. 644 of 1 April 1994, R. 1407 of 11 August 1994, R. 1808 of 17 October 1994, R. 1707 of 27 October 1994, R. 1791 of 17 November 1995, R. 72 of 26 January 1996, R. 331 of 1 March 1996, R. 957 of 7 June 1996, R. 1178 of 19 July 1996, R. 1242 of 2 August 1996, R. 1340 of 12 August 1996, R. 1567 of 27 September 1996, R. 1627 of 1 October 1996, R. 178 of 7 February 1997, R. 421 of 20 March 1997, R. 1081 of 8 August 1997, R. 274 of 20 February 1998, R. 997 of 7 August 1998 and R. 56 of 15 January 1999.

Amendment of Schedule E to the Regulations

2. Schedule E to the Regulations is hereby amended by the substitution for paragraph 17 of the following paragraph:

"17. A magistrate shall wear official dress during court sessions (except at inspections *in loco*).

A magistrate who acts as presiding officer in a court shall wear a gown. The gown of a regional court magistrate shall be black with bell-shaped sleeves with seams, an eight-centimetre-wide full-length lapel, and shoulder piece of scarlet red. The gown of a magistrate shall be of black Princetta material with black embroidery of silken cord on the front and sleeves. A five-centimetre-wide dark scarlet red band shall be affixed to the centre of the collar piece, down the full length of the front panels and parallel on either side of the silken cord on the sleeves.

The length of the gown shall be in proportion to the height of the magistrate and the hemline of the gown shall not be more than 20 centimetres above the ground.

A magistrate shall wear suitable clothes with the gown."

Commencement

3. These regulations will commence on 4 January 2000.

Die toga van 'n streeklanddros is swart met klokvormige moue met some en 'n breë vollengte lapel van agt sentimeter lank en skouerstuk in skarlakenrooi. Die toga van 'n landdros is van swart Princetta-materiaal gemaak met swart borduurwerk van koordsy op die voorkant en moue. OCCUPATIONAL HEALTH**

Annual Medical Report

- 11.2 The annual medical report contemplated in section 16 (1) must include details regarding at least the following:
- (i) Name of mine.
 - (ii) Name, address and telephone number of the occupational medical practitioner responsible for compiling the annual medical report.
 - (b) Type of mine. Commodity or commodities being mined.
 - (c) Total number of employees (including contract workers) who were subject to medical surveillance in terms of section 13 during the reporting period and the total number of hours worked by those employees.

- (d) The number of initial, periodical and exit examinations conducted as part of the medical surveillance system.
- (e) An analysis of the employees' health based on the employees' records of medical surveillance, without disclosing the names of the employees.
- (f) Comments on the future direction of the medical surveillance system.
- (g) The number of employees certified for compensation for occupational diseases.

Exit certificate

11.3 The exit certificate contemplated in section 17 must include details regarding at least the following:

- (a) **Particulars of mine:**
 - (i) Name of mine.
 - (ii) Type of mine. Commodity or commodities being mined.
 - (iii) Postal address.
 - (iv) Telephone number.
 - (v) Fax number.
 - (vi) Name of occupational medical practitioner responsible for producing the exit certificates [Section 17 (4)].
- (b) **Particulars of employee:**
 - (i) Name.
 - (ii) Date of birth.
 - (iii) Any one of the following numbers: Identity number, the Department of Mineral and Energy (DME) number, industry number, company number, or Medical Bureau for Occupational Diseases (MBOD) number.
 - (iv) Date of initial medical examination.
 - (v) Labour history, specifying occupations, periods in each occupation and, if applicable, the number of shifts worked in each occupation.
- (c) **Exit medical summary:**
 - (i) Date of last medical examination.
 - (ii) Clinical comments on chest x-ray (CXR).
 - (iii) International Labour Organization (ILO) classifications of the chest x-ray (CXR), if applicable.
 - (iv) Lung function testing:
 - Forced Expiratory Volume in 1 second (FEV₁):
 - Actual and predicted percentages.
 - Forced Vital Capacity (FVC):
 - Actual and predicted percentages.
 - Ratio of Forced Expiratory Volume in 1 second (FEV₁)/Forced Vital Capacity (FVC)— expressed as a percentage.
 - (v) Audiometry (hearing loss average in decibels (dB) at 0.5, 1, 2, 3 kilohertz (kHz)).
 - (vi) Other biological monitoring by the employer of the employee, and if so, comments on the results.
 - (vii) The significant hazards/risks the employee was exposed to, such as dust, noise, radiation, chemical or other.
 - (viii) Occupational diseases, past or present, including severity.
 - (ix) Summary of whether any compensation has been received or if a claim for compensation has been submitted.
 - (x) Name and signature of occupational health practitioner completing the exit certificate if such certificate is not completed by the occupational medical practitioner responsible for producing the exit certificate.
 - (xi) Signature of employee and date of receipt by employee of a copy of the exit certificate.
