SCHEDULE

Immunities and privileges granted to the World Commission on Dams and its transferred officials in accordance with section 4 (c) (i) of the Diplomatic Immunities and Privileges Act, 1989 (Act No. 74 of 1989), for the period up to 31 December 2000 are—

1. The immunities and privileges to be accorded to the transferred officials of the World Commission on Dams who are not citizens of or permanently resident in the Republic of South Africa are—
 - (a) (i) exemption from the requirement to obtain residence and work permits for the transferred officials of the World Commission on Dams; and
 - (ii) exemption from the requirement to obtain residence permits for the spouses and dependants of the transferred officials of the World Commission on Dams;
 - (b) exemption from income tax imposed on or in connection with any emoluments or allowances paid to them or their official services at the World Commission on Dams;
 - (c) exemption from value-added tax paid or borne on supplies of goods and services made for official purposes;
2. Immunities accorded to the World Commission on Dams are—
 - (a) exemption from value-added tax paid or borne on supplies for goods and services made for official purposes.

BASIC CONDITIONS OF EMPLOYMENT ACT, NO. 75 OF 1997

EMPLOYMENT CONDITIONS COMMISSION INVESTIGATION: HOSPITALITY SECTOR, REPUBLIC OF SOUTH AFRICA

In terms of section 52 (1) of the Basic Conditions of Employment Act, No. 75 of 1997, I, Membathisi Mphumzi Shepherd Mdladlana, Minister of Labour, hereby direct the Employment Conditions Commissioner to investigate conditions of employment in the Hospitality Sector in the Republic of South Africa.

I give notice in terms of section 52 (3) of the Basic Conditions Act, 1997, of the commencement of said investigation and invite written representation by members of the public.

The terms of reference of the investigation shall be as follows:

- (a) To review the following wage determinations:
 - (i) Wage Determination 479: Accommodation Establishment Trade, Certain Areas;
 - (ii) Wage Determination 461: Catering Trade, Certain Areas;
 - (iii) Wage Determination 457: Hotel Trade, Certain Areas;
 - (iv) Wage Determination 477: The Trade of Letting of Flats or Rooms, Certain Areas, and to establish the feasibility of grouping them together in a single determination for the Hospitality Sector.
- (b) To make recommendations regarding wages and working conditions in the Republic of South Africa pertaining to this sector.

Interested persons are hereby given the opportunity of making written representations to the Employment Conditions Commission, such representations should reach the Directorate: Minimum Standards, Department of Labour, Private Bag X117, Pretoria, 0001, within 30 days of the publication of this notice.

REGULATIONS REGARDING THE REGISTRATION OF SOCIAL WORKERS: AMENDMENT

The Minister for Welfare and Population Development has, in terms of section 28 of the Social Work Act, 1978 (Act No. 110 of 1978), on the recommendation of the South African Interim Council for Social Work, made the regulations set out in the Schedule hereto.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the regulations published as Government Notice No. R. 2426 of 30 October 1987, as amended by Government Notices Nos. R. 951 of 3 May 1991 and R. 53 of 15 January 1993.

Amendment of regulation 2

2. Regulation 2 of the Regulations is hereby amended—
 - (a) by the substitution for subparagraph (i) of paragraph (a) of the following subparagraph:

"(i) at least four-year courses in the subject Social Work, one year of which may be completed on post-graduate level";
 - (b) by the deletion of the proviso after subparagraph (iii) of paragraph (a).

Commencement

3. These regulations shall come into effect on the date of publication of this notice.


