<b>AMENDMENT OF THE PATENTS REGULATIONS, 1978</b>

The Minister of Trade and Industry has with concurrence of the Minister of Finance in respect of matters prescribing the payment of Fees and Tariff of such Fees, under section 91 of the Patents Act, 1978 (Act No. 57 of 1978), further amended the Patent Regulations, 1978, initially published under Government Notice No. R.2470 of 15 December 1978 and as subsequently amended in Government Gazette No. 1985A of March 1999, Government Gazette No. 20248 of June 1999, Government Gazette No. 20790 of 30 December 1999 and Government Gazette No. 20837 of 4 February, 2000, and Government Gazette No.21960 of 29 December 2000, in the manner set out in the Schedule, with effect from 1 April 2001.
