#### NATIONAL ROAD TRAFFIC ACT, 1996 (ACT NO. 93 OF 1996)

#### AMENDMENT OF NATIONAL ROAD TRAFFIC REGULATIONS

The Minister of Transport makes the regulations in the Schedule under section 75 of the National Road Traffic Act, 1996 (Act No. 93 of 1996).

#### SCHEDULE

##### Definition

1. In this Schedule the regulations means the National Road Traffic Regulations published in Government Notice No. R. 225 of 17 March 2000, as amended by Government Notice Nos. R. 941 of 22 March 2000.

##### Amendment of regulation 142 of the Regulations

2. Regulation 142 of the Regulations is amended by the insertion of the following paragraph after paragraph (b):

"(bA) a motor vehicle to which regulations 273 to 283 apply as contemplated in regulation 274: Provided that this provision shall become effective to motor vehicles with a gross vehicle mass of 3 500 kilograms and under, as from 1 December 2001."

##### Amendment of regulation 265 of the Regulations

3. Regulation 265 of the Regulations is amended by the substitution for subregulation (1) of the following subregulation:

"(1) An operator shall be registered in respect of a -

- (a) goods vehicle, the gross vehicle mass of which exceeds 3 500 kilograms;
- (b) breakdown vehicle; and
- (c) motor vehicle to which regulations 273 to 283 apply as contemplated in regulation 274: Provided that this provision shall become effective to motor vehicles with a gross vehicle mass of 3 500 kilograms and under, as from 1 December 2001, registered in the Republic."

**Substitution of regulation 342 of Regulations**

4. The Regulation is amended by the substitution for regulation 342 of the following regulation:

**"Transitional provisions: Professional driving permits**

**342.** The holder of a valid category "G" or "P" professional driving permit who drives a motor vehicle carrying dangerous goods, the gross vehicle mass of which exceeds 3 500 kilograms, or a vehicle to which standard specification SABS 1398 "Road tank vehicles for petroleum-based flammable liquids" or standard specification SABS 1518: "Transportation of dangerous goods - design requirements for road tankers" applies, shall from the date of commencement of regulation 115(1)(f), subject to the said permit being cancelled or suspended-

- (a) be deemed to hold a category "D" professional driving permit for the period for which his or her professional driving permit is valid; and
- (b) notwithstanding the provisions of regulation 117, the holder of a valid category "G" or "P" professional driving permit shall not be disqualified from obtaining a category "D" professional driving permit by reason only of the fact that he or she is younger than 25 years of age."

**Insertion of regulation 343D in Regulations**

5. The Regulation is amended by the insertion of the following regulation after regulation 343C:

**"Transitional provisions: Category "D" operator card**

**343D. (1)** A valid category "G" operator card displayed on a motor vehicle to which regulations 273 to 283 applies as contemplated in regulation 274, shall from the date of commencement of regulations 273 to 283 be deemed to be a valid category "D" operator card for the period of its validity.

**(2)** Notwithstanding the date of commencement of regulations 273 to 283, a motor vehicle that did not have to display an operator card before the commencement of the said regulations, shall, after the said date of commencement, display a category "D" operator card within the month after the month during which the licence disc of the vehicle concerned lapsed."

**Short title and commencement**

6. These regulations shall be called the Third Amendment to the National Road Traffic Regulations, and shall come into operation on 3 August 2001.

**COMMENCEMENT OF NATIONAL ROAD TRAFFIC REGULATIONS**

Die Minister van Vervoer het kragtens artikel 75 van die Nasionale Padverkeerswet, 1996 (Wet No. 93 van 1996), die regulasies in die Bylae uitgevaardig

**BYLAE****Woordomskrywing**

1. In hierdie Bylae beteken "die Regulasies" die Nasionale Padverkeersregulasies gepubliseer in Goewermentskennisgewing No. R. 225 van 17 Maart 2000, soos gewysig deur Goewermentskennisgewings Nos. R. 761 van 31 Julie 2000 en R. 941 van 22 September 2000.

**Wysiging van regulasie 142 van die Regulasies**

2. Regulasie 142 van die Regulasies word gewysig deur die volgende paragraaf na paragraaf (b) in te voeg:

"(bA) 'n motorvoertuig waarop regulasie 273 tot 283 van die Regulasies van toepassing is, soos beoog in regulasie 274: Met dien verstande dat hierdie bepaling in werking tree, ten opsigte van motorvoertuie met 'n bruto voertuigmassa van 3 500 kilogram en minder, op 1 Desember 2001."

**Wysiging van regulasie 265 van die Regulasies**

3. Regulasie 265 van die Regulasies word gewysig deur subregulasie (1) deur die volgende subregulasie te vervang:

"(1) 'n Operateur word geregistreer met betrekking tot 'n-
  - (a) goederevoertuig waarvan die bruto voertuigmassa 3 500 kg oorskry;
  - (b) teëspoedwa; en
  - (c) motorvoertuig waarop regulasies 273 tot 283 van toepassing is soos beoog in regulasie 274: Met dien verstande dat hierdie bepaling in werking tree, ten opsigte van motorvoertuie met 'n bruto voertuigmassa van 3 500 kilogram en minder, op 1 Desember 2001,  
wat geregistreer is in die Republiek."

#### 4. Vervanging van regulasie 342 van Regulasies

Die Regulasies word gewysig deur regulasie 342 met die volgende regulasie te vervang:

##### "Oorgangsbeplings: Professionele bestuurspermitte"

342. Die houer van 'n geldige kategorie "G" of "P" professionele bestuurspermit, wie 'n motorvoertuig bestuur waarin of waarop gevaaarlike goedere vervoer word, waarvan die bruto voertuigmassa 3 500 kilogram oorskry, of 'n voertuig ten opsigte waarvan standaardspesifikasie SABS 1398 "Padtenkvoertuie vir petroleumgebaseerde ontvlambare vloeistowwe" of SABS 1518 "Vervoer van gevaaarlike goedere - ontwerpvereistes vir padtenks" van toepassing is, word vanaf die datum van inwerkingtreding van regulasie 115(1)(f)-

- (a) behoudens intrekking of opskorting van sodanige permit, geag 'n kategorie "D" professionele bestuurspermit te hou vir die tydperk waarvoor sy of haar professionele bestuurspermit geldig is; en
- (b) nieteenstaande die beplings van regulasie 117, is die houer van 'n geldige kategorie "G" of "P" professionele bestuurspermit nie onbevoeg om 'n kategorie "D" professionele permit te verkry, slegs weens die feit dat hy of sy jonger as 25 jaar oud is nie."

##### Invoeging van regulasie 343D in die Regulasies

5. Die Regulasie word gewysig deur die volgende regulasie na regulasie 343C in te voeg:

##### "Oorgangsbeplings: Kategorie "D" operateurskaart"

343D. (1) 'n Geldige kategorie "G" operateurskaart wat op 'n motorvoertuig waarop regulasies 273 tot 283 van toepassing is soos beoog in regulasie 274 vertoon word, word vanaf die datum van inwerkingtreding van regulasies 273 tot 283 geag 'n geldige kategorie "D" operateurskaart te wees vir die tydperk waarvoor dit geldig is.

(2) Nieteenstaande die datum van inwerkingtreding van regulasies 273 tot 283, moet 'n motorvoertuig wat nie 'n operateurskaart moes vertoon voor die inwerkingtreding van die genoemde regulasies nie, na die genoemde datum van inwerkingtreding 'n kategorie "D" operateurskaart vertoon binne 'n maand na die maand gedurende waarvan die lisensieskyf van die betrokke voertuig verval het."

##### Kort titel en inwerkingtreding

6. Hierdie regulasies sal as die Derde Wysiging van die Nasionale Padverkeersregulasies bekend staan en tree op 3 Augustus 2001 in werking.
