NATIONAL ROAD TRAFFIC ACT, 1996 (ACT NO. 93 OF 1996)

AMENDMENT OF THE NATIONAL ROAD TRAFFIC REGULATIONS

The Minister of Transport has under section 75 of the National Road Traffic Act, 1996 (Act No. 93 of 1996), made the regulations in the Schedule.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the National Road Traffic Regulations published in Government Notice Nos. R.225 of 17 March 2000, as amended by Government Notices No. R. 761 of 31 July 2000, R. 941 of 22 September 2000, R. 726 of 3 August 2001 and R. 2116 of 5 October 2001.

Amendment of regulation 27 of the Regulations

2. Regulation 27 of the Regulations is amended by the insertion of the following paragraph after paragraph (b) of subregulation (2):

"(bA) The MEC for the Free State Province may, notwithstanding the provisions of regulation 35, determine, in the *Provincial Gazette*, the type of number plate to be used to display a licence number of a motor vehicle licenced in the Free State Province"

Amendment of regulation 28 of the Regulations

3. Regulation 28 of the Regulations is hereby amended by the insertion of the following subregulation after subregulation (4):

"(4A) Notwithstanding the provisions of regulation 35, the MEC for the Free State Province may by notice in the *Provincial Gazette* determine the type of number plate to be used to display a personalized number of a motor vehicle licenced in the Free State Province."

Short title and commencement

4. These regulations shall be called the Fifth Amendment to the National Road Traffic Regulations, and shall come into operation upon publication in the *Gazette*.

NASIONALE PADVERKEERSWET, 1996 (WET NO. 93 VAN 1996)

WYSIGING VAN DIE NASIONALE PADVERKEERSREGULASIES

Die Minister van Vervoer het kragtens artikel 75 van die Nasionale Padverkeerswet, 1996 (Wet No. 93 van 1996), die regulasies in die Bylae uitgevaardig.

BYLAE

Woordomskrywing

1. In hierdie Bylae beteken "die regulasies" die Nasionale Padverkeersregulasies gepubliseer in Goewermenskennigewing No. 225 van 17 Maart 2000, soos gewysig deur Goewermenskennigewings Nos. R. 761 van 31 Julie 2000, R. 941 van 22 September 2000, R. 726 van 3 Augustus 2001 en R. 2116 van 5 Oktober 2001.

Wysiging van regulasie 27 van die Regulasies

2. Regulasie 27 van die Regulasies word gewysig deur die volgende paragraaf na paragraaf (b) van subregulasie (2) in te voeg:

"(bA) Die LUR van die Vrystaat Provinsie kan, ondanks die bepalings van regulasie 35, die tipe van nommerplaat om die lisensienommer van 'n motorvoertuig wat in die Vrystaat Provinsie gelisenseer is te vertoon, bepaal."

Wysiging van regulasie 28 van die Regulasies

3. Regulasie 28 van die Regulasies word gewysig deur die volgende subregulasie na subregulasie (4) in te voeg:

"(4A) Ondanks die bepalings van regulasie 35, kan die LUR van die Vrystaat Provinsie deur 'n kennisgewing in die *Provinsiale Koerant*, die tipe van nommerplaat om 'n persoonlike lisensienommer van 'n motorvoertuig wat in die Vrystaat Provinsie gelisenseer is te vertoon, bepaal."

Kort title en inwerkingtreding

4. Hierdie regulasies sal as die Vyfde Wysiging van die Nasionale Padverkeersregulasies bekendstaan en sal by kennisgewing in die *Staatskoerant* in werking tree op.
