#### **TERMINATION OF THE INVESTIGATION INTO THE ALLEGED DUMPING OF CHOPPED STRAND MATS ORIGINATING IN OR IMPORTED FROM BRAZIL**

On 12 May 2006, the International Trade Administration Commission of South Africa (Commission) formally initiated an investigation into the alleged dumping of chopped strand mats originating in or imported from Brazil and the People's Republic of China. Notice of initiation of the investigation was published in Notice No.608 in Government Gazette No.28798 dated 12 May 2006.

The investigation was initiated after the Commission considered an application by Owens Corning SA Pty Ltd (Applicant), alleging that chopped strand mats originating in or imported from Brazil and the PRC were imported into the Southern African Customs Union (SACU) at dumped prices and the Commission was satisfied that there was a *prima facie* case of dumping, material injury, and or threat of material injury and causal link.

Subsequent to initiation, exporters and importers questionnaires were sent to various known interested parties for completion.

On 19 September 2006, the Commission received a letter from International Trade Services (ITS) on behalf of the Applicant requesting that the investigation against Brazil be terminated. The Applicant indicated in its letter that Owens Corning SA (Applicant) and Saint-Gobain Vidros SA-Divisao Vertrotex (the exporter) in Brazil are in discussions to merge as partners.

The Commission, therefore, decided to recommend to the Minister of Trade and Industry to terminate the investigation into the alleged dumping of chopped strand mats originating in or imported from Brazil.

The Commission's detailed reasons for its decision are set out in Commission Report No. 203 (Final determination).

The Minister of Agriculture received a request from Potatoes South Africa (PSA) for the implementation of statutory measures in the potato industry for a new term of four years (1 July 2007 to 30 June 2011). The existing statutory measures expire on 30 June 2007. On 18 December 2006 the Minister referred the application to the NAMC for investigation and to make a recommendation to her within 120 days.

The PSA requested the introduction and promulgation of the following statutory measures in the potatoes industry:

- Section 15 of the MAP Act: Levies relating to potatoes
- Section 18 of the MAP Act: Records and returns
- Section 19 of the MAP Act: Registration

The levy amount requested by PSA:

- (a) for all classes of potatoes marketed in potato bags manufactured from kraft paper, is 1,30 c/kg;
- (b) for all classes of potatoes not marketed in the potato bags contemplated in paragraph (a) and intended for sale on the domestic market -
  - as table potatoes, is 1,30 c/kg;
  - for processing, is 0,6 c/kg; and
  - as certified seed potatoes, is 0,44 c/kg.
- (c) for all classes of potatoes not marketed in the potato bags contemplated in paragraph (a) and intended for export, is 1,30 c/kg.
- (d) for all classes of potatoes and potato products imported, is 0,92 c/kg

The proposed levy, in terms of section 15 of the MAP Act, will finance:

- basic as well as applied research, including cultivar development and evaluation, and the dissemination of all relevant technical information;
- the gathering, processing, analysing and compiling of industry related information, including market statistics, and the dissemination thereof as well as creating market access for emerging farmers (small and medium scale), including development projects related to the potato marketing chain and the development of foreign markets; and
- generic promotion of potatoes.

Of the levy collected –

- (a) approximately 70% of the funds shall be used for the core business functions (research information and generic promotion);

- (b) approximately 20% of the funds shall be used for transformation; and
- (c) not more than 10% of the funds shall be used for administration.

Directly affected groups (producers, traders, agents, processors, exporters, importers, certification bodies, export inspection bodies, kraft paper importers, kraft paper manufacturers, potato bag manufacturers, potato sack importers and fresh produce markets) in the potato industry are kindly requested to submit any comments, in writing, regarding the proposed implementation of statutory measures, to the NAMC on or before 16 February 2007, to enable the Council to finalise its recommendation to the Minister in this regard.

In order to eliminate silicosis from the South African mining industry regional and national workshops conducted by SIMRAC identified three major areas of research that needs to be focused on. These are dust measurement and reporting, dust control, and human resource training.

Based on this project SIM 03 06 03 consists of three parts, namely:

- Part A: Dust Measurements and Reporting;
- Part B: Environmental Engineering/Dust Control; and
- Part C: Human Resources Training and Management

The most important intervention strategy for any occupational disease control programme is to eliminate or reduce the stressor at source, preventing exposure, and by doing so controlling it. This approach is a key factor of the national programme to eliminate silicosis from the South African mining industry. SIMRAC has targeted the identification and assessment of feasible and cost-effective environmental-control engineering and dust-control technologies as a research priority area for the silicosis control programme.

#### **Purpose of the workshop:**

- To inform dust-generating- and dust-control-equipment manufacturers and suppliers and occupational-airborne-pollutant-control and elimination specialists of the full extent and implications of the milestone set by the MHSC summit.
