HEALTH PROFESSIONS ACT, 1974 (ACT NO. 56 OF 1974)**REGULATIONS RELATING TO THE REGISTRATION OF TECHNICIANS IN CLINICAL TECHNOLOGY**

The Minister of Health intends to make, under section 24 of the Health Professions Act, 1974 (Act No. 56 of 1974) and on the recommendation of the Health Professions Council of South Africa, the Regulations in the Schedule.

Interested persons are invited to submit any substantiated comments in writing on the proposed regulations to the Director-General: Health, Private Bag X828, Pretoria, 0001 (for the attention of the Director: Public Entities Governance), within 3 months from date of publication of this notice.

SCHEDULE**Definitions**

1. In these regulations **“the Act”** means the Health Professions Act, 1974 (Act No. 56 of 1974) and any word or expression to which a meaning has been assigned in the Act, shall have that meaning, unless the context otherwise indicates.


“professional board” means the Professional Board for Radiography and Clinical Technology established in terms of section 15 of the Act.

Requirements for registration

2. (1) The registrar may register, as an Electro-Encephalographic Technician, Electro-Cardiography Technician or Spirometry Technician, any person who-
- (a) holds an appropriate qualification, in Electro-Encephalographic Technique, Electro-Cardiograph Technique, or Spirometry Technique, granted after an examination by any institution or examining authority approved by the Professional Board from time to time, provided that no qualification shall be accepted for the purpose of this regulation unless the training thereof has extended over a minimum period of twelve months in an institution approved by the Professional Board; and
 - (b) has passed an examination in Electro-Encephalographic Technique, Electro-cardiograph Technique, or Spirometry Technique conducted by the Professional Board in terms of section 15B (1) (b) of the Act.
- (2) The Professional Board shall, for purposes of these regulations, publish a Board's Notice in the *Gazette* listing educational institutions that have been authorised by the Professional Board to offer qualifications referred to in these regulations.

Short title

3. These Regulations are called the Regulations Relating to the Registration of Technicians in Clinical Technology.


MEDICINES AND RELATED SUBSTANCES ACT, 1965 (ACT 101 OF 1965)

The Medicines Control Council by virtue of the powers vested in it by section 22C(1)(b) of the Medicines and Related Substances Act, 1965 (Act 101 of 1965) and Regulation 27(2) of the Regulations relating to Medical Devices and *In Vitro* Diagnostics (*IVDs*) has by resolution resolved that, with effect from the date of publication of this notice, all unlicensed manufacturers, distributors and wholesalers of Medical Devices and *IVDs* are required to submit applications, as the case may be, for a licence to manufacture, wholesale or distribute medical devices and *IVDs*.

In terms of the Regulation 5(1) of the Regulations on Medical Devices and *IVDs* a manufacturer, wholesaler or distributor referred to in section 22C(1)(b) of the Act must:

- "(a)...."
- (b) submit to the Registrar an application for a licence, on a form approved and provided by the Council;
 - (c) as part of the application, provide acceptable documentary proof of-
 - (i) the particulars of the owner of the business;
 - (ii) the particulars of the authorised representative; and
 - (iii) certification to a Quality Management System for medical devices and *IVDs* as determined by the Council;
 - (d) specify, as determined by the Council, the Medical Devices or *IVDs* or group or family of medical devices or *IVDs* to be manufactured, imported, exported or distributed and sold; and
 - (e) pay the application fee.


The applications for licensing of a Manufacturer or Distributor should be submitted within six (6) months of the date following the publication of this notice. The application for licensing of a Wholesaler should be submitted within twelve (12) months of the date following the publication of this notice. If no application is made within the required period, the Manufacturer, Distributor or Wholesaler will be considered to be trading in contravention of section 22C(1)(b) of the Medicines and Related Substances Act, 1965 (Act 101 of 1965).

“annual tons” The total sum of the mass of dangerous and/or general goods loaded onto a wagon by a train operator in the preceding financial year, and transported along the portion of a rail network for which the train operator has a permit to traverse;

“cape gauge” A type of railway track where the distance between the two rails of the track is 1,067 millimetres in length;

“general freight or passenger operators” means network, train and/or station operators (or a combination thereof) whose operations include the transportation of passengers and freight that excludes dangerous and/or mining goods;

“mine operations” means the operations undertaken above surface by train, network, and station operators to support mining activities;

“non-rail related revenue” means revenue generated by Train Operators, Network Operators or Station Operators whose railway operation is incidental to its main business;

“passengers” means people transported by a train between two points (i.e. a station of boarding and of disembarkation) with the exception of a train operator’s personnel;

“rail-related revenue” means the gross inflow of cash arising from all rail operating activities of an operator;

“**relevant risk based fee rate**” means the rand value equivalent of the risks attributable to rail activities. The units of measurement include R/Kilometres (for network operations), R/number of stations (for station operator), R/passenger kilometres (for passenger operations), and R/ton kilometre (for freight operations);

“**standard gauge**” railway track where the distance between the two rails of the railway track is 1,435 millimetres in length; and

“**tourist passengers**” means passengers transported aboard railway operator’s rolling stock between two points (i.e. a station of boarding and of disembarkation) for recreational purposes, with the exception of a train operator’s personnel and commuter passengers.





TOURISM ACT, 2014 (Act No. 3 of 2014)

**REGULATIONS ON THE PRESCRIBED MANNER AND PROCEDURE FOR DEALING AND LODGING
TOURISM COMPLAINTS WITH THE TOURISM COMPLAINTS OFFICER**

The Minister of Tourism has under section 61(1) (b) and (c) of the Tourism Act, 2014 (Act No. 3 of 2014), made the regulations in the Schedule.

SCHEDULE

1. DEFINITIONS

In these regulations a word or an expression defined in the Tourism Act, 2014, has that meaning, unless the context indicates otherwise-

“**Act**” means the Tourism Act, 2014 (Act No. 3 of 2014);

“**Complainant**” means a tourist or a person who lodges a tourist complaint against a perpetrator;

“**Tourism complaint**” means any complaint in respect of any tourism services, facilities or products as contemplated in section 47; and

“**Respondent**” means a person against whom a tourism complaint is lodged.

2. MANNER OF LODGING COMPLAINTS

Any person who wishes to lodge a tourism complaint must submit-

(a) information concerning the alleged contravention or instance of non-compliance in terms of or under these regulations in writing to the Tourism Complaints Officer.

(b) a tourism complaint in respect of an alleged contravention or instance of non-compliance in terms of or under these regulations, to the Tourism Complaints Officer, in the form substantially similar to Annexure “A”, together with copies of any supporting document the Tourism Complaints Officer should consider, by-

- (i) mailing it to The Office of the Tourism Complaints Officer, Private Bag X424, Pretoria, 0001;
- (ii) delivering the documents by hand to Tourism House, 17 Trevenna Street, Sunnyside, Pretoria;
- (iii) filing it electronically at www.tourism.gov.za (Website);
- (iv) e-mailing it to complaints@tourism.gov.za (e-mail address); or
- (v) any other manner acceptable to the Tourism Complaints Officer.

3. PROCEDURE FOR LODGING COMPLAINTS

- 3.1 Upon receipt of the tourism complaint, the Tourism Complaints Officer must record the complaint, give a reference number of the tourism complaint to the complainant, and investigate the tourism complaint as soon as possible.
- 3.2 The Tourism Complaints Officer must upon receiving the tourism complaint, acknowledge receipt of the tourism complaint from the complainant, in writing.
- 3.3 The Tourism Complaints Officer must, on receipt of the tourism complaint, refer the tourism complaint to the relevant institution, indicated in section 47 of the Act, for resolution.
- 3.4 The Tourism Complaints Officer must make regular follow-ups on the tourism complaint with the resolving institution, until the tourism complaint is resolved.
- 3.5 The Tourism Complaints Officer must, upon resolution of the tourist complaint by the relevant institution, as indicated in section 47 of the Act, inform the complainant of the outcome thereof in writing.

4. MANNER OF DEALING WITH TOURISM COMPLAINTS

- 4.1 Prior to dealing with a tourism complaint, the complainant may in certain instances have to show that he or she attempted to resolve the dispute with the respondent and that such an attempt was fruitless.
- 4.2 The Tourism Complaints Officer may deal with minor tourism complaints in the following manner-
 - (a) Upon receiving a tourism complaint, the Tourism Complaints Officer must acknowledge receipt of the tourism complaint.
 - (b) The Tourism Complaints Officer must first analyse and evaluate the tourism complaint to identify minor tourist complaints he/she can deal with, from those that should be referred to the authorised institutions for resolution.

- (c) The Tourism Complaints Officer must, upon receiving a tourism complaint, write and send a letter to the respondent by hand or registered mail –
- (i) informing the respondent of the nature of the tourism complaint;
 - (ii) inviting the respondent to respond to the alleged tourism complaint and provide supporting documents, if any;
 - (iii) inviting the respondent to suggest a way in which the tourism complaint may be resolved;
 - (iv) request any other information that the Tourism Complaint Officer may deem relevant or necessary; and
 - (v) inform the respondent to respond within 14 days of the date of receipt the letter.
- 4.3 After receiving the response from the perpetrator, the Tourism Complaints Officer must write a letter to the complainant, and afford him/her an opportunity to reply, to the response of the perpetrator.
- 4.4 Should the complainant be satisfied with the response and the proposed solution from the respondent, then the tourism complaint will be considered to be finalised.
- 4.5 The Tourism Complaints Officer must, upon resolution of the tourist complaint, inform both the complainant and the relevant institution empowered to deal with the tourism complaint of the outcome thereof, in writing.
- 4.6 However, should the complainant be not satisfied with the response or the proposed solution, the tourism complaint must be referred by the Tourism Complaints Officer to the institution empowered to deal with it for resolution.

5. SHORT TITLE AND COMMENCEMENT

These regulations are called Regulations on the Prescribed Manner and Procedure for Dealing and Lodging Tourism Complaints with the Tourism Complaints Officer and shall commence on....

HEALTH PROFESSIONS ACT, 1974 (ACT NO. 56 OF 1974)

RULES RELATING TO FEES PAYABLE TO COUNCIL

The Health Professions Council of South Africa has, under section 61A of the Health Professions Act, 1974 (Act No. 56 of 1974), made the rules in the Schedule.

SCHEDULE

1. In these rules, “**the Act**” means the Health Professions Act, 1974 (Act No. 56 of 1974), and any expression to which a meaning has been assigned in the Act shall have that meaning, and, unless inconsistent with the context –
- “**health practitioner**” means a health practitioner registered in terms of the Act in the relevant professional board;
- “**rules**” means the rules relating to fees payable to council; and
- “**student**” means a person who is registrable as such in terms of the Act in the relevant professional board.

Generic fees

2. The fees payable under the Act for the restoration of a name to a register are as follows:

(iii)	after a period of more than 12 months had expired since the erasure date, shall be equivalent to five (5) times the applicable annual fee for the current year plus the outstanding fee or fees






