The Minister of Justice and Correctional Services Adv. Tshililo Michael Masutha, (MP) intends, in terms of section 2(1)(a), (f), (h), (j), (k) and (l) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) read with section 6 of Schedule 6 to the Constitution of the Republic of South Africa, 1996 to:

- (a) create, in respect of the areas mentioned in Column "A" of Schedule 1, magisterial districts as reflected under Column "B" of Schedule 1 and declare that those magisterial districts be known by the names referred to in the said Column "B";
- (b) detach portions of the magisterial districts under column "B" of Schedule 1 to form areas of jurisdiction of detached courts for sub-districts as reflected under column "E" of Schedule 1 and declare that those sub-districts be known by the names referred to in the said Column "E";
- (c) establish, for the districts mentioned under Column "B" of Schedule 1 and sub-districts under Column "E" of Schedule 1, courts as reflected under Columns "C" and "F" of Schedule 1 for the purpose of—
  - (i) the trial of persons accused of committing any offences which shall have jurisdiction contemplated in section 89 and 92 of the Magistrates' Courts Act, 1944; and
  - (ii) adjudication of civil disputes contemplated in section 29(1) of the Magistrates' Courts Act, 1944;
- (d) specify, in respect of each district mentioned under Column "C" of Schedule 1, seats of the magistracy as reflected under Column "D" of Schedule 1;

- (e) appoint, in respect of the sub-districts mentioned under Column "E" of Schedule 1, places for holding of the Detached Courts as reflected under Column "F" of Schedule 1;
- (f) define, in respect of each district mentioned under Column "B" of Schedule 1, local limits as reflected in the published maps ;
- (g) define, in respect of each detached court mentioned under Column "E" of Schedule 1, the area of jurisdiction of the sub-districts concerned as reflected under the published maps;
- (h) appoint, within the districts mentioned under Column "B" of Schedule 1 and sub-districts mentioned under Column "E" of Schedule 1, places for the holding of a court and periodical courts as reflected under Column "G" of Schedule 1;
- (i) declare that the periodical courts mentioned under Column "F" of Schedule 1, shall exercise jurisdiction over the same area of jurisdiction of the districts or sub-districts; and

**SUPERIOR COURTS ACT, 2013 (ACT NO. 10 OF 2013): DETERMINATION OF THE AREA UNDER JURISDICTION OF THE GAUTENG AND NORTH WEST DIVISION OF THE HIGH COURT OF SOUTH AFRICA**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, in terms of section 6(3)(a), of the Superior Courts Act, 2013 (Act No. 10 of 2013) (the Act), read with item 16(6) of Schedule 6 to the Constitution, 1996, hereby, after consultation with the Judicial Service Commission, with effect from 18 April 2018—

- (a) amend Government Notice No. 30 published in *Government Gazette* No. 39601 of 15 January 2016, by the deletion, under Item 2 of the Schedule to the said Notice, of the following areas; Tlokwe (and Orkney and Stillfontein sub-districts); Lekwa Teemaneng (Christiana and Bloemhof), Matlosana (Klerksdorp), Tlokwe (Potchefstroom), Mamusa (Schweizer-Reneke) and Maquassie Hills (Wolmaranstad); and
- (b) determine, under Item 3 of the Schedule to the said Notice, the area of jurisdiction of the North West Division of the High Court of South Africa as indicted in the accompanying Schedule.

Other Divisions of High Court of South Africa not listed in the Schedule to the Notice published in the Gazette of 15 January 2016 continue to exercise jurisdiction conferred on them immediately before the coming into effect of the Act, until their jurisdiction is determined in terms of the Act.

**MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): CREATION OF  
MAGISTERIAL DISTRICTS AND ESTABLISHMENT OF DISTRICT COURTS IN  
RESPECT OF THE NORTHERN CAPE PROVINCE**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1)(a), (f), (h), (j), (k) and (l) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), read with item 16(6) of Schedule 6 to the Constitution, 1996, and after consultation with the Judicial Service Commission, hereby with effect from 1 May 2018—

- (a) create, in respect of the areas mentioned in Column "A" of Schedule 1, magisterial districts as reflected under Column "B" of Schedule 1 and declare that those magisterial districts be known by the names referred to in the said Column "B";
- (b) detach portions of the magisterial districts under column "B" of Schedule 1 to form areas of jurisdiction of detached courts for sub-districts as reflected under column "E" of Schedule 1 and declare that those sub-districts be known by the names referred to in the said Column "E";
- (c) establish, for the districts mentioned under Column "B" of Schedule 1 and sub-districts under Column "E" of Schedule 1, courts as reflected under Columns "C" and "F" of Schedule 1 for the purpose of—
  - (i) the trial of persons accused of committing any offences which shall have jurisdiction contemplated in section 89 and 92 of the Magistrates' Courts Act, 1944; and
  - (ii) adjudication of civil disputes contemplated in section 29(1) of the Magistrates' Courts Act, 1944;
- (d) specify, in respect of each district mentioned under Column "C" of Schedule 1, seats of the magistracy as reflected under Column "D" of Schedule 1;

- (e) appoint, in respect of the sub-districts mentioned under Column "E" of Schedule 1, places for holding of the Detached Courts as reflected under Column "F" of Schedule 1;
- (f) define, in respect of each district mentioned under Column "B" of Schedule 1, local limits as reflected under Schedule 2;
- (g) define, in respect of each detached court mentioned under Column "E" of Schedule 1, the area of jurisdiction of the sub-districts concerned as reflected under Schedule 2;
- (h) appoint, within the districts mentioned under Column "B" of Schedule 1 and sub-districts mentioned under Column "E" of Schedule 1, places for the holding of a court and periodical courts as reflected under Column "G" of Schedule 1;
- (i) declare that the periodical courts mentioned under Column "F" of Schedule 1, shall exercise jurisdiction over the same area of jurisdiction of the districts or sub-districts; and
- (j) withdraw all the Government Notices creating magisterial districts, sub-districts, places for the holding of courts and periodical courts in the Northern Cape Province before the coming into effect of this Notice.

Any criminal or civil proceedings which on the date on which this Notice takes effect, have already been placed on the court roll for trial or hearing in a court whose area of jurisdiction has been altered by this Notice and which have not commenced, shall be dealt with and be finalised by the court where the matter is enrolled as if this Notice has not been published.
