DISASTER MANAGEMENT ACT, 2002

AMENDMENT OF DIRECTIONS ISSUED IN TERMS OF REGULATIONS 4(7), 20(1) AND 20(2) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002): MEASURES TO ADDRESS, PREVENT AND COMBAT THE SPREAD OF COVID-19 IN RAILWAY OPERATIONS

I, Fikile Mbalula, MP, the Minister of Transport, after consultation with the Cabinet members responsible for cooperative governance and traditional affairs, health, police and justice and correctional services, in terms of regulations 4(7), 20(1) and 20(2) of the Regulations issued in terms of the Disaster Management Act, 2002 (Act No. 57 of 2002), hereby amend the directions published under Government Notice No. 494, in Government *Gazette* No. 43273 of 4 May 2020, by the substitution for direction 13 of the following direction:
