**PUBLIC FINANCE MANAGEMENT ACT, 1999: AMENDMENT OF GOVERNMENT  
NOTICE NO. 437 OF 31 MARCH 2020**

I, Tito Titus Mboweni, hereby in terms of section 92 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), amend Government Notice No. 437 of 31 March 2020 by—

- (a) excluding an institution listed in a Schedule to that Act with a financial year ending 30 June, from the application of that Notice;
- (b) the deletion of the definition of “national state of disaster” in paragraph 1 of the Schedule;
- (c) the substitution of subparagraph (2) of paragraph 2 of the Schedule for the following subparagraph:  
“(2) The relevant functionary or institution must comply with a provision referred to in subparagraph (1) within two months after the deadline in the applicable provision.”; and
- (d) the deletion of subparagraph (3) of paragraph 2 of the Schedule.
