**FIREARMS CONTROL ACT, 2000 (ACT NO. 60 OF 2000)
FIREARMS CONTROL FEES AMENDMENT REGULATIONS, 2020**

The Minister of Police has, under section 145(1) of the Firearms Control Act, 2000 (Act No. 60 of 2000) amended Annexure B of the Firearms Control Regulations, 2004, as set out in the Schedule.

SCHEDULE

1. Definition

In these regulations "the Regulations" mean the Firearms Control Regulations, 2004, promulgated in Government Notice No. R. 345, dated 26 March 2004 (as amended).

2. Amendment of Annexure B of the Regulations

- (1) Annexure B of the Regulations is hereby amended by substitution for Annexure B with the following Annexure:
