MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944) APPOINTMENT OF PLACES WITHIN THE DISTRICT OTHER THAN THE SEAT OF THE MAGISTRACY FOR THE HOLDING OF A COURT

I, Ronald Ozzy Lamola, Minister of Justice and Correctional Services, acting under section 2(1) (h) of the Magistrates' Courts Act, 1944 (Act No, 32 of 1944), hereby with effect from 30 August 2021-

- (a) Vary notice No. 962, published in Government Gazette No. 38268 dated 28 November 2014, by the deletion Visagie Street as a place for the holding of court under Tshwane Central Magisterial District;
- (b) Appoint Pretmed Building, 333 Pretorius Street, Pretoria, as a place for the holding of a court within the Tshwane Central Magisterial District;
- (c) Appoint Council Chamber Wing, 330 Helen Joseph Street, Pretoria, as a place for the holding of a court within the Tshwane Central Magisterial District; and
- (d) Prescribe the local limits of Pretoria main seat of Tshwane Central Magisterial District, as the local limits within which the said courts shall have jurisdiction.
