AMENDMENT OF THE DIRECTIONS ISSUED IN TERMS OF REGULATION 4(7)(b) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002): THE TAXI RELIEF FUND TOWARDS THE IMPACT OF COVID-19 IN THE TAXI INDUSTRY FOR ADJUSTED ALERT LEVEL 1

I, **Fikile Mbalula, MP**, Minister of Transport, in terms of regulation 4(7)(b) of the Regulations issued in terms of the Disaster Management Act, 2002 (Act No. 57 of 2002), hereby amend direction 6 published under Government Notice No. 1567, in Government *Gazette* No. 45575 of 02 December 2021 as set out in the Schedule for Adjusted Alert Level 1.

#### **Definitions**

 In these directions, the "Directions" means the Directions on measures to address, prevent and combat the spread of COVID-19: The Taxi Relief Fund towards the impact of Covid-19 in the Taxi industry, published under Government Notice No. 1567, in Government Gazette No. 45575 of 02 December 2021.

## Amendment of direction 6 of the Directions

- 2. Direction 6 of the Directions is hereby amended by the substitution for subdirection (1) of the following subdirection:
  - "(1) The cut-off of date for the submission of application for the taxi relief fund is 11 March 2022."

This amendment shall come into effect on the date of publication in the Government Gazette.
