I, **Fikile Mbalula, MP**, Minister of Transport, in terms of regulation 4(7)(b) of the Regulations issued in terms of the Disaster Management Act, 2002 (Act No. 57 of 2002), hereby amend direction 6 published under Government Notice No. 1567, in Government *Gazette* No. 45575 of 02 December 2021 as set out in the Schedule for Adjusted Alert Level 1.

## Schedule

### Definitions

1. In these directions, the "Directions" means the Directions on measures to address, prevent and combat the spread of COVID-19: The Taxi Relief Fund towards the impact of Covid-19 in the Taxi industry, published under Government Notice No. 1567, in *Government Gazette* No. 45575 of 02 December 2021.

### Amendment of direction 6 of the Directions

2. Direction 6 of the Directions is hereby amended by the substitution for subdirection (1) of the following subdirection:

"(1) The cut-off of date for the submission of application for the taxi relief fund is 11 March 2022."

### Commencement

3. This amendment shall come into effect on the date of publication in the *Government Gazette*.
