**PUBLIC FINANCE MANAGEMENT ACT, 1999: LISTING AND DELISTING OF
PUBLIC ENTITIES**

I, Enoch Godongwana, Minister of Finance hereby, in terms of section 47, read with section 48, of the Public Finance Management Act, 1999 (Act No. 1 of 1999 – “the Act”), and, with effect from the date of publication of this Notice unless otherwise indicated, amend—

- (a) Part A of Schedule 3 to the Act by including—
- (i) after Productivity South Africa, Property Practitioners Regulatory Authority;
 - (ii) after Mine Health & Safety Council, Mines and Works Compensation Fund;
 - (iii) after State Theatre, Pretoria, Takeover Regulation Panel;
 - (iv) after Banking Sector Education and Training Authority, Border Management Authority, with effect from 1 April 2023;
 - (v) after Perishable Products Export Control Board, Pongola-Umzimkulu Catchment Management Agency;
 - (vi) after Mining Qualifications Authority, Mzimvubu-Tsitsikamma Catchment Management Agency;
 - (vii) after Urban Transport Fund, Vaal-Orange Catchment Management Agency; and
 - (viii) after Nelson Mandela Museum, Umtata, Ombud Council, with effect from 1 April 2023;
- (b) Part A of Schedule 3 to the Act by replacing Breede-Gouritz Catchment Management Agency with Breede-Olifants Catchment Management Agency;
- (c) Part A of Schedule 3 to the Act by deleting Estate Agency Affairs Board; and
- (d) Part B of Schedule 3 to the Act by deleting Sedibeng Water.
