**PROCLAMATION**

BY THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA.

DATE OF COMING INTO FORCE OF SECTIONS SIXTY-EIGHT TO SEVENTY-TWO, BOTH INCLUSIVE, OF THE MERCHANT SHIPPING ACT, 1951 (ACT NO. 57 OF 1951), AS AMENDED.

Under and by virtue of the powers vested in me by section *three hundred and fifty-eight* of the Merchant Shipping Act, 1951 (Act No. 57 of 1951), I hereby declare that sections *sixty-eight to seventy-two*, both inclusive, of the said Act, shall come into operation on the first day of November, 1961.

SPECIAL FEE IN RESPECT OF THE INSPECTION OF MOHAIR INTENDED FOR EXPORT FROM THE REPUBLIC.

1. Whereas a fee is payable under regulations made in terms of the Agricultural Produce Export Act, 1959 (Act No. 10 of 1959), in respect of the inspection of mohair intended for export.

Now, therefore, under the powers vested in me by sections *four and nine* of the Agricultural Grading Act, 1959 (Act No. 9 of 1959), I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, do hereby prescribe as from the 6th October, 1961, a special fee at the rate of 2c per lb, in respect of the inspection of mohair intended for export, to be devoted to the promotion of the future production of mohair.

The said special fee shall be paid by the owner or consignor of such mohair at the time of export to the Secretary for Agricultural Economics and Marketing, Private Bag 250, Pretoria.

2. Government Notice No. 1208 of 31st July, 1959, is hereby repealed as from the 6th October, 1961.

CORRECTION OF GOVERNMENT NOTICE NO. R. 753 OF THE 22ND SEPTEMBER, 1961.—REGULATIONS MADE UNDER SECTION ONE HUNDRED AND SEVENTY-THREE OF THE LIQUOR ACT, 1928.

CUSTOMS ACT, 1955.—TEMPORARY SUSPENSION OF DUTY ON IRON AND STEEL SHEETS COATED WITH TIN (No. 1/136).

I. THEOPHILUS EBENHAEZER DÖNGES, Minister of Finance, acting in terms of the powers vested in me by section sixty-five of the Customs Act, 1955, hereby suspend the duty of 3 per cent *ad valorem* provided for in item 122 (b) (4) (ii) of the Customs Tariff in respect of iron and steel sheets coated with tin, when such sheets are imported in such quantities as may be permitted by me prior to the 31st December, 1961.
