Your Excellency

I have the honour to acknowledge receipt of Your Excellency's letter of 22 September 1989 which reads as follows:

"I have the honour to refer to recent discussions between our two Governments about the question of the wreck of the Birkenhead and to propose a settlement of all outstanding issues in the following terms:

The wreck of the Birkenhead shall, as a military grave, continue to be treated at all stages with respect. In particular, the South African Government shall seek to ensure that the salvors treat reverently and refrain from disturbing or bringing to the surface any human remains which may be discovered at the site of the wreck or in its vicinity. British military historians shall have temporary access for research purposes to salvaged artefacts designated for South African museums.

BREEDERIVER GOVERNMENT WATER CONTROL AREA.—DETERMINATION OF THE MAXIMUM EXTENT OF LAND THAT MAY BE IRRIGATED

1. I, Jacob Albertus van Wyk, Deputy Minister of Water Affairs, acting on behalf of the Minister of Water Affairs, hereby, in terms of section 63 (1) (b) of the Water Act, 1956 (Act No. 54 of 1956), make the provisions of section 63 of the said Act applicable to the above-mentioned Government water control area. In consequence of this I hereby also prohibit, in terms of section 63 (11A) of the said Act, the construction, alteration or enlargement of a water work for the abstraction, diversion, impoundment or storage of water from or in the Breede River, except in terms of a permit issued by me and subject to the conditions specified in such permit.

2. I hereby further determine in terms of section 63 (2), read with section 63 (2A), of the said Act that the maximum extent of land comprising each piece of land included in the said Government water control area which can be irrigated by means of water derived from the Greater Brandvlei Dam from the Breede River shall be as follows: Provided that such land can, in the opinion of a scheduling board appointed by me in terms of section 64 (1) of the said Act, be irrigated beneficially and that the said board is satisfied that sufficient potentially irrigable land is available:

- (a) Thirty-five (35) hectares per owner as registered in the office of the Registrar of Deeds on the date by which such land was included in the said control area; or
- (b) the area as indicated in the schedule of rateable areas, compiled in terms of section 88 of the Water Act, 1956, by the Breede River Water Conservation Board and which was in force on 21 February 1986 and the area of land riparian to the Breede River that was scheduled for irrigation from the Breede River by another irrigation board in terms of section 88 of the Water Act, 1956 on the said date; or

- (c) the area that was scheduled on 8 February 1983 for irrigation from the Breede River in terms of section 88 of the Water Act, 1956, by the boards mentioned in paragraph 2 (b) above, plus the area for which the owners concerned, on invitation by the Breede River Water Conservation Board dated 8 February 1983, applied in writing for additional scheduling: Provided that the latter be limited to 80 per cent of the remaining irregable potential of the properties to which the applications are applicable, to a maximum of 105 hectares per owner who submitted an application(s) and that only an application(s) submitted before or on 9 September 1983 on a prescribed form, are considered for these additional allocations; or
- (d) the most beneficial area in terms of paragraph 2 (a) and 2 (b) hereof, plus the area specified in an authorisation issued in terms of section 56 (3) of the Water Act, 1956, to owners who, in reaction to the invitation mentioned in paragraph 2 (c) above, built private pumping schemes for the abstraction of water from the Breede River before 9 September 1983; or
- (e) in the case of properties included in—

- (i) the Rooibrug Irrigation District and the Worcester East Major Irrigation District as respectively established by Proclamation No. 164 of 4 September 1981 and 91 of 10 June 1983; and
- (ii) the proposed Langevallei Irrigation District as described in Notice 494 of 1 July 1983,

the areas scheduled on the date of the said Proclamations and Notice by the boards mentioned in paragraph 2 (b) above, plus—

- (aa) the areas scheduled in the first schedule of rateable areas of the Rooibrug Irrigation Board and the Worcester East Major Irrigation Board; and
- (bb) the planned scheduling indicated in the proposed schedule of rateable areas for the proposed Langevallei Irrigation Board:

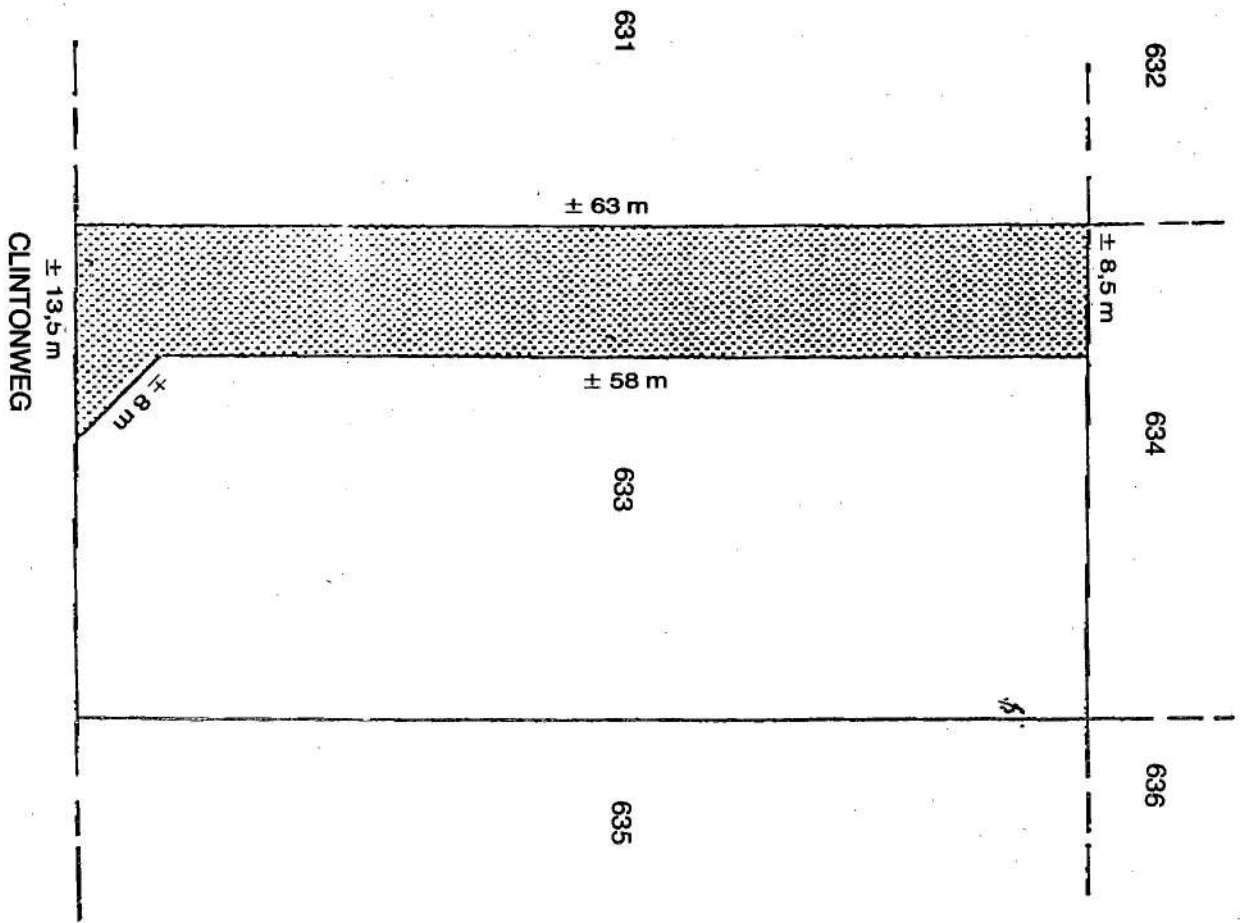
