### REGULATIONS UNDER THE STERILISATION ACT, 1998 (ACT NO. 44 OF 1998)

The Minister of Health intends, in terms of section 8 of the Sterilisation Act, 1998 (Act No. 44 of 1998), and after consultation with the members of the Executive Council, to make the regulations in the Schedule.

Interested persons are invited to submit any substantiated comments on the proposed regulations or representations they wish to make in regard hereto to the Director-General of Health, Private Bag X828, Pretoria, 0001 (for the attention of the Director: Mental Health and Substance Abuse), within one month of the date of publication of this notice.

### SCHEDULE

#### **Definitions**

1. In these regulations any word or expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates—

“annexure” means an annexure to these regulations;

“panel” means a panel as contemplated in section 3 of the Act;

“Form 1” means the form in Annexure A;

“Form 2” means the form in Annexure B;

“standard consent form” means a form provided by a health facility for recording consent to the administration of a local or general anaesthetic and an accompanying surgical procedure;

“the Act” means the Sterilisation Act, 1998 (Act No. 44 of 1998).

#### **REQUEST FOR STERILISATION**

##### **Persons capable of consenting**

2. (1) A person who is capable of consenting and who requests that a sterilisation be performed on him or her shall complete Part A of Form 1 and submit such form to the head of the healthy facility, together with a completed standard consent form.

(2) Where a sterilisation is to be performed in terms of section 2 (3) (a) of the Act, Part B of Form 1 shall be completed.

##### **Persons incompetent to consent or incapable of consenting owing to severe mental disability**

3. (1) The parent, spouse, guardian or curator who requests the sterilisation of a person who is incapable of consenting or incompetent to consent owing to severe mental disability shall complete Part B of Form 1.

(2) A person suffering from chronic or acute mental illness shall not be considered for sterilisation while he or she is unable to consent owing to such mental illness.

#### **CONSENT**

4. A standard consent form for surgical procedures used by the health facility or hospital concerned shall be completed in any request for sterilisation.

#### **PLACE WHERE STERILISATION MAY TAKE PLACE**

5. (1) A public or private health facility shall have the following to be designated a facility in terms of section 5 of the Act:

- (a) Access to medical and nursing personnel;
- (b) access to an operating theatre;
- (c) appropriate surgical equipment;
- (d) drugs for intravenous and intramuscular injection;
- (e) emergency resuscitation equipment and access to emergency referral centre or facility;
- (f) access to appropriate transport should the need arise for emergency transfer;
- (g) facilities and equipment for clinical observation and access to inpatient facilities;
- (h) appropriate infection control measures;
- (i) access to safe waste disposal infrastructure; and
- (j) telephonic means of communication.

(2) A facility shall be able to provide a twenty-four-hour service to be considered for designation.

#### **NOTIFICATION OF STERILISATION**

6. The person performing a sterilisation shall complete Form 2 and submit such form to the head of the health facility at which the sterilisation is to be performed.





