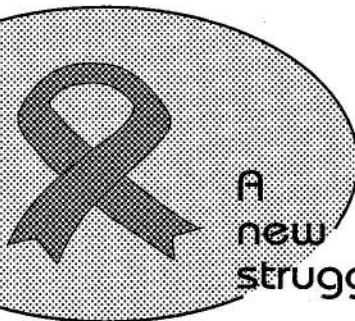

ESTABLISHMENT OF EQUALITY REVIEW COMMITTEE AND APPOINTMENT OF MEMBERS THEREOF

- (f) In terms of section 32(f) of the Act, the Honourable Ms N Botha, a member of the National Assembly.
- (g) In terms of section 32(g) of the Act, the Honourable Mr P D N Maloyi, a member of the National Council of Provinces.

2. I hereby also appoint Dr N B Pityana as chairperson of the Committee.


