PROCLAMATION

by the

President of the Republic of South Africa

NATIONAL HEALTH ACT, 2003 (ACT No. 61 OF 2003): COMMENCEMENT

Under section 94 of the National Health Act, 2003 (Act No. 61 of 2003), I hereby determine 2 May 2005 as the date on which, to the extent indicated below, the following sections of the said Act shall come into effect:

- (a) Preamble;
- (b) Schedule (Definitions)—all definitions;
- (c) Chapter One—all sections;
- (d) Chapter Two—all sections with the exception of section 11;
- (e) Chapter Three—all sections;
- (f) Chapter Four—all sections;
- (g) Chapter Five—all sections;
- (h) Chapter Seven—all sections except sections 50 and 51;
- (i) Chapter Nine—all sections except section 71;
- (j) Chapter Ten—all sections except sections 77, 78, 79 and 83;
- (k) Chapter 11—all sections;
- (l) Chapter 12—all sections including section 93 (1) but only to the extent that section 93 (1) repeals—
 - (i) sections 14, 15, 16, 18, 19, 21, 22, 23, 24, 25, 26, 29, 30, 31, 41, 53 of the Health Act, 1977 (Act No. 63 of 1977);
 - (ii) those sections of the Health Amendment Act, 1979 (Act No. 18 of 1979) if any, that amend the sections of the Health Act, listed in subparagraph (i);
 - (iii) those sections of the Health Amendment Act, 1981 (Act No. 33 of 1981), that amend the sections of the Health Act, 1977 listed in paragraph (i);
 - (iv) those sections of the Health Amendment Act, 1982 (Act No. 37 of 1982), if any, that amend the sections of the Health Act listed in subparagraph (i);
 - (v) those sections of the Health Amendment Act, 1983 (Act No. 21 of 1983), if any, that amend the sections of the Health Act listed in subparagraph (i);
 - (vi) those sections of the Health Amendment Act, 1984 (Act No. 2 of 1984), if any, that amend the sections of the Health Act listed in subparagraph (i);
 - (vii) those sections of the Health Amendment Act, 1985 (Act No. 70 of 1984), if any, that amend the sections of the Health Act listed in subparagraph (i);
 - (viii) the National Policy for Health Act, 1990 (Act No. 116 of 1990);
 - (ix) the Academic Health Centre Act, 1993 (Act No. 86 of 1993);
 - (x) those sections of the Health and Welfare Matters Amendment Act, 1993 (Act No. 118 of 1993), that amend the sections of the Health Act listed in subparagraph (i).
