AMENDMENT OF TELEPHONE REGULATIONS.

His Excellency the Governor-General has been pleased, under the provisions of sub-section (4) of section two and of section three of Act No. 44 of 1958, to approve of the following amendment to the Telephone Regulations:—

Regulation 37.—After “King William’s Town” insert “Klerksdorp”.

Regulation 46 and 47.—Re-number regulations 46 and 47 as 46 (i) and 46 (ii), respectively.

Insert the following new regulations 47 and 48:—

47. Automatic Exchanges with Variable Time Interval Metering.—For the purpose of these regulations an “automatic exchange with variable time interval metering” shall mean an automatic exchange where the charges for trunk calls directly dialled by subscribers are registered as local call units on subscribers meters, as follows:—

- One unit is registered at the commencement of each call, a second unit during the first meter-period and thereafter one unit at the end of each meter-period throughout the duration of the call.
- The meter-periods vary in accordance with the distance between the exchanges concerned and are as follows:—

48. Grouping of Exchanges.—The Postmaster-General may, at his discretion, group two or more exchanges together for trunk-call tariff purposes and may apply the tariff for one of them to each of the other exchanges within the group, where this is necessary for technical or economic reasons.

Voeg die volgende nuwe regulasies 47 en 48 in:—

47. Outomatiese sentrales met telling volgens wisselbare tydskuur.—Vir die bepalings van hierdie regulasie beteken ’n „outomatiese sentrale met telling volgens wisselbare tydskuur”, ’n outomatiese sentrale waar die koste vir hooflynoproep, wat regstreeks deur huurders geskakel word, as plaaslike oproepenhede, soos volg, op huurders se tellers geregistreer word:—

- Een eenheid word aan die begin van elke oproep geregistreer, ’n tweede eenheid gedurende die eerste telperiode en daarna deurgaans een eenheid aan die einde van elke telperiode vir die duur van die oproep.
- Die telperiodes wissel na gelang van die afstand tussen die betrokke sentrales en is soos volg:—
