AMENDMENT OF TELEPHONE REGULATIONS.

His Excellency the Governor-General has been pleased under the provisions of sub-section (4) of section *two* and of section *three* of Act No. 44 of 1958, to approve of the following amendment to the Telephone Regulations:—

Regulation 40.—After “Cape Town” (Cape Peninsula Exchange System, Zone A) insert “Maitland, Pinelands”.

Regulation 46 (ii).—Under “For the purpose of this regulation—” delete “(a) the Cape Peninsula exchange system (Group 1) shall comprise the Camps Bay, Cape Town, Rondebosch, Sea Point, Woodstock and Wynberg exchanges” and replace by “(a) the Cape Peninsula exchange system (Group 1) shall comprise the Camps Bay, Cape Town, Maitland, Pinelands, Rondebosch, Sea Point, Woodstock and Wynberg exchanges”.

AMENDMENT OF TELEPHONE REGULATIONS.

His Excellency the Governor-General has been pleased under the provisions of sub-section (4) of section *two* and of section *three* of Act No. 44 of 1958, to approve of the following amendment to the Telephone Regulations:—

Regulation 21.—Delete and replace by the following:—

“21. *Restrictions upon the Use of Exchange Lines.*—If the telephone traffic offered over a subscriber's exchange line or group of lines is beyond its capacity, that is, if it is so frequently engaged that the uncompleted calls cause overloading of the exchange equipment, the Postmaster-General may give the subscriber notice in writing, requiring him to hire such number of additional exchange lines as in the opinion of the Postmaster-General are necessary to meet the requirements of the telephone traffic to and from the subscriber concerned, and if the subscriber fails to comply with such notice within one month of its receipt, the Postmaster-General may determine the agreement at any time thereafter by notice in writing to that effect.”

WYSIGING VAN TELEFOONREGULASIES.

Dit het Sy Eksellensie die Goewerneur-generaal behaag om, kragtens die bepaling van subartikel (4) van artikel *twee* en van artikel *drie* van Wet No. 44 van 1958, sy goedkeuring te heg aan die onderstaande wysiging van die Telefoonregulasies:—

Regulasie 21.—Skrap en vervang dit deur die volgende:—

„21. *Gebruik van sentralelyne: Beperkings.*—Indien die verkeer wat oor 'n huurder se sentralelyn of groep lyne aangebied word, bo die vermoë van die lyn/lyne is, dit wil sê, as dit so dikwels beset is dat die onvoltooide oproepe die sentrale-uitrusting oorlaai, kan die Posmeester-generaal die huurder skriftelik kennis gee en van hom vereis dat hy soveel addisionele sentralelyne huur as wat, na die oordeel van die Posmeester-generaal, nodig is om te voldoen aan die vereistes van die telefoonverkeer van en na die betrokke huurder, en as die huurder in gebreke bly om die gestelde vereistes binne een maand na ontvangs van die kennisgewing na te kom, kan die Posmeester-generaal te eniger tyd daarna die ooreenkoms by skriftelike kennisgewing beëindig.
