CUSTOMS ACT, 1955.—AMENDMENT OF THE THIRD SCHEDULE.
(No. 3/20.)

I, THEOPHILUS EBENHAEZER DÖNGES, Minister of Finance, acting under the powers conferred upon me by section *one hundred* of the Customs Act, 1955, hereby amend the Third Schedule to the said Act to the extent set out in the Schedule hereto.

920	By the substitution for the item of the following item:— “920 Goods (excluding any goods the importation of which is prohibited) to a value not exceeding £25, brought into the Union in the baggage of visitors, immigrants, tourists and Union residents returning to the Union .. Provided that— (a) such goods accompany the importer, are declared at the place where he enters the Union and are not imported on behalf of other persons or for trade purposes; (b) returning Union residents who have been absent from the Union for less than 14 days, persons travelling between places in the Union only, persons in transit through the Union to or from other African territories (except in respect of and to the extent mentioned in paragraph (c)) and minors travelling with one or both their parents, shall not be entitled to the rebate; (c) no more than the undermentioned quantities of the goods specified hereunder is included in such value of £25 allowed in respect of each person, but for the purposes of sub-paragraphs (i) and (ii) a husband and his wife travelling together shall be regarded as one person: (i) Potable spirits .. one-sixth gallon; (ii) Wine one-sixth gallon; (iii) Perfumed spirits and toilet waters one-half pint; (iv) Tobacco: Cigarettes 400; Cigars 50; Pipe and cigarette tobacco one-half pound.”	The whole duty:	—

EXCISE ACT, 1956.—AMENDMENT OF REGULATIONS.

I, THEOPHILUS EBENHAEZER DÖNGES, Minister of Finance, acting in terms of the powers vested in me by section *ninety-nine* of the Excise Act, 1956, hereby amend Government Notice No. 2159 of the 3rd December, 1943:

(a) by the substitution for paragraph (3) of Regulation No. 10 of the following paragraph:—

“(3) Excisable goods taken on board any ship or aircraft as stores must be laden under the supervision of a customs officer. If such stores are consumed on any ship in any port in the Union or on any aircraft at any place in the Union when the aircraft is not airborne or on any aircraft on a flight between any places in the Union, the duty thereon shall be paid by the master or pilot or the agents of such ship or aircraft.”; and

(b) by the deletion in Regulation No. 42 of the word “proof”.

AKSYNSWET, 1956.—WYSIGING VAN REGULASIES.

Ek, THEOPHILUS EBENHAEZER DÖNGES, Minister van Finansies, handelende kragtens die bevoegdheid my verleen by artikel *nege-en-negentig* van die Aksynswet, 1956, wysig hierby Goewermentskennisgewing No. 2159 van 3 Desember 1943—

(a) deur paragraaf (3) van Regulasie No. 10 deur die volgende paragraaf te vervang:—

„(3) Synsbare goedere wat as voorrade op 'n skip of vliegtuig gelaai word, moet onder toesig van 'n doeanebeampte gelaai word. Indien die voorrade verbruik word op 'n skip in 'n hawe in die Unie of op 'n vliegtuig op enige plek in die Unie wanneer die vliegtuig nie in die lug is nie of op 'n vliegtuig op 'n vlug tussen plekke in die Unie, moet die regte daarop deur die gesagvoerder of vlieënier of die agente van sodanige skip of vliegtuig betaal word.”; en

(b) deur in Regulasie No. 42 die woord „proefsterkte” deur die woord „sterkte” te vervang.
