His Excellency the Governor-General has been pleased, in terms of sub-section (4) of section two and section three of the Post Office Act, 1958 (Act No. 44 of 1958), to approve that the Telegraph Regulations published in Government Notice No. R. 610 of 29th April, 1960, as amended, be further amended as follows:—

Schedule D (page 16) under the heading "Temporary telex connection from sports grounds" replace:—

- (i) "R0.62½ per hour" (for the use of a Post Office operator) by "R0.75 per hour"; and
- (ii) "R0.15 per hour" (for the use of a Post Office messenger) by "R0.25 per hour".

AMENDMENT OF THE REGULATIONS FOR THE ARTIFICIAL INSEMINATION OF ANIMALS.

His Excellency the Governor-General has, under the powers vested in him by section twenty of the Artificial Insemination of Animals Act, 1954 (Act No. 23 of 1954), as amended, amended the regulations published by Government Notice No. R. 1038 of 1960, by the substitution for regulation 15 thereof of the following regulation:—

"15. (1) Bulls at registered A.I. centres which do not comply with the requirements for approval, shall be removed from the centre forthwith: Provided that a bull which does not fully comply with the requirements for approval and from which semen is collected exclusively for the insemination of animals belonging to the owner of such bull, may be permitted to remain on the premises of a registered A.I. centre on such conditions as the Registrar may specify in a written permit and for so long as there is compliance with such conditions.

(2) The Registrar may at any time in his discretion withdraw any permit issued by him in terms of the proviso to sub-regulation (1) and may alter or add to the conditions specified in such permit."

WYSIGING VAN DIE REGULASIES VIR DIE KUNSMATIGE INSEMINERING VAN DIERE.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid hom verleen by artikel twintig van die Wet op Kunsmatige Inseminering van Diere, 1954 (Wet No. 23 van 1954), soos gewysig, die regulasies, soos gepubliseer in Goewermentskennisgewing No. R. 1038 van 1960, gewysig deur regulasie 15 daarvan deur die volgende regulasie te vervang:—

„15. (1) Bulle op geregistreerde K.I.-sentrum wat nie aan die vereistes vir goedkeuring voldoen nie, moet dadelik van die sentrum verwijder word: Met dien verstande dat 'n bul wat nie volkomé aan die vereistes vir goedkeuring voldoen nie en waarvan die saad uitsluitlik opgevang word vir die inseminering van diere van die eienaar van sodanige bul, toegelaat kan word om op die perseel van 'n geregistreerde K.I.-sentrum te bly op die voorwaardes wat die Registrateur in 'n skriftelike permit mag spesifiseer en solank as wat daar aan sodanige voorwaardes voldoen word.

(2) Die Registrateur kan te eniger tyd 'n permit wat hy kragtens die voorbehoudsbepaling by sub-regulasie (1) uitgereik het, na goeddunke terugtrek en kan die voorwaardes in sodanige permit gespesifieer, wysig of daaraan toevoeg.“
