AMENDMENT OF TELEPHONE REGULATIONS.

His Excellency the Governor-General has been pleased, under the provisions of sub-section (4) of section *two* and of section *three* of Act No. 44 of 1958, to approve of the following amendments to the Telephone Regulations:—

Regulation No. 46 (ii):—

After “The Durban and Pietermaritzburg exchange systems” insert “Pietermaritzburg exchange system and Cato Ridge . . . R0.05. Pietermaritzburg exchange system and Howick . . . R0.02½”.

After “The Durban exchange system (Group 1) on the one hand and Amanzimtoti”, insert “Cato Ridge”.

After “The Durban exchange system (Group 1) on the one hand and Scottburgh and Stanger on the other hand” insert “The Durban exchange system (Group 2) on the one hand and Cato Ridge on the other hand . . . R0.02½”.

AMENDMENT TO TELEPHONE REGULATIONS.

His Excellency the Governor-General has been pleased, under the provisions of sub-section (4) of section *two* and of section *three* of Act No. 44 of 1958, to approve of the following amendments to the Telephone Regulations:—

Regulation No. 27 (ii).

Substitute “subscriber connected to a farm telephone or other party line” for “farm telephone subscriber”.

PART III.

Substitute the following for the existing heading:—

“MULTIPARTY TELEPHONE LINES (AUTOMATIC AND NON-AUTOMATIC), FARM TELEPHONE LINES (AUTOMATIC AND NON-AUTOMATIC) AND RURAL EXCHANGE LINES.”

For Regulation No. 51 substitute the following:—

“51. *Multiparty Telephone Lines (Automatic and Non-automatic), Farm Telephone Lines (Automatic and Non-automatic) and Rural Exchange Lines.*—Multiparty telephone lines (automatic and non-automatic), farm telephone lines (automatic and non-automatic) and rural exchange lines shall be provided only where and when in the opinion of the Postmaster-General this is the most suitable type of service to meet requirements.

Where multiparty or farm telephone lines are connected to a semi-automatic switching unit such unit shall be deemed to be a departmental exchange.”

Regulasie No. 27 (ii).

DEEL III.

Vervang die bestaande opskrif deur die volgende:—
MEERPERSOONSTELEFOONLYNE (OUTOMATIES EN NIE-OUTOMATIES), PLAASSTELEFOONLYNE (OUTOMATIES EN NIE-OUTOMATIES) EN PLATTELANDSE SENTRALELYNE.”

Vervang Regulasie No. 51 deur die volgende:—

„51. *Meerpersoonstelefoonlyne (outomaties en nie-outomaties), plaastelefoonlyne (outomaties en nie-outomaties) en plattelandse sentraleyne.*—Meerpersoons-telefoonlyne (outomaties en nie-outomaties), plaastelefoonlyne (outomaties en nie-outomaties) en plattelandse sentraleyne word slegs verskaf as dit na die mening van die Posmeester-generaal die geskikste soort diens vir die doel is.

Waar meerpersoons- of plaastelefoonlyne by 'n half-outomatiese skakeleenheid aangesluit word, word die skakeleenheid as 'n departementele sentrale beskou.”

Substitute "Non-automatic Multiparty and Farm Telephone Line Service."—The annual rental per subscriber for a non-automatic multiparty or farm telephone line service shall be as follows:—" " for "Non-automatic Farm Telephone Line Service."—The annual rental per subscriber for a non-automatic farm telephone line service shall be as follows:—" "

Renumber Regulation No. "53" as "53 (ii)".

Add the following new Regulation No. 53 (i):—

"53. (i) *Automatic Multiparty Telephone Line Service.*—The annual rental, per subscriber, for an automatic multiparty telephone line service is R16.00.

Call Fees:—

(a) For calls between subscribers on the same line	Free.
(b) For each call to the exchange to which the subscriber is connected or to another exchange in the same zone.....	R0.02½
(c) To exchanges in adjacent zones.....	R0.05
(d) To exchanges in the third zone (the subscriber's zone counting as the first), within the same exchange system.....	R0.07½
(e) To exchanges in the fourth zone (the subscriber's zone counting as the first), within the same exchange system.....	R0.07½
(f) To exchanges in the fifth zone (the subscriber's zone counting as the first), within the same exchange system.....	R0.10
(g) To exchanges in the sixth zone (the subscriber's zone counting as the first), within the same exchange system.....	R0.12½
(h) For calls to exchanges more than six zones distant (the subscriber's zone counting as the first), within the same exchange system, the rates for trunk calls shall apply."	

For Regulation No. 55, substitute the following:—

"55. *Re-arrangement of Multiparty and Farm Telephone Lines.*—The Postmaster-General reserves the right to re-arrange any multi-party or farm telephone line where such re-arrangement would result in immediate or eventual economy in construction costs."

For regulation No. 56, substitute the following:—

"56. *Limitation of Connections.*—(a) *Farm Telephone Lines (Automatic and Non-automatic).*—The connection of more than ten parties to any non-automatic farm telephone line shall not ordinarily be permitted. The number of connections to an automatic farm telephone line is limited to a maximum of ten. The provision of a second connection on the same line for an individual subscriber and the connection of persons other than bona fide farmers shall be entirely at the discretion of the Postmaster-General.

(b) *Multiparty Telephone Lines (Automatic and Non-automatic).*—The connection of more than ten parties to any non-automatic multiparty telephone line shall not ordinarily be permitted. The number of connections to an automatic multiparty telephone line is limited to a maximum of five. The provision of a second connection on the same line for an individual subscriber shall be entirely at the discretion of the Postmaster-General."

Regulation No. 57.

After "Completion of Contracts.—" insert "(a) *Farm Telephone Lines (Automatic and Non-automatic).*—".

Insert the following new paragraph (b):—

"(b) *Multiparty Telephone Lines (Automatic and Non-automatic).*—Subscribers of multiparty telephone line services shall be liable for the payment of rental for a fixed minimum period of six months, calculated from the date of commencement of service, provided that where service is required in premises in which a complete installation exists, the subscriber's minimum rental liability shall cover any unexpired balance of the aforementioned fixed period of the agreement with the previous subscriber."

Die getal aansluitings op 'n outomatiese plaastelefoonlyn is beperk tot 'n maksimum van tien. Die verskaffing van 'n tweede aansluiting by dieselfde lyn vir 'n indiwiduele huurder en die aansluiting van ander persone as bona fide boere berus uitsluitlik by die Posmeester-generaal.

(b) *Meerpersoonstelefoonlyne (outomaties en nie-outomaties).*—Gewoonlik word nie toegelaat dat meer as tien persone by 'n nie-outomatiese meerpersoonstelefoonlyn aangesluit word nie. Die getal aansluitings op 'n outomatiese meerpersoonstelefoonlyn is beperk tot 'n maksimum van vyf. Die verskaffing van 'n tweede aansluiting by dieselfde lyn vir 'n indiwiduele huurder berus uitsluitlik by die Posmeester-generaal."

,, (b) *Meerpersoonstelefoonlyne (outomaties en nie-outomaties).*—Huurders van meerpersoonstelefoonlyndienste is aanspreeklik vir die betaling van huur vir 'n vasgestelde minimum tydperk van ses maande, gereken van die datum waarop die diens begin, met dien verstaande dat, waar diens verskaf moet word op 'n perseel waarin 'n volledige installasie bestaan, die huurder se minimum aanspreeklikheid vir huur die onverstreke gedeelte moet dek van vooroemde vasgestelde termyn van die ooreenkoms wat met die vorige huurder aangegaan is."
