

Item.	Artikel.	Korting op reg toegestaan soos hieronder aangedui.
851	Deur na subparagraaf (x) van paragraaf (13) die volgende subparagraaf by te voeg:— “(j) Nywerheid vir die afskeiding van nikkel en koper van ertse en koncentrate.....”	Tot die bedrag van die intermediere reg.”

OPMERKING.—Die uitwerking van hierdie kennisgewing is dat natriumkarbonaat, uitgesonderd kristalsoda, ingevoer of uit entrepot geneem mag word deur geregistreerde vervaardigers vir gebruik in gemelde nywerheid.

### SCHEDULE.

Item.	Article.	Duty rebated as under.
851	By the addition, after sub-paragraph (x) of paragraph (13), of the following sub-paragraph:— “(j) Industry for the extraction of nickel and copper from ores and concentrates.....”	To the extent of the intermediate duty.”

NOTE.—The effect of this notice is that sodium carbonate, excluding soda crystals, may be imported or taken out of bond by registered manufacturers for use in the industry stated.
