PRICE CONTROL.

MAXIMUM PRICES OF MILK.

Acting in terms of War Measure No. 49 of 1946, I, Heinrich Rudolph Philip August Kotzenberg, Price Controller, hereby amend, with effect from the 1st July, 1963, Government Notice No. R. 187 (maximum prices of milk) of the 14th February, 1961, as amended, as set out in the Schedule hereto.

SCHEDULE.

1. Paragraph 6 is amended by the deletion of the definition of "East London".

2. The Schedule referred to in paragraph 3 is amended by the deletion of PART C thereof.

NOTE.—The effect of this notice is the abolition of price control on fresh milk in East London.
