Under and by virtue of the powers vested in me by section *forty-four* of the Births, Marriages and Deaths Registration Act, 1963 (Act No. 81 of 1963) I do hereby declare that as from the first day of January 1964, the provisions of the said Act shall apply to the registration of births, marriages and deaths of Indians in the Province of Natal.

(1) Subject to any provision to the contrary contained in this statute, a candidate shall not be admitted to the degree of master in the faculty of arts or of science or of commerce or of social science until at least two years after admission to the ordinary degree of bachelor, or at least one year after his admission to the degree of bachelor with honours in such faculty, or in the case of the degree of master of fine art or master of education or master of law or master of music, at least one year after his admission to the degree of bachelor in such faculty."

### NATIVE BUILDING WORKERS ACT, 1951.

### TRAINING OF NATIVE BUILDING WORKERS.

I, BAREND JACOBUS SCHOEMAN, Minister of Labour, acting in terms of the powers conferred on me under sub-section (1) of section *ten* of the Native Building Workers Act, 1951 (Act No. 27 of 1951), hereinafter referred to as the Act, hereby prescribe the conditions set out hereunder for the training of natives to perform skilled work of a nature and standard required for the construction of buildings for use by natives in native areas.

1. *Requirements of Training.*—The requirements which shall be complied with by a native who desires to be trained as a learner in terms of section *ten* of the Act shall be that—

- (a) he shall not be under 18 years of age;
- (b) he shall agree to abide by the conditions prescribed in this notice;
- (c) he shall accept employment with an employer specified in the notice served in terms of sub-section (4) of section *ten* of the Act in the skilled work and under the conditions specified therein, and continue

2. Paragraaf 40 (1) word deur onderstaande paragraaf vervang:—

### WET OP NATURELLEBOUWERKERS, 1951.

### OPLEIDING VAN NATURELLEBOUWERKERS.

Ek, BAREND JACOBUS SCHOEMAN, Minister van Arbeid, handelende kragtens die bevoegdheid my verleen by sub-artikel (1) van artikel *tien* van die Wet op Naturellebouwerkers, 1951 (Wet No. 27 van 1951), hierna die Wet genoem, skryf hierby die voorwaardes voor wat hieronder uiteengesit word vir die opleiding van naturelle om geskoonde werk te verrig van 'n aard en standaard wat nodig is vir die oprigting van geboue bedoel vir naturelle in naturellegebiede.

1. *Opleidingsvereistes.*—Die vereistes waaraan 'n naturel moet voldoen wat opgelei wil word as leerling kragtens artikel *tien* van die Wet, is soos volg:—

- (a) Hy moet nie jonger as 18 jaar wees nie;
- (b) hy moet instem om die voorwaardes aan te neem wat in hierdie kennisgewing voorgeskryf word;
- (c) hy moet werk aanvaar by 'n werkgever genoem in die kennisgewing wat gedien is kragtens subartikel (4) van artikel *tien* van die Wet, in die geskoonde werk en op die voorwaardes daarin aangedui, en

in the service of that employer until he has completed the prescribed period of training or has otherwise qualified for registration as a native building worker in terms of the Act.

**2. Nature and Period of Training.**—The period of training shall be four years, of a practical nature in the skilled work specified in the notice served in terms of sub-section (4) of section *ten* of the Act and the full period thereof shall be served in the employ of an employer designated in terms of sub-section (3) of section *ten* of the Act.

**3. Variation in Period of Training.**—(1) A learner may on completion of not less than one year of his training in terms of paragraph 2 hereof, be allowed to take such test as the Minister may determine (hereinafter referred to as 'the test').

(2) If a learner is unsuccessful in any such test, he may be allowed to take another such test after he has completed a further period of training of not less than six months, and if he continues to be unsuccessful, he may be allowed to take further tests at intervals of not less than six months.

(3) If a learner is successful in the test he may, on completion of a further period of training of not less than one year, take the trade test referred to in sub-section (2) of section *eleven* of the Act (hereinafter referred to as the 'trade test'); provided that a learner shall not be accepted for a trade test except on the recommendation of his employer, or a person acting on behalf of the employer, or of an inspector.

(4) If a learner is unsuccessful in such trade test, he may be permitted to undergo further trade tests at intervals of not less than six months, in which event the proviso to sub-paragraph (3) hereof shall apply.

(5) If a native who is accepted for training has experience in skilled work, he may be granted a remission from the period of learnership of not more than two years; provided that where such remission is for a period of less than one year, he shall not be allowed to take the test until after the completion of a total period of experience of one year in the skilled work concerned, and provided further that, if the remission is for more than one year, but not more than two years, he may be allowed to take the test forthwith.

(6) Any learner who is absent from work for any period during which he is not entitled to leave under a determination made in terms of section *thirteen* of the Act, may be required to work one extra day in respect of every day of such absence before any of the periods referred to in this notice may be regarded as completed.

#### DECLARATION OF AREAS AS URBAN AREAS.

Under the powers vested in me in the definition of 'urban area' in section *one* of the Native Building Workers Act (Act No. 27 of 1951), as amended by Act No. 38 of 1953 and Act No. 60 of 1955, I, JOHANNES DE KLERK, Minister of Labour, hereby declare the following areas as urban areas for purposes of this Act, from the 16th day of May, 1958:—

#### AREAS.

(a) The area as defined by Proclamation No. 32 (Administrator's), 1952, of 13th February, 1952, published in the *Official Gazette* No. 2311 of 20th February, 1952, of the Province of Transvaal.

**2. Aard en tydperk van opleiding.**—Die opleidingstyd moet vier jaar duur, en moet prakties van aard wees in die geskoonde werk genoem in die kennisgewing gedien kragtens subartikel (4) van artikel *tien* van die Wet, en dit moet gedien word in die diens van die werkewer wat kragtens subartikel (3) van artikel *tien* aangewys is.

**3. Verkorting van opleidingstydperk.**—(1) By voltooiing van minstens een jaar van sy opleiding kragtens paragraaf 2 hiervan, kan 'n leerling toegelaat word om 'n toets wat die Minister bepaal (hierna, die toets' genoem), te ondergaan.

(2) As die leerling in so'n toets nie slaag nie, kan hy toegelaat word om 'n verdere toets af te lê nadat hy 'n bykomende opleidingstydperk van minstens ses maande voltooi het, en as hy aanhou sak, kan hy toegelaat word om verdere toetse met tussenpose van minstens ses maande af te lê.

(3) As 'n leerling in die toets slaag, kan hy na voltooiing van 'n verdere opleidingstydperk van minstens een jaar die ambagstoets afle waarna in subartikel (2) van artikel *elf* van die Wet verwys word (hierna, die ambagstoets' genoem); met dien verstande dat 'n leerling nie vir 'n ambagstoets aangeneem sal word nie, behalwe op aanbeveling van sy werkewer of 'n persoon wat namens die werkewer optree, of van 'n inspekteur.

(4) As 'n leerling in 'n ambagstoets sak, kan hy toegelaat word om verdere ambagstoetse af te lê met tussenpose van minstens ses maande, in welke geval die voorbehoud in subparagraph (3) hiervan van toepassing is.

(5) As 'n naturel wat vir opleiding aangeneem word, ervaring in geskoonde werk het, kan 'n vermindering van die leertyd van hoogstens twee jaar aan hom toegestaan word; met dien verstande dat ingeval so 'n vermindering minder as 'n jaar is, hy nie toegelaat mag word om die toets af te lê totdat hy 'n totale tydperk van ondervinding van een jaar in die betrokke geskoonde werk opgedoen het nie; voorts, as die vermindering vir meer as een jaar is maar nie vir meer as twee jaar nie, kan hy toegelaat word om die toets onmiddellik af te lê.

(6) Van 'n leerling wat afwesig is vir 'n tydperk waarin hy nie geregtig is tot afwesigheidsverlof ingevolge 'n vaststelling gemaak kragtens artikel *dertien* van die Wet nie, kan vereis word om een ekstra dag te werk ten opsigte van elke dag wat hy afwesig was, voordat enige van die tydperke in hierdie kennisgewing genoem, as voltooi beskou kan word.

The provisions of Government Notice No. 2138, dated the 16th November, 1956, are hereby withdrawn.

- (2) Exemption is granted in the Union of South Africa, excluding the Magisterial Districts of The Cape, Bellville, Wynberg and Simonstown, to—
- the occupier of a private residence in respect of the renovation, maintenance, repair or alteration (excluding the addition of one or more rooms) of the residence which he occupies (for the purposes of this exemption, the term "private residence" includes outhouses but does not include flats);
  - the occupier of a residential flat in respect of the internal renovation or maintenance of that flat;
  - the owner of a business or the person responsible for the management of an institution, in respect of the renovation or maintenance of any building used for the purpose of such business or institution, provided that—
    - this exemption shall apply only in respect of the performance of skilled work by a Native who is in the regular employ of the business or institution, and who has not been taken into employment solely to perform a specified piece of skilled work;
    - not more than one such Native may be employed on skilled work in each business or institution or branch of such business or institution; provided further that in the case of limewashing or colourwashing of walls more than one such Native may be employed on such work;
  - the owner of a business or the person responsible for the management of an institution, in respect of the application of protective anti-corrosive coatings, bituminous or other primer coats to walls, pipes, machinery, plant, installations, steel or other metal structures used for the purpose of such business or institution; provided that this exemption shall apply only in respect of the performance of such work by Natives who are in the regular employ of the business or institution and who have not been taken into employment solely to perform the application of such coatings.

## NOTE.

(a) The prohibition of the employment of Natives to do skilled building work in urban areas, is dealt with in two sections of the Act, viz. section *fourteen*, which deals exclusively with employment in the Building Industry, and section *fifteen*, which applies the prohibition to persons who are not engaged in the Building Industry.

The Building Industry is not affected by section *fifteen* or by this notice, which refers exclusively to section *fifteen*.

(b) The prohibition against the employment of Natives to do skilled building work applies only in urban areas, i.e. areas under the jurisdiction of municipal councils, borough councils, town councils, town boards, village management boards, local boards, health boards, health committees or areas which have in terms of the definition of "urban area" in section *one* of the Act been declared as urban areas by the Minister. Native areas within such urban areas are excluded.

(c) This notice provides for the following two classes of exemption from the provisions of section *fifteen*:

- Throughout the Union, work in the activities exempted by paragraph (1) of the Schedule may continue to be performed by Natives. These

(d) If European or other non-Native labour is not available to perform any building work not exempted under this notice, application for special exemption in respect of such work may be made to the nearest Divisional Inspector of Labour or Industrial Inspector. It is not intended that the prohibition should cause unnecessary hardship.

(e) The exemptions granted by this notice do not affect or modify any other law dealing with the employment of Natives or with conditions of employment.

(f) The exemptions provided for in this notice are subject to review from time to time.
