## DIAMOND CUTTING REGULATIONS.

It is hereby notified that the State President has, under the powers vested in him by section *forty-eight* of the Diamond Cutting Act, 1955 (Act No. 33 of 1955), been pleased to make the following regulations in substitution of the regulations published under Government Notice No. 2524 of 23rd December, 1955.

## ANNEXURE.

## DIAMOND CUTTING REGULATIONS.

- In these regulations, unless the context indicates otherwise, "the Act" means the Diamond Cutting Act, 1955 (Act No. 33 of 1955), and any expression to which a meaning has been assigned in that Act bears, when used in these regulations, the meaning so assigned thereto.

- An application for a licence shall be in form "A" set out in the Schedule to these regulations.

- The authority under sub-section (2) of section *twenty* of the Act, shall be in form "B" set out in the Schedule.

- A licence shall be in form "C" set out in the Schedule.

- The authority under sub-section (4) of section *twenty-four* of the Act, shall be in form "D" set out in the Schedule.

- The recognizance referred to in section *twenty-five* of the Act—

- (a) shall be in form "E" set out in the Schedule;
- (b) shall be entered into before the magistrate of the district in which the diamond cutting authorised by the licence concerned is or is to be carried on;
- (c) shall be entered into for the period of duration of the licence concerned; provided that such recognizance shall remain enforceable for a further period of three months in respect of any act referred to in paragraph (a) or (b) of section *twenty-six* of the Act, and committed by the licensee during the currency of his licence.

## REGULASIES IN VERBAND MET DIE SLYP VAN DIAMANTE.

Hierby word bekendgemaak dat dit die Staatspresident behaag het om, kragtens die bevoegdheid hom verleen by artikel *agt-en-veertig* van die Wet op die Slyp van Diamante, 1955 (Wet No. 33 van 1955), onderstaande regulasies uit te vaardig ter vervanging van die regulasies afgekondig by Goewermentskennisgewing No. 2524 van 23 Desember 1955.

## AANHANGSEL.

## REGULASIES IN VERBAND MET DIE SLYP VAN DIAMANTE.

- Tensy dit dit die samehang anders blyk, beteken „die Wet” in hierdie regulasies die Wet op die Slyp van Diamante, 1955 (Wet No. 33 van 1955), en elke uitdrukking waaraar in dié Wet 'n bepaalde betekenis toegeken is, het, wanneer dit in hierdie regulasies gebruik word, dié betekenis.

- 'n Aansoek om 'n lisensie moet opgestel word volgens vorm „A” in die Bylae van hierdie regulasies.

- Die magtiging kragtens subartikel (2) van artikel *twintig* van die Wet moet opgestel word volgens vorm „B” in die Bylae.

- 'n Lisensie moet opgestel word volgens vorm „C” in die Bylae.

- Die magtiging kragtens subartikel (4) van artikel *vier-en-twintig* van die Wet moet opgestel word volgens vorm „D” in die Bylae.

- Die borgakte wat in artikel *vyf-en-twintig* van die Wet genoem word, moet—

- (a) opgestel word volgens vorm „E” in die Bylae;
- (b) aangegaan word voor die landdros van die distrik waarin die slyp van diamante, waartoe die betrokke lisensie magtiging verleen, uitgeoefen word of uitgeoefen staan te word;
- (c) aangegaan word vir die geldigheidsduur van die betrokke lisensie; met dien verstande dat sodanige borgakte vir 'n verdere tydperk van drie maande afdwingbaar sal bly ten opsigte van enige handeling in paragraaf (a) of (b) van artikel *ses-en-twintig* van die Wet genoem, wat die gelisensieerde gedurende die geldigheidstydperk van sy lisensie begaan.

7. An application for registration by an employee or intended employee in diamond cutting shall be in form "F" set out in the Schedule.

8. A certificate of registration of an employee in diamond cutting shall be in form "G" set out in the Schedule.

9. A permit for the sale, delivery, disposal or export of unpolished diamonds in terms of sub-section (1) of section *thirty-six* of the Act, shall be in form "H" set out in the Schedule.

10. (1) (a) A note of sale and purchase or of delivery and receipt of diamonds shall be in form "I" set out in the Schedule.

(b) Such notes shall be printed and in book form and kept in numerical and chronological order.

(2) Any person who falsely completes any such note of sale and purchase or of delivery and receipt, shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred rand, or to imprisonment for a period not exceeding six months.

11. The packing and sealing for export of any fragments, crushed diamonds and diamond dust, referred to in sub-section (2) of section *thirty-six* of the Act, and of any cut or polished diamonds referred to in sub-section (1) of section *thirty-seven* of the Act, shall be in the following manner:—

(a) The diamonds shall be placed in a metal box which shall be wrapped in two coverings of linen-lined paper;

(b) the inner cover shall be sealed in the presence of the Commissioner with the seal of the exporter on several places and the address of the consignee shall be inscribed thereon;

(c) the outer cover shall bear a similar address and be tied over the box with a tape and sealed in several places with the seal of the exporter and at the end of the tape with the official seal of the Commissioner. The Commissioner shall affix his signature on the outer cover, together with the date of sealing.

11. (bis). No diamond fragment, crushed diamond, diamond powder or cut or polished diamond, referred to in Regulation 11 shall be removed or exported from the Republic of South Africa unless packed and sealed in the manner prescribed by Regulation 11 and sent by registered post.

12. (1) The record to be kept by every licensee in terms of section *thirty-eight* of the Act, of all his dealings in diamonds and of all his diamond cutting operations shall be in form "J" set out in the Schedule and the following particulars shall be recorded therein:—

(a) The dates of all purchases, receipts, sales or deliveries of diamonds;

(b) the full name and address of the consignor, consignee, purchaser or broker;

(c) the weight and price of each parcel of diamonds received and in cases of receipt other than purchases, the market value of the diamonds;

(d) the number, weight and value of all diamonds polished each month;

(e) the weight and selling value of unpolished diamonds and of polished diamonds resulting from his own diamond cutting operations, sold, exported or disposed of, with the full names and addresses of the persons to whom sold, exported or disposed of and in cases of disposals other than sales, the market value of the diamonds concerned;

(f) the number, weight and value of all polished diamonds and the number, weight and value of all unpolished diamonds on hand on the last day of each month.

7. 'n Aansoek om registrasie deur 'n werknemer of voornemende werknemer by die slyp van diamante moet opgestel word volgens vorm „F” in die Bylae.

8. 'n Registrasiesertifikaat van 'n werknemer by die slyp van diamante moet opgestel word volgens vorm „G” in die Bylae.

9. 'n Permit vir die verkoop, aflewing, van die hand sit of uitvoer van ongepolyste diamante ooreenkomsdig subartikel (1) van artikel *ses-en-dertig* van die Wet, moet opgestel word volgens vorm „H” in die Bylae.

10. (1) (a) 'n Verkoop- en koopbrief of aflewerings- en ontvangsbrief van diamante moet opgestel word volgens vorm „I” in die Bylae.

(b) Sodanige verkoop- en koopbrieve of aflewerings- en ontvangsbrieve moet gedruk en in boekvorm wees en in numeriese en chronologiese volgorde gehou word.

(2) Elkeen wat 'n verkoop- en koopbrief of aflewerings- en ontvangsbrief valslik uitskryf, is aan 'n misdryf skuldig en by skuldigbevinding strafbaar met 'n boete van hoogstens een honderd rand of gevangenisstraf vir 'n tydperk van hoogstens ses maande.

11. Die verpakking en verseling van brokstukke, fygemaakte diamante en diamantpoeier vir uitvoer wat in subartikel (2) van artikel *ses-en-dertig* van die Wet genoem word, en van geslypte of gepolyste diamante, genoem in subartikel (1) van artikel *sewe-en-dertig* van die Wet, moet op die volgende wyse geskied:—

(a) Die diamante moet in 'n metaalhouer geplaas word wat in twee omhulsels van linnekapper toegedraai moet word;

(b) die binneste omhulsel moet in die teenwoordigheid van die Kommissaris met die seël van die uitvoerder versel word, en die adres van die geadresseerde moet daarop aangebring word;

(c) die buitenste omhulsel moet ook so geadresseer, oor die houer met 'n band vasgemaak en op verskeie plekke versel word met die seël van die uitvoerder en aan die punt van die band met die offisiële seël van die Kommissaris. Die Kommissaris moet sy handtekening en die datum van verseling op die buitenste omhulsel aanbring.

11. (bis). Geen diamant, brokstuk, fygemaakte diamant, diamantpoeier of geslypte of gepolyste diamant soos in regulasie 11 bedoel, mag uit die Republiek van Suid-Afrika verwyder of uitgevoer word nie tensy dit verpak en versel is op die wyse in regulasie 11 voorgeskryf en per aangetekende pos gestuur word.

12. (1) Die aantekenings wat elke gelisensieerde ooreenkomsdig artikel *agt-en-dertig* van die Wet moet hou van al sy transaksies met betrekking tot diamante en van al sy bedrywighede met betrekking tot die slyp van diamante, moet opgestel word volgens vorm „J” in die Bylae, en die volgende besonderhede moet daarin vervat wees:—

(a) Die datums van alle aankope, ontvangste, verkope en aflewerings van diamante;

(b) die volle name en adres van die afsender, geadresseerde, koper of makelaar;

(c) die gewig en prys van elke pakkie diamante wat ontvang word en, in gevalle van ander ontvangste as aankope, die markwaarde van die diamante;

(d) die getal, gewig en waarde van alle diamante wat elke maand gepoleer is;

(e) die gewig en verkoopswaarde van ongepolyste diamante en van gepolyste diamante verkry as gevolg van sy eie diamantslypwerksaamhede, wat verkoop, uitgevoer of van die hand gesit word, met die volle name en adres van die persone aan wie verkoop, van die hand gesit of na wie uitgevoer is, en in gevalle waar dit van die hand gesit is op 'n ander wyse as deur middel van verkoop, ook die markwaarde van die betrokke diamante;

(f) die getal, gewig en waarde van alle gepoleerde diamante en die getal, gewig en waarde van alle ongepoleerde diamante voorhande op die laaste dag van elke maand.

(2) In all the above entries relating to the purchase or receipt, sale or delivery of diamonds other than polished diamonds, there shall be separately specified any stone valued at R200 or over or of a weight of 10 carats and over.

13. (1) The daily record every licensee is, in terms of section *forty-one* of the Act required to keep of all diamonds handed to and returned by each of his registered employees, shall be in form "K" set out in the Schedule.

(2) The form shall be printed and in book form and kept in numerical and chronological order.

14. (1) The daily record to be kept by a registered employee in terms of section *forty-one* of the Act, of all diamonds received from and returned by him to the licensee, shall be in form "L" set out in the Schedule.

(2) The record shall be initialed daily by the employee.

(3) The form shall be printed and in book form and kept in numerical and chronological order.
