**CENSUS OF SOCIAL WELFARE ORGANIZATIONS  
OR INSTITUTIONS.**

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to social welfare organizations or institutions in substitution for the regulations framed under the provisions of section *ten* of the Statistics Act, 1914 (Act No. 38 of 1914), as amended from time to time

tyd gewysig, en afgekondig by Goewermentskennisgewing No. 138 van 16 Januarie 1920, uitgevaardig:—

1. In hierdie regulasies, tensy uit die samehang anders blyk, het elke uitdrukking waaraan in die Wet op Statistieke, 1957, 'n betekenis geheg word, die betekenis aldus daaraan geheg, en beteken—

- (i) "boekjaar" met betrekking tot 'n maatskaplike welsynsorganisasie of -inrigting, die tydperk van twaalf maande wat deur die geldelike opgawes en state van daardie organisasie of inrigting gedek word;
- (ii) "maatskaplike welsynsorganisasie of -inrigting" enige staats-, staatsondersteunde of private organisasie of inrigting waarvan die doelstelling is om by te dra tot of onderstand, hulp, beskerming en onderdak te verskaf aan persone of diere wat in nood verkeer, behoefte het aan bystand of dakloos is en sluit in, sonder om die betekenis van die uitdrukking te beperk, organisasies of inrigtings wat die volgende is of beheer nl. 'n weeshuis, kindershuis, bewaarskool, herstellingsoord, ouetehuis of tehuis vir verswaktes, inrigting vir verstandelik vertraagdes, liggaamlik beproefde of gebrekkige persone, reddingshuis, herberg vir mans en vrouens, armetehuis en enige verwante inrigting, maar sluit nie 'n onderlinge hulpvereniging [soos omskryf in die Wet op Onderlinge Hulpverenigings, 1956 (Wet No. 25 van 1956), soos gewysig], of 'n organisasie of inrigting wat belang het by sake wat binne die bestek val van regulasies betreffende die versameling van statistieke ten opsigte van gesondheidsdienste, akkommodasiedienste en behuising, in nie.

2. Die persoon in beheer van 'n maatskaplike welsynsorganisasie of -inrigting verstrek elke jaar aan die Direkteur van Statistiek, op of voor 30 September van daardie jaar, of binne 'n verdere tydperk van verlenging van nie meer as sestig dae nie soos deur die Direkteur toegestaan mag word, 'n opgawe op 'n vorm wat ten opsigte van die betrokke maatskaplike welsynsorganisasie of -inrigting en van die boekjaar of enige gedeelte daarvan wat gedurende die tydperk 1 Julie van die vorige jaar tot en met 30 Junie van daardie jaar geëindig het, die gevraagde besonderhede en inligting aandui soos uiteengesit in regulasie 3. Die inligting word verstrek op 'n vorm wat die Direkteur aan hom uitreik.

3. Die volgende besonderhede en inligting moet in die opgawe gemeld in regulasie 2, verstrek word:—

- (i) Naam en adres van organisasie of inrigting.
- (ii) Beskrywing van werksaamhede van organisasie of inrigting en deur wie beheer.
- (iii) Boekjaar deur die opgawe gedek.
- (iv) Getal voltydse en deeltydse werknemers soos op 30 Junie ingedeel volgens ras, geslag en beroepsgroep.
- (v) Salarisse, lone en toelaes aan voltydse en deeltydse werknemers gedurende die maand Junie betaal, ingedeel volgens ras, geslag en beroepsgroep.
- (vi) Getal inwonendes of persone wat bystand ontvang het, persone toegelaat en ontslaan, ingedeel volgens ras, geslag en ouderdomsgroepe.
- (vii) Inkomste en uitgawes gedurende die boekjaar.
- (viii) Kapitaaluitgawes gedurende die boekjaar.
- (ix) Opsomming van bates en laste aan die einde van die boekjaar.

4. Enige persoon wat, sonder redelike oorsaak, versuim om aan die bepalings van regulasie 2 te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand of, in die geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur.

and published under Government Notice No. 138 of the 16th January, 1920:—

1. In these regulations, unless the context otherwise indicates, any expression to which a meaning is assigned in the Statistics Act, 1957, has the meaning so assigned thereto, and—

- (i) "financial year" means, in relation to a social welfare organization or institution, the period of twelve months covered by the financial returns and statements of that organization or institution;
- (ii) "social welfare organization or institution" means any Government, State-aided or private organization or institution, the object of which is to afford or contribute towards the relief, assistance, protection, or shelter to persons or to animals who are in distress, in need of succour, or homeless, and shall include, without limiting the scope of the term, organizations or institutions which are or conduct an orphanage, children's home, crèche, home for convalescent, aged or infirm persons, institution for mentally retarded, physically afflicted or handicapped persons, rescue home, shelter for men and women, almshouse and any kindred institution, but shall not include a friendly society [as defined in the Friendly Societies Act, 1956 (Act No. 25 of 1956), as amended], or an organization or institution concerned with matters falling within the scope of regulations governing the collection of statistics relating to health services, accommodation services and housing.

2. The person in charge of a social welfare organization or institution shall each year render to the Director of Statistics, Pretoria, on or before 30th September of that year, or within a further period of extension not exceeding sixty days as may be granted by the Director, a return on a form indicating the particulars and information required as set out in regulation 3, in respect of such social welfare organization or institution and for its financial year or any part thereof which ended during the period 1st July of the previous year up to and including 30th June of that year. The information shall be furnished on a form which the Director will issue to him.

3. The following particulars and information shall be furnished in the return referred to in regulation 2:—

- (i) Name and address of organization or institution.
- (ii) Description of activities of organization or institution and by whom controlled.
- (iii) Financial year covered by return.
- (iv) Number of full-time and part-time employees as at 30th June classified according to race, sex and occupational group.
- (v) Salaries, wages and allowances paid to full-time and part-time employees during the month of June, according to race, sex and occupational group.
- (vi) Number of residents or persons assisted, admissions and discharges, according to race, sex and age groups.
- (vii) Revenue and expenditure during the financial year.
- (viii) Capital expenditure during the financial year.
- (ix) Summary of assets and liabilities as at the end of the financial year.

4. Any person who, without reasonable cause, fails to comply with the requirements of regulation 2, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

## SENSUS VAN WOL- EN BOKHAARVOORRADE.

Die Staatspresident het kragtens die bepalings van artikel *twalf* van die Wet op Statistieke, 1957 (Wet No. 73 van 1957), die volgende regulasies in verband met die versameling van statistieke ten opsigte van wol- en bokhaarvoorrade ter vervanging van die regulasies opgestel kragtens artikel *tien* van die "Statistieke Wet", 1914 (Wet No. 38 van 1914), soos van tyd tot tyd gewysig, en afgekondig by Goewermenskennisgewing No. 885 van 15 Mei 1942, uitgevaardig:—

1. Elke persoon in die Republiek van Suid-Afrika wat die eienaar of bestuurder is van of iemand anders wat belas is met die toesig oor 'n pakhuis waar wol en/of bokhaar opgeberg word, moet binne vier dae na die end van elke maand, op 'n vorm soos in die Bylae hieronder uiteengesit wat hy van die Direkteur van Statistiek, Pretoria, moet verkry, 'n opgaaf verstrek aan die Direkteur van Statistiek, Pretoria, van die hoeveelheid en soort wol en/of bokhaar wat op die laaste dag van die maand in sodanige pakhuis in voorraad was.

Enige persoon van wie 'n opgawe kragtens hierdie regulasies vereis word en wat, sonder redelike oorsaak, versuim om daaraan te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand of, in geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur.

Die Staatspresident het kragtens die bepalings van artikel *twalf* van die Wet op Statistieke, 1957 (Wet No. 73 van 1957), die volgende regulasies in verband met 'n jaarlikse versameling van statistieke ten opsigte van die visnywerheid ter vervanging van die regulasies afgekondig by Goewermenskennisgewing No. 979 van 1 November 1961, uitgevaardig:—

1. Vir die toepassing van hierdie regulasies beteken—  
 "vervaldatum" 31 Oktober van enige besondere jaar;  
 "vis" enige soort seevis of seesoogdier, en sluit in walvisse, robbe, seevarke, waterskilpaaie, skulpvisse, oesters, skubdiere, seewurms en askideë, en die eiers, broeisels of kleintjies, of enige gedeelte van vis, soos hierin omskryf;

## CENSUS OF STOCKS OF WOOL AND MOHAIR.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to stocks of wool and mohair, in substitution for the regulations framed under the provisions of section *ten* of the Statistics Act, 1914 (Act No. 38 of 1914), as amended from time to time, and published under Government Notice No. 885, dated the 15th May, 1942:—

1. Every person in the Republic of South Africa who is the owner or manager or other person in charge of any warehouse where wool and/or mohair is stored shall render to the Director of Statistics, Pretoria, within four days of the end of each month, on a form as set forth in the Schedule hereto, which he shall obtain from the Director of Statistics, Pretoria, a return furnishing the quantity and class of wool and/or mohair in stock in such warehouse on the last day of the month.

2. Any person of whom a return is required in terms of these regulations who, without reasonable cause, fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

## CENSUS OF THE FISHING INDUSTRY.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to an annual collection of statistics relating to the fishing industry in substitution of the regulations promulgated under Government Notice No. 979 of the 1st November, 1961:—

1. For the purpose of these regulations—

"due date" means the 31st October of any particular year;

"fish" means any species of sea fish or sea mammal and includes whales, seals, porpoises, turtles, shellfish, oysters, crustaceans, sea worms and ascidians and the spawn, eggs, brood or young, or any part of fish, as herein defined;

"visserij" die kommersiële vang, neem, jag en versameling van vis in see- en kuswaters, waters weg van die kus en binnelandse waters of kunsmatige damme. Dit sluit die in bedryf hou van oesterbeddings, visbroeiplekke en visdamme in;

"visserboot" enige boot wat gebruik word om vis te vang vir handelsdoeleindes;

"vishawe" enige plek langs die kus vanwaar vissersbote uitgaan;

"operateur" die persoon of onderneming vir wie se voordeel die visbedryf onderneem word;

"eienaar" die persoon of onderneming op wie se naam die vissersboot geregistreer is;

"kaptein" die persoon in beheer van 'n vissersboot en kan die operateur soos omskryf, of sy werknemer of die huurder van 'n boot wees;

"kontroleur" in die geval van 'n vishawe waar 'n amptenaar van die Afdeling Visserie gestasioneer is, die verantwoordelike amptenaar, en in die geval van 'n vishawe waar geen amptenaar van die Afdeling Visserie gestasioneer is nie, die amptenaar in bevel van die naaste polisiekantoor of -pos.

2. Die eienaar of operateur van enige vissersboot moet, op of voor die vervaldatum, 'n opgawe verstrek vir die jaar geëindig 30 Junie wat die vervaldatum onmiddellik voorafgaan, met dien verstande dat indien die eienaar of operateur se boekjaar op 'n ander datum as 30 Junie eindig, die opgawe verstrek moet word ten opsigte van die boekjaar wat die vervaldatum onmiddellik voorafgaan. In so 'n opgawe moet hy al die gegewens verstrek wat in die aanhangsel hiervan uiteengesit is, of soveel van die gegewens as wat deur die Direkteur van Statistiek verlang word en wat uiteengesit is op 'n vorm deur die Direkteur uitgereik. Die vorm vir die doel van die verstrekking van die opgawe kan op mondelinge of skriftelike aansoek van 'n kontroleur of van die Direkteur van Statistiek, Pretoria, verkry word.

3. Die eienaar of operateur moet die opgawe aan die kontroleur van die Sensus adresseer en dit aflewer of pos aan die kontroleur of adresseer en pos aan die Direkteur van Statistiek, Pretoria.

4. Enige eienaar of operateur wat, sonder redelike oorsaak, versuim om aan hierdie regulasies te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand of, in die geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur.

"fishing" means the commercial catching, taking, hunting and gathering of fish in ocean, coastal, off-shore and inland waters or artificial dams. It includes the operation of oyster beds, fish hatcheries and fishing preserves;

"fishing boat" means any vessel used for the catching of fish for purposes of trade;

"fishing harbour" means any place along the coast from which fishing boats operate;

"operator" means the person or concern for whose benefit the business of fishing is carried on;

"owner" means the person or concern in whose name a fishing boat is registered;

"skipper" means the person in charge of a fishing boat, and may be the operator as defined or his employee or the renter of a boat;

"supervisor" means, in the case of a fishing harbour where an officer of the Division of Fisheries is stationed, the officer in charge, and in the case of a fishing harbour where no officer of the Division of Fisheries is stationed, the officer in charge of the nearest police station or post.

2. The owner or operator of any fishing boat shall on or before due date render a return for the year ending 30th June immediately preceding the due date, provided that if the financial year of any owner or operator ends on a date other than 30th June, the return shall be rendered in respect of the financial year immediately preceding the due date. In such a return he shall furnish all the information detailed in the Annexure hereto, or so much of such information as may be required by the Director of Statistics and set out on a form issued by the said Director. The form for the purpose of rendering the return may be obtained on verbal or written application, from a supervisor or from the Director of Statistics, Pretoria.

3. The owner or operator shall address such return to the supervisor of the Census and deliver or post it to the supervisor, or address and post it to the Director of Statistics, Pretoria.

4. Any owner or operator who, without reasonable cause, fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to reply therewith, to a fine not exceeding two rand for every day during which such failure continues.

## STATISTICS ACT, 1957.

## STATISTICS ON WHOLESALE, RETAIL AND MOTOR TRADE INSTITUTIONS AND ON SERVICE ESTABLISHMENTS AND INSTITUTIONS.

I, THEOPHILUS EBENHAEZER DÖNGES, Minister of the Interior, under the powers vested in me by sub-section (1) of section two of the Statistics Act, 1957 (Act No. 73 of 1957), do hereby declare that statistics may be collected—

- (a) from establishments and institutions in connection with the wholesale, retail and motor trade; and
- (b) in connection with services, including professional, catering, accommodation, entertainment, amusement, recreation, sporting and cultural institutions.

the provisions of section *ten* of the Statistics Act, 1914 (Act No. 38 of 1914), as amended from time to time, and published under Government Notice No. 297, dated the 20th February, 1942:—

1. Every person in the Republic of South Africa who is the occupier, owner or caretaker of, or the agent for any dwelling shall, within seven days of the service upon him of a form under these regulations, render on such form and in respect of such period as may be determined by the Director of Statistics, Pretoria, to the said Director or to an officer authorised thereto in writing by him, a return containing the particulars and information prescribed in regulation 2 hereof, in respect of the dwelling occupied or owned by him, or in respect of which he is the caretaker or agent.

2. The following shall be the matters which may be prescribed in the form of return, required under these regulations:—

The address of the dwelling; the type of dwelling (house or flat); the number of rooms therein; materials of which outer walls are built; the monthly rental of such dwelling if rented; the name, race and business, trade, profession or calling of the occupier; the number of persons ordinarily resident in such dwelling; the number of domestic servants employed, and the wages in cash and kind paid to them.

3. Any person of whom a return is required in terms of these regulations who, without reasonable cause, after service upon him of such a form, fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand, or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

#### COLLECTION OF STATISTICS RELATING TO CULTURAL INSTITUTIONS.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to cultural institutions, as prescribed by Government Notice No. 420 of the 21st March, 1958, in substitution for the regulations framed under the provisions of section *ten* of the Statistics Act, 1914 (Act No. 38 of 1914), as amended from time to time, and published under Government Notice No. 1787 of the 28th December, 1917:—

1. In these regulations, unless the context otherwise indicates, any expression to which a meaning is assigned in the Statistics Act, 1957, has the meaning so assigned thereto, and—

- (i) "financial year" means, in relation to a cultural institution, the period of twelve months covered by the financial returns and statements of that institution;
- (ii) "cultural institution" means any art gallery, museum, botanical garden, zoological garden, aquarium, flora and fauna reserve, natural and historical monument, national monument, library and kindred institution to which the public has access.



2. The person in charge of a cultural institution shall each year render to the Director of Statistics, Pretoria, on or before the 30th September of that year, or within a further period of extension not exceeding sixty days as may be granted by the Director, a return on a form furnishing the particulars and information required as set out in regulation 3, in respect of such cultural institution and for its financial year, or any part thereof, which ended during the period 1st July of the previous year up to and including 30th June of that year, except in the case of a library for which the dates shall be 31st October, 1st August and 31st July, respectively. The information shall be furnished on a form which the Director will issue to him.

3. The following particulars and information shall be furnished in the return referred to in regulation 2:—

(a) In the case of a library:—

- (i) Name and address of library;
- (ii) whether affiliated to the Provincial Library Service or not;
- (iii) financial year covered by the return;
- (iv) by whom controlled;
- (v) number of branch libraries, depots and travelling library units, according to race served;
- (vi) number of registered borrowers, according to race;
- (vii) book stock of own books and books of Provincial Library Service, according to race served;
- (viii) circulation of books, according to language in which books are written and according to race served;
- (ix) number of full-time and part-time employees as at 30th June, classified according to race, sex and occupational group;
- (x) salaries, wages and allowances paid to full-time and part-time employees during the month of June, according to race, sex and occupational group;
- (xi) revenue and expenditure during the financial year;
- (xii) capital expenditure during the financial year;
- (xiii) summary of assets and liabilities as at the end of the financial year.

(b) In the case of other cultural institutions:—

- (i) Name and address of institution;
- (ii) financial year covered by the return;
- (iii) by whom controlled;
- (iv) number of visitors during the financial year;
- (v) number of full-time and part-time employees as at 30th June, classified according to race, sex and occupational group;
- (vi) salaries, wages and allowances paid to full-time and part-time employees during the month of June, according to race, sex and occupational group;
- (vii) revenue and expenditure during the financial year;
- (viii) capital expenditure during the financial year;
- (ix) summary of assets and liabilities as at the end of the financial year.

4. Any person in charge of a cultural institution who, without reasonable cause, fails to comply with the requirements of these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

1. Vir die toepassing van hierdie regulasies bestaan die motorhandel uit: Algemene garages, garages (alleen gebruikte motors), diensstasies, motorbegravinge, handelaars in dele en bybehore (groot- en kleinhandel), groot-handeldistribueerders van motorvoertuie, kleinhandelaars in motorbuitende, onderdakparkeergarages en ander motorhandelinrigtings.

2. ## REGULATIONS.

## COLLECTION OF STATISTICS RELATING TO THE MOTOR TRADE.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to the motor trade, as prescribed by Government Notice No. 420 of the 21st March, 1958, in substitution for the regulations promulgated under Government Notice No. 980 of the 10th November, 1961:—

1. For the purpose of these regulations the motor trade comprises: General garages, garages (used cars only), service stations, motor graveyards, parts and accessory dealers (wholesale and retail), wholesale distributors of motor vehicles, retail tyre dealers, covered parking garages and other motor trade establishments.

2. (a) The person in charge of a motor trade establishment shall each year on or before the 31st day of October, or on or before such later date as the Director of Statistics may for good cause allow, render on a form or forms which may be obtained from the Director of Statistics, Pretoria, a return or returns which he shall sign and certify as being correct, containing all the particulars and information prescribed in regulation 4 in respect of the period defined in regulation 3.

(b) For the purpose of these regulations the person in charge of a motor trade establishment shall be—

(i) any person who during the period defined in regulation 3 owned a motor trade establishment; provided that a return or returns referred to in paragraph (a) may also be accepted from a person who was commissioned by such owner with the supervision, control, administration, direction or management of the affairs of such establishment, as the case may be;

(ii) a trustee or liquidator or an executor or administrator of an insolvent or deceased estate, or a liquidator of a company or co-operative society or co-operative company in liquidation, or a judicial manager of a company under judicial management which owned a motor trade establishment during the period defined in regulation 3.

3. The period which shall be covered by the return or returns is the financial year which ended on any date during the twelve months from 1st July to 30th June.

4. The following particulars and information shall be furnished in the return or the returns referred to in regulation 2:—

- (1) Financial year covered by return.
- (2) Magisterial district in which the establishment is situated.
- (3) Trading and registered name, address and post office box (if any) of the establishment.
- (4) Name of proprietor or manager.
- (5) Whether the establishment is an individual, a partnership, private limited liability company, public limited liability company, co-operative society or company, a municipal or government concern or any other body.
- (6) If the establishment is individual or a partnership, the race of the owner(s) or, if private limited liability company, the race of the financial controlling shareholders.



- (7) Naam en adres van die hoofkantoor waarvan die inrigting 'n tak is.
- (8) Of die inrigting petrol van een of meer handelsmerke (bevoorregte merke uitgesonderd) verkoop.
- (9) Getal petrol- en dieselpompe.
- (10) Getal, volgens ras en geslag, werkende eienaars, vennote en gesinsassistenten.
- (11) Totale getal persone in diens op die laaste betaaldag in September en die werklike bedrag aan salarisse en lone vir Septembermaand uitbetaal en 'n ontleding van beroep volgens ras en geslag.
- (12) Koste van betalings in natura (as daar verskaf is) toegeken aan werknemers (uitgesonderd werkende eienaars) ingestel volgens ras en geslag vir die maand September.
- (13) Ontleding en totaal van aankope en oorplasings- in volgens soort artikel en vorderings ten opsigte van werk verrig deur ander herstellingsinrigtings (insluitende reserwedele aangebring en materiaal gebruik).
- (14) Ontleding en totaal van verkope en oorplasings- uit volgens soort artikel, vorderings ten opsigte van werk verrig (herstelwerk en dienste, met inbegrip van reserwedele aangebring en materiaal gebruik), waarde van uitrusting en ander goedere vervaardig en gekapitaliseer en ander inkomste.
- (15) Inligting oor werkwinkelbedryf (a) waarde van vooraflewerings- en gratis dienste ten opsigte van motorvoertuie, (b) die opknapping van voertuie self gebruik.
- (16) Ontleding van totale verkope volgens tipe klant.
- (17) Verkope van motorbrandstof.
- (18) Waarde van voorrade nuwe en gebruikte motorvoertuie en trekkers, reserwedele en bybehore, met inbegrip van gereedskap en garage-uitrusting, brandstof en smeerolies, werk aan die gang, eie fabrikate en enige ander, soos aan die begin en einde van die boekjaar.
- (19) Ontleding en totaal van uitgawes (salarisse en lone aan die werknemers gedurende die boekjaar uitbetaal, besturende direkteur se besoldiging, waardevermindering op vaste eiendom, masjinerie en uitrusting, huurgelde betaal, slegte skulde, koste van elektriese krag en lig, hoofkantooruitgawes en alle ander).
- (20) Opsomming van totaal van die inkomste en uitgawes van die inrigting met opgawe van die netto wins of verlies.
- (21) Balansstaat, aandeelkapitaal, ontleding en totaal van kapitaaluitgawes, rente en dividende ontvang, rente op lenings en skuldbriewe betaal.
- (22) Wins of verlies voor voorsiening gemaak is vir inkomstebelasting en uitgesonderd rente en dividende ontvang ten opsigte van die boekjaar en die vorige boekjaar.
- (23) Winsverdeling vir die jaar (alleen maatskappye), dividende verklaar en voorsiening vir inkomstebelasting.

5. Indien die inrigting 'n tak is, het die inligting in paragrawe (21) tot (23) van regulasie 4 alleen betrekking op die onderneming waarvan die inrigting 'n tak is.

6. Die persoon in beheer van 'n motorhandelinrigting wat sonder redelike oorsaak versuim om aan hierdie regulasies te voldoen, begaan 'n misdryf en is by skuldigebevinding strafbaar met 'n boete van hoogstens vyftig rand of, in die geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur.

Die persoon in beheer van 'n motorhandelinrigting word nie van hierdie strafbepalings onthef slegs omdat hy geen vorm of vorms ontvang het om die opgawe of opgawes genoem in paragraaf (a) van regulasie 2 in te dien nie. Die Direkteur van Statistiek kan, indien hy dit raadsaam ag, 'n vorm of vorms laat aflewer of per pos afstuur aan die persoon in beheer van 'n motorhandelinrigting.

- (7) Name and address of the head office of which the establishment is a branch.
- (8) Whether the establishment sells one or more petrol brands (excluding privileged brands).
- (9) Number of petrol and diesel pumps.
- (10) Number, by race and sex, of working proprietors, partners and family assistants.
- (11) Total number of persons employed on the last pay-day in September, and the actual amount of salaries and wages paid for the month of September, and analysis of occupation by race and sex.
- (12) Cost of payments in kind (if provided) assigned to employees (excluding working proprietors) classified by race and sex for the month of September.
- (13) Analysis and total purchases and transfers-in by kind of article and charges for work done by other repairs service establishments (including spares fitted and materials used).
- (14) Analysis and total sales and transfers-out by kind of article, charges for work done (repairs and services including spares fitted and materials used), value of equipment and other goods manufactured and capitalised and other revenue.
- (15) Information regarding workshop operations, (a) value in respect of pre-delivery and free services on vehicles, and (b) in respect of reconditioning of own used vehicles.
- (16) Analysis of total sales according to class of customer.
- (17) Sales of motor spirit.
- (18) Value of stocks of new and used motor vehicles and tractors, spares and accessories, including tools and garage equipment, fuel and lubricants, work in progress, own manufactures and any other, as at the beginning and end of the financial year.
- (19) Analysis and total of expenditure (salaries and wages paid to the employees during the financial year, managing director's remuneration, depreciation on fixed property, plant and equipment, rent paid, bad debts, cost of power and light, head office expenses and all other).
- (20) Summary of total establishment's revenue and expenditure as well as the net profit or loss.
- (21) Balance sheet, share capital, analysis and total of capital expenditure, interest and dividends received, interest paid on loans and debentures.
- (22) Profit or loss before provision for income tax and excluding interest and dividends received, relating to the financial year and the previous financial year.
- (23) Appropriation for the year (companies only), dividends declared and income tax provision.

5. If the establishment is a branch the information referred to in paragraphs (21) to (23) of regulation 4 shall relate only to the undertaking of which the establishment is a branch.

6. The person in charge of a motor trade establishment who, without reasonable cause, fails to comply with these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues. The person in charge of a motor trade establishment shall not be relieved of these penalties by reason only of his not having received a form or forms to furnish the return or returns referred to in paragraph (a) of regulation 2. The Director of Statistics may, if he deems it advisable, cause a form or forms to be delivered or sent by post to the person in charge of a motor trade establishment.

3. Die volgende besonderhede en inligting moet in die opgawevorm in regulasie 2 genoem, uiteengesit word:—

- (a) Die soort artikel of diens soos gespesifiseer in die Aanhangsel hiervan wat verkoop of gelewer word.
- (b) Die pryse waarteen sodanige artikels verkoop word volgens gespesifiseerde hoeveelheid, kwaliteit en handelsmerk van artikel, en die pryse waarteen sodanige dienste gelewer word.
- (c) Enige prysverhoging of -verlaging in vergelyking met besonderhede van pryse verstrek vir enige voorafgaande tydperk en die redes daarvoor.

4. Enige persoon van wie 'n opgawe kragtens hierdie regulasies verlang word en wat, nadat sodanige vorm aan hom bestel is, sonder redelike oorsaak versuim om aan hierdie regulasies te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand of, in geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur.

## REGULATIONS.

## COLLECTION OF STATISTICS RELATING TO PRICES OF COMMODITIES AND SERVICES.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to prices of commodities and services in substitution for the regulations published under Government Notice No. 799, dated the 6th June, 1958:—

1. For the purpose of these regulations an establishment or institution is one which sells commodities wholesale or retail or which renders services to or for persons.

2. The person in charge of any establishment or institution in the Republic of South Africa shall, after service upon him of a form under these regulations, render on such form to the Director of Statistics, Pretoria, or to an officer authorised thereto in writing by the said Director, a return containing the relevant particulars and information prescribed in regulation 3 hereof in respect of the commodities and services sold or rendered. Such return shall be rendered on or before the 7th of each month, or on or before the 7th of the month for which the return is required.

3. The following shall be the particulars and information set out in the form referred to in regulation 2:—

- (a) The type of commodity or service specified in the Annexure hereto sold or rendered.
- (b) The prices at which such commodities are sold, according to specified quantity, quality and brand of commodity, and the prices at which such services are rendered.
- (c) Any increases or decreases in such prices compared with particulars of prices rendered for any preceding period and the reasons therefor.

4. Any person of whom a return is required in terms of these regulations who, without reasonable cause, after service upon him of such form, fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

## REGULATIONS.

## COLLECTION OF INDUSTRIAL STATISTICS.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of current monthly, quarterly or half-yearly statistics relating to industrial production and related economic indicators in respect of the industrial sector of the Republic of South Africa in substitution for the regulations promulgated under Government Notice No. R. 1682 of the 14th October, 1960:—

1. For the purpose of these regulations, a factory or productive industry shall be—

- (a) any premises used for or in connection with—
  - (i) the manufacture, processing, making, preparing or packing of goods or commodities;
  - (ii) the slaughtering of animals and killing of poultry, rabbits and small game;
  - (iii) construction, demolition, excavation, installation assembly, completion, repair and other work;
  - (iv) the cleaning or dyeing of any article of textile fabric;
  - (v) the collection and purification of water and its distribution to domestic and industrial consumers;
  - (vi) the disposal of garbage and sewage;
- (b) any premises in which administrative, clerical, sales, research or other activities directly related to any activity referred to in (a) are performed.

2. Notwithstanding the provisions of regulation 1 hereof, a factory or productive industry shall not include—

- (a) premises where alteration, sorting, grading, assembling, packing, freezing, chilling or storage is performed only incidentally to the conduct of wholesale or retail commercial distributive trade and production on farms;
- (b) private houses, hotels, boarding-houses, restaurants, refreshment or tearooms or eating-houses, in respect of any activity referred to in regulation 1 which is ordinarily and necessarily incidental to the conduct of such establishments.

3. The person in charge of a factory or productive industry in the Republic shall, after having been requested thereto in writing by the Director of Statistics, each month within ten days of the end of the preceding calendar month or the preceding accounting month of the industrial establishment, if such account month ends before the last day of a calendar month, as the case may be, or on or before such later date as the Director of Statistics may for good cause allow, render on a form or forms which may be obtained from the Director of Statistics, Pretoria, a return or returns furnishing the particulars and information prescribed in regulation 5 in respect of such industrial establishment for such preceding calendar month or preceding accounting month: Provided that the Director of Statistics may direct that any of the particulars and information prescribed in regulation 5 be furnished for each quarter or half-year within ten days of the end of the last calendar month in the quarter or half-year concerned or before such later date as the Director of Statistics may for good cause allow. Such return or returns shall be completed, signed, dated, addressed and posted to the Director of Statistics, Pretoria.

- (ii) a trustee or liquidator, or an executor or administrator of an insolvent or deceased estate or a liquidator of a company or co-operative society or co-operative company in liquidation, or a judicial manager of a company under judicial management which owned a factory or productive industry during the period defined in regulation 3.

5. The following shall be the matters prescribed in the return required under these regulations:—

- (1) Registered or trading name.
- (2) Business address.
- (3) Period covered by the return.
- (4) Description, quantity and selling value at works of manufactures produced and work done.
- (5) Description, quantity and cost of material used.
- (6) Description, quantity and value of sales or deliveries.
- (7) Description, quantity and value of new orders.
- (8) Description, quantity and value of unfulfilled orders.
- (9) Description, quantity and value of stocks.
- (10) Actual and anticipated capital expenditure on dwellings, non-residential buildings, other construction and works, transport equipment, machinery and other equipment.
- (11) Profit or loss.
- (12) Receipt and payment of interest, rent and dividends.
- (13) Taxes paid.
- (14) Details of production, capacity and related matters.
- (15) Capacity and business address of the signatory.

6. Any person of whom a return is or returns are required in terms of these regulations who, without reasonable cause fails to comply therewith, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues. Such person shall not be relieved of these penalties by reason only of his having received no form or forms to furnish the return or returns described in regulation 5; the Director of Statistics may, if he deems it advisable, cause a form or forms to be delivered or sent by post to the person in charge of an industrial establishment.

(ii) 'n trustee of likwidateur of 'n eksekuteur of administrateur van 'n insolvente of bestorwe boedel, of 'n likwidateur van 'n maatskappy of koöperatiewe vereniging of koöperatiewe maatskappy in likwidasie, of 'n geregtelike bestuurder van 'n maatskappy onder geregtelike bestuur wat die eienaar van 'n fabriek of produktiewe nywerheid was gedurende die tydperk in regulasie 3 omskryf.

gated under Government Notice No. 1811 of the 22nd November, 1957, and (b) the regulations framed under the provisions of section *ten* of the Statistics Act, 1914 (Act No. 38 of 1914), as amended from time to time, and published under Government Notice No. 616 of the 24th March, 1950:—

1. For the purpose of these regulations, a factory or productive industry shall be—

(a) any premises used for or in connection with—

- (i) the manufacture, processing, making, preparing or packing of goods or commodities;
- (ii) the slaughtering of animals and killing of poultry, rabbits and small game;
- (iii) construction, demolition, excavating, installation, assembly, completion, repair and other work;
- (iv) the cleaning or dyeing of any article of textile fabric;
- (v) the collection and purification of water and its distribution to domestic and industrial consumers;
- (vi) the disposal of garbage and sewage.

(b) any premises in which administrative, clerical, sales, research or other activities directly related to any activity referred to in (a) are performed.

2. Notwithstanding the provisions of regulation 1 hereof, a factory or productive industry shall not include—

(a) premises where alteration, sorting, grading, assembling, packing, freezing, chilling or storage is performed only incidentally to the conduct of wholesale or retail commercial distributive trade and production on farms;

(b) private houses, hotels, boarding-houses, restaurants, refreshment or tearooms or eating-houses, in respect of any activity referred to in regulation 1 which is ordinarily and necessarily incidental to the conduct of such establishments.

3. The person in charge of a factory or productive industry in the Republic of South Africa shall each year on or before the 30th September of that year or on or before such later date as the Director of Statistics may for good cause allow, render on a form or forms which may be obtained from the Director of Statistics, Pretoria, a return or returns furnishing all the particulars and information prescribed in regulation 5 hereof in respect of such factory or productive industry for the preceding period 1st July to 30th June or in respect of the preceding business or financial year which ended on any date between 1st July and 30th June.

4. For the purpose of these regulations, the person in charge of a factory or productive industry shall be—

(i) any person who, during the period defined in regulation 3, owned a factory or productive industry: Provided that a return or returns referred to in regulation 3 may also be accepted from a person who was commissioned by such owner with the supervision, control, administration, direction or management of the affairs of such a factory or productive industry, as the case may be;

(ii) a trustee or liquidator or an executor or administrator of an insolvent or deceased estate, or a liquidator of a company or co-operative society or co-operative company in liquidation, or a judicial manager of a company under judicial management which owned a factory or productive industry during the period defined in regulation 3.

5. The following shall be the matters prescribed in the return required under these regulations:—

- (1) Trading name.
- (2) Business address.
- (3) Address of factory or productive industry.
- (4) Name and residential address of proprietor.
- (5) Whether individual, partnership, private limited liability company, public limited liability company, public corporation, co-operative society, co-operative company, municipality, government.
- (6) If an individual or partnership, the race of the owner(s) or, if a private limited liability company, the race of the financial controlling shareholders.
- (7) Name and address of head office, and various activities of the firm administered by the head office.
- (8) Names and addresses of branch factories.
- (9) Name, address and principal activities of parent or holding company.
- (10) Names, addresses and principal activities of subsidiary companies.
- (11) Date when factory or productive industry first commenced operations.
- (12) Nature of activities, including particulars of ancillary services undertaken.
- (13) Business or financial year covered by return.
- (14) Number of persons employed (working proprietors, including unpaid family assistants, production and related workers, maintenance and repair workers, sales and delivery personnel and all other employees, including executive managing directors, accountants and other administrative and clerical personnel as well as research personnel), classified according to race and sex.
- (15) Actual man-hours worked by production and related workers.
- (16) Amount of salaries, wages and allowances, including the value of rations and quarters, if provided, paid to employees (production and related workers, maintenance and repair workers, sales and delivery personnel and all other employees, including executive managing directors, accountants and other administrative and clerical personnel, as well as research personnel) classified according to race and sex.
- (17) Employers' contributions to Unemployment Insurance Fund, Workmen's Compensation Fund, Native Services Levy Fund, Sick/Medical Benefit Fund, Pension Fund, Holiday Fund and Provident Fund.
- (18) Net value of fixed assets, capital expenditure, depreciation, rent paid, value of fixed assets sold and adjustment in value of fixed assets.
- (19) Mechanical power employed, number of engines and horsepower.
- (20) Quantity and cost of fuel, light and power and water purchased or used.
- (21) Quantity and value of electricity and gas produced, and water obtained from own waterworks.
- (22) Description, quantity and cost of materials as well as consumable stores and other stores, purchased, transferred-in or used.
- (23) Analysis of purchases and transfers-in according to source.

Die persoon in beheer van 'n fabriek of produktiewe nywerheid wat sonder redelike oorsaak versuim om aan hierdie regulasies te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand of, in die geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur. Die persoon in beheer van 'n fabriek of produktiewe nywerheid word nie van hierdie strafbepalings onthef nie, slegs omdat hy geen vorm of vorms ontvang het nie om die opgawe of opgawes, omskryf in regulasie 3, in te dien; die Direkteur van Statistiek kan, indien hy dit goeddink, 'n vorm of vorms laat aflewer of per pos versend aan die persoon in beheer van 'n fabriek of produktiewe nywerheid.

## **REGULASIES.**

### **VERSAMELING VAN STATISTIEKE BETREFFENDE VAKVERENIGINGS, WERKGEWERS-ORGANISASIES, NYWERHEIDSRADE EN BESIGHEIDS-, BEROEPS-, PROFESSIONELE EN ANDER SOORTGELYKE VERENIGINGS.**

Die Staatspresident het kragtens die bepalinge van artikel twaalf van die Wet op Statistieke, 1957 (Wet No. 73 van 1957), die volgende regulasies uitgevaardig in verband met die versameling van statistieke betreffende vakverenigings, werkgewersorganisasies, nywerheidsrade en besigheids-, beroeps-, professionele en ander soortgelyke verenigings ter vervanging van die regulasies afgekondig by Goewermentskennisgewing No. 982 van 10 November 1961: —

1. Die sekretaris van elke vereniging of organisasie genoem in paragrawe A, B, C en D van regulasie 2 hiervan, moet binne die tydperk voorgeskryf en ten opsigte van die tydperk wat in die onderskeie regulasies bepaal word, aan die Direkteur van Statistiek, Pretoria, of aan 'n beampte wat skriftelik deur hom daartoe gemagtig is, 'n opgawe verstrek, geteken en korrek gesertifiseer deur die sekretaris, wat al die besonderhede en gegewens bevat wat in die onderskeie regulasies voorgeskryf is.

2. Die besonderhede en gegewens in regulasie 1 genoem, is die volgende: —

#### **A. Vakverenigings, federasies van vakverenigings, personeel-, beroeps-, en professionele verenigings.**

- (i) Naam en volledige posadres van die vereniging;
- (ii) of die vereniging geregistreer is kragtens die Wet op Nywerheidsversoening, 1956 (Wet No. 28 van 1956);

- (24) Description, quantity and sales or value of goods or commodities manufactured, processed, made, prepared or packed, and description and value of construction, demolition, excavation, installation, assembly, completion, repair and other work done.
- (25) Analysis of sales and work done according to class of customer.
- (26) Value of stocks (raw materials, packing materials, fuel, consumable stores and other stores, work in progress, own manufactures and factored goods) as at the beginning and end of the business or financial year.
- (27) Manufacturing, construction, working cost or workshop account, trading account, profit and loss account, appropriation account and balance sheet.

6. The person in charge of a factory or productive industry who, without reasonable cause, fails to comply with these regulations, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues. The person in charge of a factory or productive industry shall not be relieved of these penalties by reason only of his having received no form or forms to furnish the return or returns defined in regulation 3; the Director of Statistics may, if he deems it advisable, cause a form or forms to be delivered or sent by post to the person in charge of a factory or productive industry.

## **REGULATIONS.**

### **COLLECTION OF STATISTICS RELATING TO TRADE UNIONS, EMPLOYERS' ORGANISATIONS, INDUSTRIAL COUNCILS AND BUSINESS, OCCUPATIONAL, PROFESSIONAL AND OTHER SIMILAR ASSOCIATIONS.**

The State President has, under the provisions of section twelve of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to trade unions, employers' organisations, industrial councils, business, occupational, professional and other similar associations in substitution for the regulations published under Government Notice No. 982 of the 10th November, 1961.

1. The secretary of each association or organisation mentioned in paragraphs A, B, C and D of regulation 2 hereof, shall render within the prescribed time and in respect of such period as laid down in the respective regulations, to the Director of Statistics, Pretoria, or to an officer authorised thereto in writing, a return, which he shall sign and certify as being correct, containing all the particulars and information prescribed by the respective regulations.

2. The particulars and information referred to in regulation 1 are as follows: —

#### **A. Trade Unions, Federations of Trade Unions, Staff, Occupational and Professional Associations.**

- (i) Name and full postal address of association;
- (ii) whether the association is registered in terms of the Industrial Conciliation Act, 1956 (Act No. 28 of 1956);

- (xi) an analysis of the expenditure account of the association, especially with regard to—
  - (a) staff salaries, wages, allowances, bonuses, honoraria, personal commission and gratuities;
  - (b) contributions to pension, provident and staff medical aid funds;
  - (c) contributions to unemployment insurance and workmen's compensation funds;
  - (d) benefits, refunds and payments to members and their dependants;
  - (e) subscriptions and grants to associated or affiliated councils, federations and unions;
  - (f) grants and donations to social clubs, welfare organisations, research and educational institutions and to private persons;
  - (g) transfers to head office or branches;
  - (h) grants and donations to funds or organisations outside the Republic of South Africa;
  - (i) property assessment rates, licences, pass fees and Native Service Levy Fund;
  - (j) insurance premiums;
  - (k) interest on deposits and loans;
  - (l) depreciation;
  - (m) bad debts and subscriptions written off;
  - (n) losses on subsidiary and additional undertakings;
  - (o) transfers to reserves;
  - (p) commission on collections to employers;

- (b) furniture, equipment and vehicles;

- (g) current deposits and cash; and
- (h) sundry debtors.

Any secretary of an organisation or association in regulation 2 who, without reasonable cause, fails to comply with these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

5. Die Staatspresident het kragtens die bepalings van artikel twaalf van die Wet op Statistieke, 1957 (Wet No. 73 van 1957), die volgende regulasies uitgevaardig in verband met die versameling van statistieke betreffende lone en werkgeleentheid ter vervanging van die regulasies opgestel kragtens artikel tien van die "Statistieke Wet, 1914" (Wet No. 38 van 1914), soos van tyd tot tyd gewysig, en afgekondig by Goewermentskennisgewing No. 481 van 5 April 1957:—

1. Elke werkgewer in die Republiek van Suid-Afrika moet nadat hy deur die Direkteur van Statistiek, Pretoria, daartoe versoek is, aan genoemde Direkteur of aan 'n beampte wat skriftelik deur hom daartoe gemagtig is, ten opsigte van sodanige tydperk as wat deur genoemde Direkteur aangedui mag word, en binne die tydperke voorgeskryf in paragrawe (a) en (b) van regulasie 3, onderskeidelik, opgewes verstrek, geteken en korrek gesertifiseer deur dié werkgewer, wat al die besonderhede en gegewens bevat wat voorgeskryf is in paragrawe (a) en (b) van regulasie 2, onderskeidelik, ten opsigte van alle persone wat by sodanige werkgewer in diens is.

2. Die besonderhede en gegewens in regulasie 1 genoem, is soos volg:—

## (a) Opgewe van lone.

- (i) Die aard van die besigheid en die plek waar die besigheid gedryf word.
- (ii) Die nommer en die datum van die loonreëlingsmaatreël, indien een van toepassing is, waarvolgens lone en salarisse betaal word; die maksimum werkure per week en die minimum loontariewe per uur, per dag en/of per week en/of per maand soos bepaal by die loonreëlingsmaatreël.
- (iii) Die beroep, ras en geslag van iedere werknemer.
- (iv) Of die werknemer 'n ambagsman, vakman, vakleerling of leerling of anderins is.
- (v) Die loontarief van elke werknemer en/of sodanige loontarief per uur, per dag, per week of per maand betaalbaar is.
- (vi) Die getal gewone ure en die getal oortydure wat elke werknemer gewerk het.
- (vii) Die bedrag van gewone verdienste en die bedrag van oortydverdienste; en
- (viii) Die lewenskostetoelaes, alle ander toelaes, die waarde van voedsel en huisvesting en die grootstotaal van die verdienste van elke werknemer.

5. The secretary of an association or organisation will not be exempted from this penalty clause merely because no forms have been received by him on which to render the returns mentioned in paragraphs A, B, C and D of regulation 2; the Director of Statistics may, if he deems it necessary, send such necessary forms to the secretary for completion.

6. *Purpose of Regulations.*—The purpose of these regulations is to collect more detailed statistics regarding the associations and organisations mentioned in the regulations, especially in regard to their scope and importance in the economy and their contribution to national income and expenditure.

## REGULATIONS.

## COLLECTION OF STATISTICS RELATING TO WAGES AND EMPLOYMENT.

The State President has, under the provisions of section twelve of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to wages and employment in substitution for the regulations framed under the provisions of section ten of the Statistics Act, 1914 (Act No. 38 of 1914), as amended from time to time, and published under Government Notice No. 481 of the 5th April, 1957:—

1. Every employer of labour in the Republic of South Africa shall, after having been requested by the Director of Statistics so to do, furnish to the said Director, or to an officer authorised in writing by him, in respect of such period as directed by the said Director and within the periods prescribed in paragraphs (a) and (b) of regulation 3, respectively, returns signed and certified to be correct by such employer and containing all the particulars and information prescribed in paragraphs (a) and (b) of regulation 2, respectively, in respect of all persons who are employed by such employer.

2. The particulars and information referred to in regulation 1, shall be as follows:—

## (a) Return of Wages.

- (i) The nature of the business and the place where the business is carried on.
- (ii) The number and date of the wage regulating measure, if any, in force, in terms of which the wages and salaries are paid; the maximum hours of work per week and the minimum wage rates per hour, per day and/or per week and/or per month as laid down by the wage regulating measure.
- (iii) The occupation, race and sex of each person employed.
- (iv) Whether the employee is artisan, journeyman, apprentice or learner or otherwise.
- (v) The rate of wages of each person employed and whether such rate of wages is payable per hour, per day, per week or per month.
- (vi) The number of ordinary hours and the number of overtime hours worked by each person employed.
- (vii) The amount of ordinary earnings and the amount of overtime earnings.
- (viii) The cost-of-living allowances, all other allowances, the value of food and quarters and the grand total of the earnings of each person employed.



## (b) Werkgeleentheid en arbeidsomset.

- (v) Die getal werksdae in die laaste volle betaalweek van die maand en in die maand.
- (vi) Die getal vakatures.
- (vii) Die oorsaak van enige toename of afname in die getal werknemers en dié vir korttyd gewerk.
- (viii) Die aard van die besigheid en die plek waar die besigheid gedryf word; en
- (ix) Die naam van die inrigting en die datum waarop die vorm ingevul is.

3. (a) Die opgawe van lone wat die besonderhede en gegewens bevat wat in paragraaf (a) van regulasie 2 voorgeskryf is, moet binne 'n tydperk van 30 dae vanaf die datum van die versoek deur die Direkteur van Statistiek gerig, verstrek word en moet afsonderlik ten opsigte van Blankes en nie-Blankes verstrek word.

## (b) Employment and Labour Turnover.

- (i) The number, race and sex of employees on the last day of the month if paid monthly, or on the last day of the last full pay-week of the month if paid weekly.
- (ii) The total gross salaries paid or accrued for the month in respect of monthly paid employees and the total gross wages paid or accrued for the last full pay-week of the month if paid weekly.
- (iii) The total number of man-hours worked during the last full pay-week of the month in respect of weekly paid employees.

Any employer of labour who, having been requested by the Director of Statistics in terms of regulation 1 to furnish any return referred to in regulation 2, without reasonable cause, fails to comply with these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

## COLLECTION OF STATISTICS RELATING TO HEALTH SERVICES AND FUNERAL FURNISHING.

1. In these regulations, unless the context otherwise indicates, any expression to which a meaning is assigned

- (i) "health services" shall mean the services rendered by any person, whether legal or natural, in—
  - (a) treating and/or caring or advising in regard to the treatment of persons for physical or mental diseases, disorders, afflictions, injuries or any other conditions or impairments affecting the proper functioning of the body or mind;
  - (b) performing diagnostic or other work ancillary to the treatment of the persons suffering from the conditions indicated under 1 (i) (a);
  - (c) operating medical research establishments;
  - (d) combating environmental conditions injurious to public health; and
 shall include, without limiting the scope of the definition, hospitals, nursing and maternity homes, sanatoria and health centres; out-patient services; clinics and district nursing services; the medical, dental, auxiliary medical and nursing professions; health institutes;
- (ii) "funeral furnishing" shall mean the services rendered by any persons, whether legal or natural, in—
  - (a) the treatment or preparation of corpses for disposal thereof by burial, cremation or other means, but excluding the activities involved in the process whereby the corpse is cremated;
  - (b) the conduct of funerals;
  - (c) the manufacture of coffins, wreaths and grave decorations when such manufacturing is done by establishments engaged in the activities mentioned in paragraphs 1 (ii) (a) and 1 (ii) (b);
- (iii) "financial year," in terms of these regulations, shall mean the period of twelve months covered by the financial returns and statements of persons as defined in paragraphs 1 (i) and 1 (ii).

2. The person or officer in charge of an establishment, institution or organisation concerned with the treatment of persons in hospitals, nursing and maternity homes, sanatoria and health centres, clinics, or by means of out-patient and district nursing services shall each year as prescribed in regulation 3 furnish for the financial year to the Director of Statistics, Pretoria, the particulars and information contained in Annexure A hereto.

3. The particulars and information required in terms of regulation 2 shall be furnished in a form or forms of return which shall be rendered to the Director of Statistics, Pretoria, on or before the date prescribed in paragraph (a) or (b) of this regulation, as the case may be, or such later date as the Director may in his discretion authorise. The forms of return are obtainable from the Director of Statistics.

The date of rendition shall be as follows:—

- (a) In the case of an establishment, institution or organisation whose financial year ends on any date between 1st January and 30th June (both dates inclusive) such return or returns shall, after proper completion, be rendered to the Director of Statistics, Pretoria, each year on or before the 31st August of the year in which the financial year ends.
- (b) In the case of an establishment, institution or organisation whose financial year ends on any date between 1st July and 31st December (both dates inclusive) such return or returns shall, after proper completion, be rendered to the Director of Statistics, Pretoria, each year on or before the 28th February of the year immediately following the year in which the financial year ends.

- (a) Residential buildings—shall consist of dwelling-houses, flats, and any other buildings used for residential purposes.
- (b) Flat—is a self-contained dwelling-unit, consisting of at least one living-room together with a kitchen and bathroom and is cojoined to similar units in one building, and comprises—
  - (i) flats cojoined to similar units in the same building; or
  - (ii) flats cojoined to offices and shops in the same building.
- (c) Non-residential buildings—are any buildings erected or used for non-residential purposes.

2. Every town clerk, town treasurer, secretary or other responsible officer of a municipality, borough, village management board, village council, health committee, township, local board, local area or other urban local body constituted under any law in the Republic of South Africa shall render to the Director of Statistics, Pretoria, monthly not later than the 10th day of the month following that to which the return refers and on a form which he shall obtain from the Director of Statistics, Pretoria, a return furnishing particulars in regard to the matters specified in regulation 3.

3. (a) The return submitted to the Director of Statistics by the person referred to in regulation 2 shall consist of two parts, i.e. Building Plans Passed and Buildings Completed and shall contain particulars of all residential and non-residential buildings to be erected or already erected.

(b) The return referred to in (a) above shall include particulars of additions and alterations to existing residential and non-residential buildings and shall specify (i) plans passed in respect of additions and alterations to such buildings, and (ii) such additions and alterations completed.

4. Any person of whom a return is or returns are required in terms of these regulations who, without reasonable cause fails to comply therewith shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

Any person of whom a return is, or returns are required in terms of these regulations and who without reasonable cause fails to comply therewith, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand or, in the case of continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.

### STATISTICS OF ACCOMMODATION ESTABLISHMENTS.

The State President has under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of statistics relating to accommodation establishments as prescribed by Government Notice No. 420 of 21st March, 1958:—

1. In these regulations, unless the context otherwise indicates, any expression to which a meaning is assigned in the Statistics Act, 1957, has the meaning so assigned thereto, and—

(i) "accommodation establishment" means premises where residential accommodation with board or an associated service is rendered to human beings or animals whether or not such accommodation or service is rendered for business purposes; and

(ii) "month" means in relation to an accommodation establishment, the accounting month ending on or before the last day of any calendar month in question.

2. The person in charge of an accommodation establishment shall, after a form or forms have been duly sent, delivered or tendered to him, render to the Director of Statistics, Pretoria, in respect of such establishment on or before the 10th August, 1963, and thereafter on or before the 10th of every subsequent month, the information in respect of the previous month in forms which are substantially in accordance with forms (i) and (ii) contained in the Annexure hereto.

3. Any person who, without reasonable cause, fails to comply with the requirements of regulation 2, shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand.

## GENERAL.

A. *Legal Requirements for Accommodation Establishments to Submit Returns.*—In terms of the regulations published under section 12 of the Statistics Act, 1957, these returns are required from each accommodation establishment thereto instructed by the Director of Statistics.

B. *Confidential Nature of Information.*—The information furnished in these returns will be treated as strictly confidential and particulars of individual returns will not be published or disclosed.

C. *Separate Information for Each Accommodation Establishment.*—Separate information must be supplied in respect of each accommodation establishment thereto instructed.

D. *Due Date of Returns.*—The value of the statistics compiled from these returns depends largely upon the early publication of the results of the monthly surveys, and an appeal is made to each respondent to render the returns promptly each month within ten days of the end of the month to which the return relates.

E. *Period Covered by Returns.*—The returns must cover a period of one month. This does not necessarily have to be a calendar month, but may be an accounting month, covering, for example, the period from the 27th day of one month up to and including the 26th day of the following month. Particulars in respect of calendar months are, however, preferable.

## EXPLANATORY NOTES.

1. *Trading Revenue (Section A).*—(a) *Accommodation (Item 1).*—Only amounts charged for rooms are to be shown.

(b) *Catering (Item 2).*—Item 2 should include meals for boarders, casual meals and refreshments and catering at dances, parties, etc.

(c) *Liquor and Tobacco Sales (Item 3).*—Off-consumption bottle sales must be recorded under item 3 (b) whenever an off-sales privilege, a bottle liquor licence and/or a wholesale liquor licence is held by or on behalf of the holder of the hotel liquor licence and is used in conjunction with the hotel business.

(d) *Miscellaneous (Item 4).*—Miscellaneous revenue should include rentals and fees for offices, shops, garages, billiard rooms, dance floors, laundering, ironing, etc.

2. *Guest Nights Sold (Section B).*—For the purpose of this question "guest night sold" means one person accommodated for one night and "permanent boarder" means a person other than a member of the management or staff who, on the relative day, was considered to be a permanent resident in your establishment and to have no other permanent dwelling-place.

(c) *Salaries and Wages*.—(i) Should include cash salaries and wages, cost of living and other allowances, employer's contribution to pension and provident funds, bonuses and commissions, but *exclude* employer's own contribution to Workmen's Compensation and Unemployment Insurance Funds and payments in kind.

(ii) Convert weekly wages to a monthly basis by multiplying by  $4\frac{1}{3}$ .

(d) *Payments in Kind*.—Total estimated monthly cost to the establishment of payments in kind such as food, quarters, clothing, etc. Do not include the cost of uniforms.

(b) bestaan 'n handelonderneming waar ook al 'n eenmansaak, vennootskap, private maatskappy met beperkte aanspreeklikheid, publieke maatskappy met beperkte aanspreeklikheid, koöperatiewe vereniging of maatskappy, munisipale of regeringsorganisasie of enige ander liggaam die eienaar is van een of meer handelsinrigtings;

(c) is 'n groothandelonderneming of -inrigting, 'n handelonderneming of -inrigting wat gewoonlik handelsware verkoop aan handelaars en distributeurs vir herverkoop of aan kopers vir gebruik of verbruik in hul eie besigheid;

(d) is 'n kleinhandelonderneming of -inrigting, 'n handelonderneming of -inrigting wat gewoonlik handelsware direk aan verbruikers vir persoonlike of huishoudelike gebruik verkoop; en

## REGULATIONS.

### WHOLESALE AND RETAIL TRADE STATISTICS.

The State President has, under the provisions of section *twelve* of the Statistics Act, 1957 (Act No. 73 of 1957), made the following regulations in regard to the collection of wholesale and retail trade statistics in substitution of the regulations published under Government Notice No. 1171 of the 15th August, 1958:—

#### 1. For the purpose of these regulations—

(a) a trading establishment exists wherever goods (including produce and livestock) are sold, bartered, exchanged or transferred, or offered for sale, barter or exchange, irrespective of the purpose for which such goods are to be used;

(b) a trading firm exists wherever an individual, partnership, private limited liability company, public limited liability company, co-operative society or company, municipal or governmental organisation or any other body owns one or more trading establishments;

(c) a wholesale trading firm or establishment is a trading firm or establishment which generally sells merchandise to dealers and distributors for resale or to purchasers for use or consumption in their own business;

(d) a retail trading firm or establishment is a trading firm or establishment which generally sells merchandise direct to consumers for personal or household use; and

(e) the person in charge of a trading firm or establishment is one of the following:—

(i) The person who owns a trading firm or establishment;

- (ii) die persoon wat deur die eienaar van 'n handelonderneming of -inrigting gemagtig is, of die persoon wat andersins belas is met die toesig, beheer, administrasie, leiding of bestuur van die sake van sodanige handelonderneming of -inrigting, na gelang van die geval;
- (iii) die persoon wat geag kan word deur die eienaar van 'n handelonderneming of -inrigting gemagtig te wees, of die persoon wat andersins geag kan word belas te wees met die toesig, beheer, administrasie, leiding of bestuur van die sake van sodanige onderneming of inrigting, na gelang van die geval.

2. Die persoon in beheer van 'n handelonderneming of -inrigting, hetsy groot- of kleinhandel, gedurende die tydperk of op die datum waarop 'n opgawe of opgawes betrekking het, soos omskryf in onderskeidelik paragrawe (a), (b) en (c) van regulasie 3, moet, nadat hy deur die Direkteur van Statistiek versoek is en nadat 'n vorm of vorms behoorlik aan hom gestuur, afgelewer of aangebied is, aan die Direkteur van Statistiek, Pretoria, op sodanige vorm of vorms, 'n opgawe of opgawes, soos omskryf onderskeidelik in paragrawe (a), (b) en (c) van regulasie 3, wat al die besonderhede en inligting voorgeskryf in onderskeidelik paragrawe (a), (b) en (c) van regulasie 4 bevat, binne die tydperk of tydperke voorgeskryf in onderskeidelik paragrawe (a), (b) en (c) van regulasie 5, verstrek.

3. Die opgawes waarna in regulasie 2 verwys word, is soos volg, naamlik:—

- (a) 'n Maandelikse opgawe van verkope deur handelsinrigtings met betrekking tot die maand Julie 1958, en met betrekking tot elke maand daarna of, indien die boekmaand van die betrokke handelsinrigting voor die laaste dag van sodanige maand geëindig het, dan met betrekking tot elke sodanige boekmaand.
- (b) 'n Kwartaallikse opgawe van voorrade wat deur handelondernemings aangehou word met betrekking tot die 30ste Junie 1958, en daarna met betrekking tot onderskeidelik die 30ste September, 31ste Desember, 31ste Maart en 30ste Junie van elke jaar of, indien die boekmaand van die betrokke handelonderneming in enige van die genoemde maande op 'n datum voor die laaste dag daarvan geëindig het, dan met betrekking tot die laaste dag van sodanige boekmaand.
- (c) 'n Jaarlikse opgawe van 'n gekombineerde handels- en wins-en-verliesrekening en ander gegewens van handelondernemings met betrekking tot die boekjaar van die betrokke handelondernemings wat in die jaar 1958 geëindig het of sal eindig en wat in enige jaar daarna sal eindig.

4. Die besonderhede en inligting waarna in regulasie 2 verwys word, is soos volg:—

- (a) Maandelikse opgawe van verkope deur handelsinrigtings—
  - (i) Die geregistreerde naam of handelsnaam en adres van die handelsinrigting wat die opgawe verstrek;
  - (ii) die tydperk waarop die opgawe betrekking het;
  - (iii) besonderhede ten opsigte van die waarde van die verkope van handelware gedurende die tydperk wat deur die opgawe gedek word; en
  - (iv) die handtekening, hoedanigheid en besigheidsadres of posbusadres (indien daar een is) van die persoon wat die opgawe verstrek, asook die datum waarop die opgawe ingevul is.
- (b) Kwartaallikse opgawe van voorrade wat deur die handelondernemings aangehou word—
  - (i) Die geregistreerde naam of handelsnaam en adres of posbusadres (indien daar een is) van die handelonderneming wat die opgawe verstrek;
  - (ii) die datum waarop die opgawe betrekking het;

- (ii) the person who has been commissioned by the owner of a trading firm or establishment or the person who has otherwise been charged with the supervision, control, administration, direction or management of the affairs of such a trading firm or establishment, as the case may be;

- (iii) the person who may be considered as having been commissioned by the owner of a trading firm or establishment, or the person who may otherwise be considered as having been charged with the supervision, control, administration, direction or management of the affairs of such a trading firm or establishment, as the case may be.

2. The person in charge of a trading firm or establishment, whether wholesale or retail, during the period or on the date to which a return or returns shall relate, as described in paragraphs (a), (b) and (c) of regulation 3, respectively, shall after having been requested thereto by the Director of Statistics and after a form or forms have been duly sent, delivered or tendered to him, render to the Director of Statistics, Pretoria, upon such form or forms a return or returns, as described in paragraphs (a), (b) and (c) of regulation 3, respectively, containing all the particulars and information prescribed in paragraphs (a), (b) and (c) of regulation 4, respectively, within the period or periods prescribed in paragraphs (a), (b) and (c) of regulation 5, respectively.

3. The returns referred to in regulation 2 shall be the following, viz.:—

- (a) A monthly return of sales by trading establishments in respect of the month of July, 1958, and in respect of every month thereafter, or, if the accounting month of the trading establishment in question ended before the last day of any such month, in respect of every such accounting month.
- (b) A quarterly return of stocks held by trading firms in respect of the 30th June, 1958, and thereafter in respect of the 30th September, 31st December, 31st March and 30th June, respectively, in every year, or, if the accounting month of the trading firm in question ended in any of the said months on a date prior to the last day thereof, in respect of the last day of such accounting month.
- (c) An annual return of a combined trading and profit and loss account and other data of trading firms in respect of the financial year of the trading firm in question ended or ending in the year 1958, and ending in every year thereafter.

4. The particulars and information referred to in regulation 2 shall be as follows:—

- (a) Monthly return of sales by trading establishments—
  - (i) the registered name or trading name and address of the reporting trading establishment;
  - (ii) the period to which the return relates;
  - (iii) particulars regarding the value of the sales of merchandise during the period covered by the return; and
  - (iv) the signature, capacity and business address or post office box address (if any) of the person rendering the return, and the date on which the return was completed.
- (b) Quarterly return of stocks held by trading firms—
  - (i) the registered name or trading name and address or post office box address (if any) of the reporting trading firm;
  - (ii) the date to which the return relates;



- (iii) die waarde van die voorrade handelware op die datum waarop die opgawe betrekking het; en
  - (iv) die handtekening, hoedanigheid en besigheids-adres, of posbusadres (indien daar een is) van die persoon wat die opgawe verstrek, asook die datum waarop die opgawe ingevul is.
- (c) Jaarlikse opgawe van 'n gekombineerde handels- en wins-en-verliesrekening en ander gegewens van handelondernemings—
- (i) die geregistreerde naam, handelsnaam of -name, adres en posbusadres (indien daar een is) van die handelonderneming wat die opgawe verstrek;
  - (ii) vermelding van die feit of die handelonderneming die eiendom is van 'n eenmansaak, vennootskap, private maatskappy met beperkte aanspreeklikheid, publieke maatskappy met beperkte aanspreeklikheid, koöperatiewe vereniging of maatskappy, munisipale of regeringsorganisasie of enige ander liggaam;
  - (iii) die boekjaar waarop die opgawe betrekking het;
  - (iv) die getal samestellende inrigtings van die handelonderneming wat onderskeidelik binne en buite die Republiek geleë is;
  - (v) besonderhede ten opsigte van die handels- en wins-en-verliesrekening vir die boekjaar wat deur die opgawe gedek word;
  - (vi) besonderhede ten opsigte van die waarde van die verkope van handelware gedurende die boekjaar wat deur die opgawe gedek word;
  - (vii) besonderhede ten opsigte van sekere bates aan die begin en einde van die boekjaar wat deur die opgawe gedek word;
  - (viii) in gevalle van maatskappye met beperkte aanspreeklikheid of koöperatiewe maatskappye, besonderhede van dividende verklaar ten opsigte van die boekjaar wat deur die opgawe gedek word;
  - (ix) in gevalle waar handelondernemings inrigtings buite die Republiek van Suid-Afrika het, besonderhede van winste of verliese van die inrigtings buite die Republiek vir die boekjaar wat deur die opgawe gedek word; en
  - (x) die handtekening, hoedanigheid en besigheids-adres of posbusadres (indien daar een is) van die persoon wat die opgawe verstrek, asook die datum waarop die opgawe ingevul is.

5. Die tydperke waarna in regulasie 2 verwys word, is die tydperke waarin die opgawes aan die Direkteur van Statistiek, Pretoria, gepos moet word en moet soos volg wees:—

- (a) Maandelikse opgawe van verkope: Binne tien dae na die einde van die tydperk wat deur die opgawe gedek word.
- (b) Kwartaallikse opgawe van voorrade: Binne ses weke na die datum waarop die opgawe betrekking het.
- (c) Jaarlikse opgawe van 'n gekombineerde handels- en wins-en-verliesrekening en ander gegewens: Binne vier maande na die einde van die tydperk wat deur die opgawe gedek word.

6. Die persoon in beheer van 'n handelonderneming of -inrigting wat, nadat hy kragtens regulasie 2 daartoe versoek is, sonder redelike oorsaak versuim om aan hierdie regulasies te voldoen, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens vyftig rand of, in die geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens twee rand vir elke dag waarop sodanige versuim voortduur.

- (iii) the value of the stocks of merchandise on the date to which the return relates; and
- (iv) the signature, capacity and business address or post office box address (if any) of the person rendering the return, and the date on which the return was completed.

(c) Annual return of a combined trading and profit and loss account and other data of trading firms—

- (i) the registered name, trading name or names, address and post office box address (if any) of the reporting trading firm;
- (ii) mention of the fact whether the trading firm is owned by an individual, partnership, private limited liability company, public limited liability company, co-operative society or company, municipal or governmental organisation or any other body;
- (iii) the financial year to which the return relates;
- (iv) the number of constituent establishments of the trading firm situated inside and outside the Republic, respectively;
- (v) particulars regarding the trading and profit and loss accounts for the financial year covered by the return;
- (vi) particulars regarding the value of the sales of merchandise during the financial year covered by the return;
- (vii) particulars regarding certain assets at the beginning and end of the financial year covered by the return;
- (viii) in the case of limited liability companies or co-operative companies, particulars of the dividends declared in respect of the financial year covered by the return;
- (ix) in the case of trading firms operating establishments outside the Republic of South Africa, particulars of the profits or losses of the extra-Republic establishments for the financial year covered by the return; and
- (x) the signature, capacity and business address or post office box address (if any) of the person rendering the return, and the date on which the return was completed.

5. The periods referred to in regulation 2 shall be the periods within which the returns shall be posted to the Director of Statistics, Pretoria, and shall be as follows:—

- (a) Monthly return of sales: Within ten days after the end of the period covered by the return.
- (b) Quarterly return of stocks: Within six weeks of the date to which the return relates.
- (c) Annual return of a combined trading and profit and loss account and other data: Within four months after the end of the period covered by the return.

6. The person in charge of a trading firm or establishment, who, after having been requested in terms of regulation 2, without reasonable cause fails to comply with these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding fifty rand, or in the case of a continuing failure to comply therewith, to a fine not exceeding two rand for every day during which such failure continues.
