3. These amendments shall take effect as from the 1st April, 1964.

### PRICE CONTROL.

#### MAXIMUM PRICES OF MILK.

I, Gabriël Joseph Johannes Fourie Steyn, Deputy Price Controller, acting by virtue of the powers assigned to me by the Price Controller in terms of regulation 1 of War Measure No. 49 of 1946, do hereby amend, with effect from the 12th June, 1964, Government Notice No. R. 48 of 10th January, 1964 (maximum prices of milk)—

(1) by the substitution of the following sub-paragraph for sub-paragraph (3) of paragraph 1:

"(3) The maximum price at which fresh milk may be sold to a distributor in the Port Elizabeth area by a producer or may be purchased by such a distributor from a producer is 29½ cents per 10·3 lb."; and

(2) by the substitution for the whole of Part E—Port Elizabeth, contained in the Schedule thereto, of Part E—Port Elizabeth as set out in the Schedule hereto.

NOTE.—The effect of this notice is to increase the maximum prices of fresh milk in the Port Elizabeth area.

#### SCHEDULE.

##### PART E—PORT ELIZABETH.

Maximum Price.

1. Bottled milk, sold on credit and delivered to the purchaser at premises of seller, and milk sold either for cash or on credit and delivered to the purchaser elsewhere than at premises of seller:—
  - (a) If the quantity thus sold and delivered at any one time does not exceed two gallons..... 6½c per pint.
  - (b) If the quantity thus sold and delivered at any one time exceeds two gallons... 46c per gallon.
2. Bottled milk sold by licence holder of restaurant, refreshment room or tearoom:—
  - (a) Bottles closed with carton or metal discs 6½c per pint.
  - (b) Crown-corked bottles..... 7c per pint.
3. Milk sold for cash and delivered to purchaser at premises of seller in container supplied by purchaser:—
  - (a) Per single half-pint..... 3½c per half-pint.
  - (b) Per single pint..... 6c per pint.
4. All sales and deliveries other than (i) those specified in section 1, 2 and 3 above; and (ii) sales and deliveries in connection with State-aided Milk and Butter Scheme:—
  - (a) If the quantity sold and delivered at any one time is not less than two gallons but less than 25 gallons..... 44c per gallon.
  - (b) If the quantity sold and delivered at any one time is 25 gallons or more..... 43c per gallon.
5. Milk sold in cartons..... 7½c per pint.

NOTE.—Section 3 of the foregoing schedule relates to the so-called "cash-and-carry" trade.

Ek Gabriël Joseph Johannes Fourie Steyn, Adjunk-pryskontroleur, handelende kragtens die bevoegdheid my deur die Pryscontroleur verleen by regulasie 1 van Oorlogsmaatregel No. 49 van 1946, wysig hierby, met ingang van 12 Junie 1964, Goewermentskennisgewing No. R. 48 van 10 Januarie 1964 (maksimum pryse van melk)—

(1) deur subparagraaf (3) van paragraaf 1 deur die volgende subparagraaf te vervang:—

„(3) die maksimum prys waarteen vars melk aan 'n distribueerder in die gebied Port Elizabeth deur 'n produsent verkoop mag word of deur 'n distribueerder van 'n produsent gekoop mag word, is 29½ sent per 10·3 lb.”; en

(2) deur die geheel van Deel E—Port Elizabeth vervat in die Bylae daarvan, te vervang deur Deel E—Port Elizabeth soos in die Bylae hiervan uiteengesit.

  - (b) As die hoeveelheid aldus op 'n slag verkoop en gelewer, meer as twee gelling is..... 46c per gelling.
2. Melk, in bottels, deur lisensiehouer van restaurant, verversingskamer of teekamer verkoop:—
  - (a) Bottels toegemaak met kartonskywe of metaaldoppies..... 6½c per pint.
  - (b) Kroongekurkte bottels..... 7c per pint.
3. Melk vir kontant verkoop en by perseel van die verkoper aan 'n koper gelewer in 'n houer deur die koper verskaf:—
  - (a) Per enkele halfpint..... 3½c per halfpint.
  - (b) Per enkele pint..... 6c per pint.
4. Alle ander verkope en afleverings as (i) dié vermeld in artikels 1, 2 en 3 hierbo; en (ii) verkope en afleverings in verband met Staats-ondersteunde Melk- en Botterskema:—
  - (a) As die hoeveelheid op 'n slag verkoop en gelewer, minstens twee gelling maar minder as 25 gelling is..... 44c per gelling.
  - (b) As die hoeveelheid op 'n slag verkoop en gelewer, 25 gelling of meer is..... 43c per gelling.
5. Melk in kartonhouers verkoop..... 7½c per pint.

**FACTORIES, MACHINERY AND BUILDING WORK  
 ACT, 1941, AS AMENDED.**

**EXEMPTION.—IRON, STEEL, ENGINEERING AND  
 METALLURGICAL INDUSTRY, REPUBLIC OF  
 SOUTH AFRICA.**

I, ALFRED ERNEST TROLLIP, Minister of Labour, hereby, in terms of sub-section (1) of section *fifty-four* of the Factories, Machinery and Building Work Act, 1941, as amended, exempt all employers engaged in the Iron, Steel, Engineering and Metallurgical Industry as defined in the Main Agreement published under Government Notice No. 727 of the 17th May, 1963, the Radio, Refrigeration and Domestic Electrical Appliances Division Agreement published under Government Notice No. 1274 of the 16th August, 1963, the Iscor Agreement published under Government Notice No. 1307 of the 23rd August, 1963, or the Amcor Agreement published under Government Notice No. 1458, dated the 20th September, 1963, who have, in terms of the exemption from the Cost of Living Allowance Regulations published under Government Notice No. R. 255 of the 21st February, 1964, consolidated the basic wages and cost of living allowances (hereinafter referred to as the "consolidated wage") of the employees referred to in the said exemption, from the provisions of paragraph (a) of sub-section (2) of section *twenty* of the said Act, on condition that an employee who is required or permitted to work on a Sunday shall be remunerated at a rate of not less than one and two-third times his consolidated wage in respect of the total period worked by him on such Sunday, or be paid remuneration which is not less than one and two-third times the consolidated wage payable in respect of the period ordinarily worked by him on a week-day, whichever is the greater.

Government Notice No. R. 1269 published in the *Government Gazette* of the 16th August, 1963, is hereby withdrawn.

- (b) the substitution in sub-clause (a) of clause 6 of the word "Departments" for the word "Department";
- (c) the insertion in item (c) under Group II of the schedule to sub-clause (b) of clause 6, of the word "National" after the word "at";
- (d) the insertion in item (c) under Group II of the schedule to sub-clause (b) of clause 6, of the word "Nasionale" after the word "van", in the Afrikaans text.
