NATURAL AND HISTORICAL MONUMENTS, RELICS AND ANTIQUES ACT, 1934.—REGULATIONS—AMENDMENT OF.

The Deputy-Minister acting for the Minister of Education, Arts and Science has, by virtue of the powers vested in him by section *twelve* of the Natural and Historical Monuments, Relics and Antiques Act, 1934 (Act No. 4 of 1934), amended Government Notice No. R. 823, dated the 26th May, 1961, by the substitution for regulation 10 (1) (a) of the following paragraph:

“10. (1) (a) The subsistence allowance payable per day to a member of the Commission other than a full-time Government official shall be as follows:

- (i) each day, reckoned from midnight to midnight, on which a meeting of the Commission is attended, irrespective of the duration of the meeting;
- (ii) each day, reckoned from midnight to midnight, on which work of the Commission is performed at the chairman's request, irrespective of the duration of such work;
- (iii) time spent by individual members on work of the Commission at the request of the chairman, calculated *pro rata* for every completed hour, where six hours of work shall be considered a full day: Provided that such work shall not include the normal duties of preparation for meetings; and
- (iv) time spent in travelling or stopping over on the business of the Commission, calculated *pro rata* for every completed hour in respect of periods, excluding a day reckoned from midnight to midnight, on which a meeting is held or work is performed: Provided that the above-mentioned allowance shall be the maximum all-inclusive allowance payable to such member for a period of twenty-four hours, reckoned from midnight to midnight, irrespective of whether it is by way of reimbursement in respect of one or more than one of the services set out in this paragraph.”

### REQUIREMENTS RELATING TO RECORDS AND RETURNS.—AMENDMENT.

In terms of sub-section (2) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dried Bean Control Board, referred to in section 3 of the Dried Bean Scheme, published by Proclamation No. R. 68 of 1961, as amended, has, in terms of section 14 of that Scheme, with my approval and with effect from the date of publication hereof, amended the requirements set out in the Annexure to Government Notice No. R. 1107 of the 6th July, 1962, in the manner set out in the Annexure hereto.

#### ANNEXURE.

Government Notice No. R. 1107 of the 6th July, 1962, is hereby amended by—

(1) the insertion after clause 2 of the Annexure thereto, of the following clause:—

“3. Every person dealing with dried beans in the course of trade and who imports dried beans into the Republic of South Africa—

(1) shall record in Afrikaans or English the particulars required in Schedule C hereto in respect of dried beans so imported into the Republic of South Africa, and shall retain such record for a period of three years; and

DECLARATION OF CERTAIN OFFICERS IN THE SERVICE OF LOCAL AUTHORITIES AS PEACE OFFICERS FOR THE PURPOSE OF SUB-SECTIONS (1) AND (2) OF SECTION THREE HUNDRED AND NINE BIS OF THE CRIMINAL PROCEDURE ACT, 1955 (ACT NO. 56 OF 1955), IN RELATION TO CERTAIN OFFENCES.

By virtue of the powers vested in me by sub-section (3) of section *three hundred and nine bis* of the Criminal Procedure Act, 1955 (Act No. 56 of 1955), I, BALTHAZAR JOHANNES VORSTER, Minister of Justice, hereby declare that for the purposes of sub-sections (1) and (2) of the said section *three hundred and nine bis* every officer in the service of a local authority who has been or is duly appointed by such local authority as a traffic officer or inspector of licences under—

- (a) the Road Traffic Ordinance, 1955 (Ordinance No. 19 of 1955) (Cape);
- (b) the Road Traffic Ordinance, 1956 (Ordinance No. 26 of 1956) (Natal);
- (c) the Road Traffic Ordinance, 1956 (Ordinance No. 17 of 1956) (Orange Free State); or
- (d) the Road Traffic Ordinance, 1957 (Ordinance No. 18 of 1957) (Transvaal);

and who is in uniform and in respect of whom the local authority has been or is furnished with a certificate issued by the District Commandant of the South African Police to the effect that he is convinced that the officer is competent to discharge and exercise the powers and duties of a peace officer, shall from the date upon which this declaration is published or from the date upon which the said certificate is furnished to the local authority concerned, whichever is the later date, within the area of jurisdiction of the local authority concerned, be deemed to be a peace officer in relation to any contravention of the above-mentioned Ordinances or of any by-law, regulation or rule made or issued under the said Ordinances when committed within the area of jurisdiction of such local authority: Provided that if such officer is a non-White, he may exercise the powers contemplated by this declaration in respect of non-Whites only.
